

Planned changes to the Producer Price Index

17 November 2011

A. Introduction

The South African PPI has been published in some form for at least 100 years. It is currently published as four main sets of tables. These are the domestic output PPI, the import PPI, the export PPI, and two tables of specific construction-related materials. In 2009 a review of the PPI was conducted. Based on this it was decided to integrate the PPI more closely with the system of national accounts and initiate a number of other improvements. This document outlines the methods and structures for a new set of producer price indices.

B. Main changes to be introduced

In addition to the reweighting of the index, the new PPI will be different in format and product composition from the current version. The new format PPI is designed to be in line with accepted practice in the international statistical community.

1. Format

Businesses are grouped into industries according to the extent that they produce related outputs. The current, aggregate, headline PPI cannot be said to represent the sales of any particular business type. It is standard international practice to rather produce PPIs for specific industries, and not one for the economy as a whole.

The main focus of the PPI is on tracking prices of domestically produced goods. These goods may be sold to either local or foreign customers. The domestic output PPI therefore captures both local sales and exports. Stats SA will continue to publish a dedicated export, and import, price index (see paragraph 2 below).

The new format of the PPI for domestic output will not contain an aggregate PPI but instead will consist of five separate PPIs. This is based on the 'stages of production' concept. 'Stages of production' separates the economy into distinct industries which have an input-output relationship with each other. It separates the primary industries from those in which there is further transformation of products. The new indices comprise:

- Agriculture, forestry and fishing
- Mining and quarrying
- Electricity and water
- Intermediate manufactured goods or goods for further processing i.e.
 those manufactured products that serve mainly as an input into further manufacturing, and
- Final manufactured goods i.e. those manufactured products that are mainly for final demand and are not incorporated into further production.

The PPI for final manufactured goods will be the new headline PPI as this best represents the effects of price changes through the five stages of production.

2. Export and Import indices

The current import and export price indices will be replaced by unit value indices (UVIs). UVIs are calculated on the basis of customs information sourced from the South African Revenue Service (SARS). The weights of the UVIs are derived from the value of the products exported or imported. The unit values are derived from the value divided by the quantity of a specific product in a specific month for a specific exporter or importer per product group. Only the product groups (and not the individual traders) are weighted. The geometric means of the price relatives of individual unit values provide the monthly changes in the index.

Unit value indices have the advantage of being based on the population of all transactions and not just a sample. They therefore have complete coverage when compared with traditional price indices.

Only the export UVI will be ready for release with the revamped PPI. In the meantime, the current import PPI table will be continued. We anticipate that the import UVI will be ready for launch in 2013.

3. Newly calculated weights

The weights for the PPI are calculated at two levels. At the *industry* level the weights are calculated on the proportion of value added as reflected in the national accounts. Supply and use tables are used to differentiate the output of the manufacturing industry in respect of goods produced primarily for further processing and goods produced primarily for final demand.

At the *product* level, the weights assigned to different products are derived from the turnover on products as captured by Stats SA's large sample surveys (LSS) or data obtained from industry sources.

In future, Stats SA will update the higher level weights with the most recent annual national accounts data, and the product weights with any relevant data that are available. Weights updates will take place in the January PPI publication each year and the indices will be chain linked.

4. Updated classification

The PPI uses two sets of classifications. The Standard Industrial Classification (SIC) is used as the classification system at a publication level for *industries*. The Central Product Classification (CPC) is used as the classification system for *products*. The new PPI will use version 2 of the CPC, which is an update of version 1.1 used currently. The differences in the two versions are not substantial as far as they affect the South African PPI. All sub-indices will therefore correspond to CPC v2 in an aggregate form.

5. A new set of products (basket) for each of the PPIs.

The PPI basket (domestic output) currently contains about 800 different 'indicator' products (lowest level at which weights are available). Index number practice shows that there is little point in collecting data on items that have a weight of less than 0,1% of the entire basket, as their price movements, no matter how dramatic, will have virtually no effect on the index.

The new basket has been selected on the basis of those products which showed a significant weight within each of the five main industries. The product list is not intended to be exhaustive, but rather each product is selected to be representative of others within its class. The full list of products is attached as Appendix A. The total number of indicator products is 273, compared with the previous list of about 800. However, 212 of the products in the new basket also appear in the old basket. The reduction in the number of 'indicator' products means that it is possible to collect significantly more prices for each indicator product, thereby improving the robustness of the index.

6. Tables of selected building materials

Stats SA currently publishes Tables 11 and 12 of the PPI as an additional service for users. This information is mainly used for contract escalations and there are a limited number of products in this table that also appear in the main PPI. Consequently, Tables 11 and 12 will not be significantly affected by the current changes to the PPI.

However, Stats SA wishes to improve the quality of these tables and the fashion in which changes are made to them. To this end, Stats SA is establishing a steering committee comprising major industry associations that advise companies on contract adjustments. This steering committee will consider requests and recommendations for changes to the product composition and subweightings of these tables.

7. New base year

The base year refers to a price reference period. This is a period in which the indices average 100 for the year. The base year for the new PPI will be 2011 assuming publication during 2012.

8. Time series information

The introduction of the new PPI will in effect be a new PPI series. This implies that there will be a break in the official PPI series. To assist data users in managing this break Stats SA will provide:

- Indices for the new series starting from January 2011 using all new products;
- Indices extending back to 2009 using the historical prices but new weights and format; and
- Factors to link specific indices in the old and new series on request.

In addition to the time series information, Stats SA will publish a comprehensive methods and sources document for the PPI. This manual will provide an explanation of all aspects of the PPI from composition of the basket and weights through to the mechanics of its compilation.

9. Behind-the-scenes enhancements

Stats SA is taking the opportunity of this PPI overhaul to introduce a number of improvements to its PPI data collection and management. To facilitate the production of a high quality PPI the following developments are being introduced:

- New capturing and database system;
- Enhanced data collection methodology with greater focus on actual transaction prices, which accounts for discounts and excludes distributionrelated costs;
- Improved process for data collection including dispatch and receipt of questionnaires by email;
- Greater number of prices per indicator product; and
- Improved quality controls and editing processes.

C. Services PPIs

In the medium term, Stats SA plans to expand the number of industries for which PPIs are published – services industries in particular. During 2012, Stats SA will begin research work on the compilation of PPIs for specific services. The timing of these has not yet been determined but will largely be influenced by the availability of results from Stats SA's large sample surveys.

Among the first to be developed will be PPIs for construction services and business services.

D. Launching the revamped PPI

Stats SA's work programme as tabled in Parliament sets the date for delivery of the new PPI as January 2013. However, it is anticipated that the new PPI will be ready for publication in mid 2012.

The new indices will be published as soon as they are ready. This has the advantage of providing the public with more reliable data sooner. There will be no revision of the published indices for the first half of 2012. The annual average PPI, which is published at the end of a calendar year, will be based on the new indices.

Some months prior to the publication of the new PPI, Stats SA will communicate the final weights and publication format.
