

**SKULDSAKE STEEDS OP HOË VLAK**

Die totale getal siviele dagvaardings vir skuld toon 'n toename van 0,3% in februarie 1995 teenoor Februarie 1994. Siviele vonnisse vir skuld by versteek en toestemming toon 'n toename van 5,5% en die totale bedrag betrokke by hierdie vonnisse het met 9,1% toegeneem.

'n Totaal van 90 668 dagvaardings is gedurende Februarie 1995 uitgeréik. Dagvaardings ten opsigte van agterstallige huur toon die skerpste toename van 3 249 vir Februarie 1994 na 5 962 vir Februarie 1995.

Siviele vonnisse vir skuld het in Februarie 1995 toegeneem tot 'n totaal van 44 423. Hiervan was 11 862 vonnisse ten opsigte van goedere wat op ope rekening verkoop is, 8 017 vonnisse ten opsigte van professionele dienste en 7 389 vonnisse ten opsigte van ander dienste gelewer.

Die totale bedrag betrokke by vonnisse vir skuld het R226,6 miljoen in Februarie 1995 beloop. Die gemiddelde bedrag per vonnis was R5 101. Vonnisse ten opsigte van geld geleent het egter 'n gemiddelde van R19 233 per vonnis getoon.

**DEBT CASES STILL ON HIGH LEVEL**

The total number of civil summonses for debt shows an increase of 0,3% in February 1995 compared with February 1994. Civil default and consent judgements for debt show an increase of 5,5% and the total amount involved in these judgements increased by 9,1%.

A total of 90 668 summonses were issued during February 1995. Summonses in respect of rent in arrear show the sharpest increase from 3 249 for February 1994 to 5 962 for February 1995.

Civil judgements for debt increased to a total of 44 423 in February 1995. Of this, 11 862 were judgements in respect of goods sold on open account, 8 017 judgements in respect of professional services and 7 389 judgements in respect of other services rendered.

The total amount involved in judgements for debt amounted to R226,6 million in February 1995. The average amount per judgement was R5 101. Judgements in respect of money lent showed an average of R19 233 per judgement.

Except for cases recorded, all other information relates to debt cases only; i.e. claims for damages, ejection orders and other non-debt cases are excluded.


Default and consent judgements relate to judgements given in respect of undefended debt cases only.

Thousand




