

SKULDSAKE BEGIN MEER TOENEEM

Die totale getal siviele dagvaardings vir skuld vir die drie maande tot Januarie 1995 toon 'n toename van 5,3% vergeleke met die vorige drie maande na seisoensaanpassing. Siviele vonnisse vir skuld by versteek en toestemming toon 'n toename van 5,9% (sien grafieke).

Dagvaardings het gedurende Januarie 1995 toegeneem tot 'n totaal van 84 702 wat 'n toename van 10,2% vergeleke met Januarie 1994 verteenwoordig. Dagvaardings ten opsigte van nie-professionele dienste het 'n toename van 47,7% oor hierdie tydperk getoon.

'n Totaal van 37 328 skuldbonnisse is gedurende Januarie 1995 gevel. Hiervan was 27,6% ten opsigte van goedere verkoop en 33,7% ten opsigte van dienste gelewer. Die totale bedrag betrokke by vonnisse het R232,2 miljoen beloop.

HOWE VIR KLEIN EISE

Gedurende 1994 het die aantal howe vir klein eise toegeneem tot 111. 'n Totaal van 25 356 verhore het in 1994 plaasgevind.

DEBT CASES INCREASE AGAIN

The total number of civil summonses for debt for the three months up to January 1995 shows an increase of 5,3% compared with the previous three months after seasonal adjustment. Civil default and consent judgements for debt show an increase of 5,9% (see graphs).

Summonses increased during January 1995 to a total of 84 702 which represents an increase of 10,2% compared with January 1994. Summonses in respect of non-professional services showed an increase of 47,7% over this period.

A total of 37 328 judgements for debt were passed during January 1995. 27,6% of these were in respect of goods sold and 33,7% in respect of services rendered. The total amount involved in judgements was R232,2 million.

SMALL CLAIMS COURTS

During 1994 the number of small claims courts increased to 111. A total of 25 356 hearings occurred in 1994.

Except for cases recorded, all other information relates to debt cases only; i.e. claims for damages, ejection orders and other non-debt cases are excluded.


Default and consent judgements relate to judgements given in respect of undefended debt cases only.



BYLAE**HOWE VIR KLEIN EISE****OPMERKINGS**

Howe vir klein eise dien as 'n forum vir die beregtiging van geldelike eise van nie meer as R2 000 nie teen individue of firms. Dit is slegs vir gebruik deur die algemene publiek en nie vir sake-onderneemings nie.

Die volgende sake is van die jurisdiksie van die hof vir klein eise uitgesluit:

- Eise ter waarde van meer as R2 000.
- Eise teen die staat.
- Eise wat op 'n sessie of 'n oordrag van regte gebaseer is.
- Eise waarin skadevergoeding aangevra word ten opsigte van laster, kwaadwillige vervolging, onregmatige vryheidsberowing, onregmatige arrestasie, verleiding en verbreking van troubelofte.
- Eise vir die ontbinding van 'n huwelik.
- Eise in verband met die geldigheid van 'n testament.
- Eise in verband met die status van 'n persoon ten opsigte van sy geestesvermoëns.
- Eise waarin die nakoming van 'n kontrak aangevra word, sonder 'n alternatiewe eis om betaling van skadevergoeding, behalwe in die geval van 'n eis om 'n rekening te verstrek of los goed of vaste eiendom ter waarde van nie meer as R2 000 nie, oor te dra.

VERGELYKAARHEID

Die inligting ten opsigte van landdroshewe wat in hierdie statistiese vrystelling getoon word, het slegs op skuldsake betrekking en is derhalwe nie streng vergelykbaar met die inligting wat vir die Howe vir klein eise getoon word nie.

BEGRIFFE

"Howe" verwys na die totale getal Howe vir klein eise aan die einde van die maand soos aangedui. "Litigante verwys" het betrekking op die getal persone (eisers) wat deur klerke van die hof vir klein eise na regsassistentes verwys is.

ANNEXURE**SMALL CLAIMS COURTS****NOTES**

Small claims courts serve as a forum for the adjudication of money claims of not more than R2 000 against individuals or firms. It is for use by the general public only and not for business enterprises.

The following actions are excluded from the jurisdiction of the small claims court:

- Claims exceeding R2 000 in value.
- Claims against the state.
- Claims based on cession or the transfer of rights.
- Claims for damages in respect of defamation, malicious prosecution, wrongful imprisonment, wrongful arrest, seduction and breach of promise to marry.
- Claims for the dissolution of a marriage.
- Claims concerning the validity of a will.
- Claims concerning the status of a person in respect of his mental capacity.
- Claims in which the performance in accordance with a contract is sought, without an alternative claim for payment of damages, except in the case of a claim for rendering an account or transferring movable or immovable property not exceeding R2 000 in value.

COMPARABILITY

The information in respect of magistrates courts shown in this statistical release refers to debt cases only and is therefore not strictly comparable with the information shown for the small claims courts.

CONCEPTS

"Courts" relates to the total number of small claims courts at the end of the months as indicated. "Litigants referred" relates to the number of persons (plaintiffs) referred to legal assistants by clerks of the small claims court.
