MEER SKULDSAKE IN MAART 1995

Die totale getal siviele dagvaardings vir skuld en die totale getal siviele vonnisse vir skuld vir Maart 1995 toon toenames van onderskeidelik 12,3% en 7,0% vergeleke met Februarie 1995.

Gedurende Maart 1995 is 'n totaal van 101 814 siviele dagvaardings vir skuld uitgereik - 'n toename van 12,3% vergeleke met Februarie 1995. Die grootste toenames het voorgekom ten opsigte van afbetalings-verkooptransaksies (22,0%), nie-professionele dienste gelewer (16,7%), geld geleen (35,5%) en "ander" dagvaardings (32,9%).

Siviele vonnisse vir skuld het toegeneem van 44 423 vir Februarie 1995 tot 47 543 vir Maart 1995. Dié toename is veral te wyte aan 'n toename van 1 861 in vonnisse vir goedere verkoop op ope rekening en 'n toename van 573 in vonnisse vir nie-professionele dienste gelewer.

Die bedrag betrokke by vonnisse vir skuld het met 13,8% toegeneem van R226,6 miljoen vir Februarie 1995 tot R257,8 miljoen vir Maart 1995. Hierdie toename kan hoofsaaklik toegeskryf word aan toenames in nie-professionele dienste gelewer (33,6%), promesses, wissels, V/T-tjeks, kredietkaarte en ander skuld-bewyse (42,7%) en "ander" vonnisse (27,5%).

MORE DEBT CASES IN MARCH 1995

The total number of civil summonses for debt and the total number of civil judgements for debt for March 1995 show increases of 12,3% and 7,0% respectively, compared with February 1995.

During March 1995 a total of 101 814 civil summonses for debt were issued - an increase of 12,3% compared with February 1995. The largest increases occurred in respect of instalment sale transactions (22,0%), non-professional services rendered (16,7%), money lent (35,5%) and "other" summonses (32,9%).

Civil judgements for debt increased from 44 423 for February 1995 to 47 543 for March 1995. This increase is primarily due to an increase of 1 861 in judgements regarding goods sold on open account and an increase of 573 in judgements regarding non-professional services rendered.

The amount involved in judgements for debt increased by 13,8% from R226,6 million for February 1995 to R257,8 million for March 1995. This increase can mainly be attributed to increases in non-professional services rendered (33,6%), promissory notes, bills, R/D cheques, credit cards and other acknowledgements of debt (42,7%) and "other" judgements (27,5%).




