STATISTIEKE VAN LIKWIDASIES EN INSOLVENSIES AUGUSTUS 1987
 STATISTICS OF LIQUIDATIONS AND INSOLVENCIES AUGUST 1987

1. OPSOMMING

Die totale getal likwidاسies vir die drie maande tot Augustus 1987 toon 'n merkbare toename van 19,7% vergeleke met die voorafgaande drie maande, maar steeds 'n aansienlike afname van 29,2% vergeleke met die ooreenstemmende drie maande van 1986.

Die totale getal insolvensies vir die drie maande tot Julie 1987 toon 'n afname van 13,7% vergeleke met die voorafgaande drie maande, en 'n afname van 23,4% vergeleke met die ooreenstemmende drie maande van 1986.

1. SUMMARY

The total number of liquidations for the three months up to August 1987 shows a noticeable increase of 19,7% compared with the previous three months, but still a substantial decrease of 29,2% compared with the corresponding three months of 1986.

The total number of insolvencies for the three months up to July 1987 shows a decrease of 13,7% compared with the previous three months, and a decrease of 23,4% compared with the corresponding three months of 1986.

2. OPMERKINGS

- 2.1 Die gegewens vir likwidاسies het betrekking op die totale getal maatskappye en beslote korporاسies wat finaal gelikwideer is. Hierdie gegewens word verkry vanaf die Registrateur van Maatskappye en Beslote Korporاسies.
- 2.2 Insolvensies het slegs betrekking op private persone en vennootskappe wat finaal gesekwestreer is; dit verteenwoordig nie die getal persone betrokke nie, aangesien 'n vennootskap as een insolvensie gereken word, ongeag die getal vennote. Die syfers is gebaseer op gegewens verkry uit die Meesters se Kennisgewings wat gereeld in die Staatskoerant verskyn.

2. NOTES

- 2.1 The figures for liquidations relate to the total number of companies and close corporations which are placed under final liquidation. This information is obtained from the Registrar of Companies and Close Corporations.
- 2.2 Insolvencies relate to private persons and partnerships which are placed under final sequestration; they do not represent the number of persons involved, as a partnership is counted as one insolvency, irrespective of the number of partners. The figures are based on information extracted from the Masters' Notices published currently in the Government Gazette.

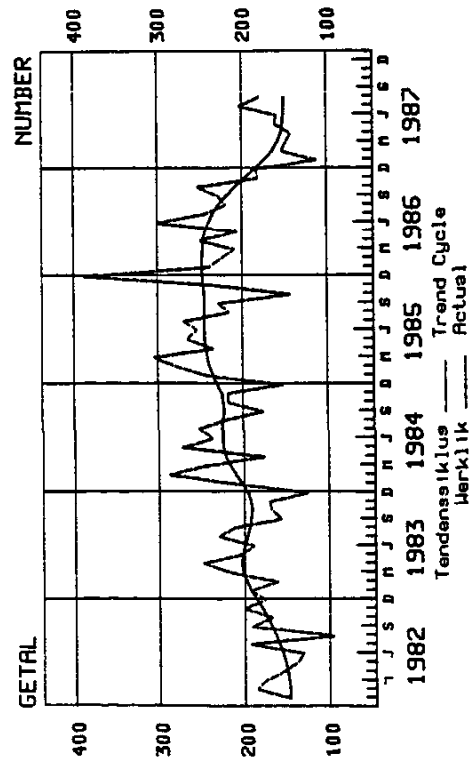

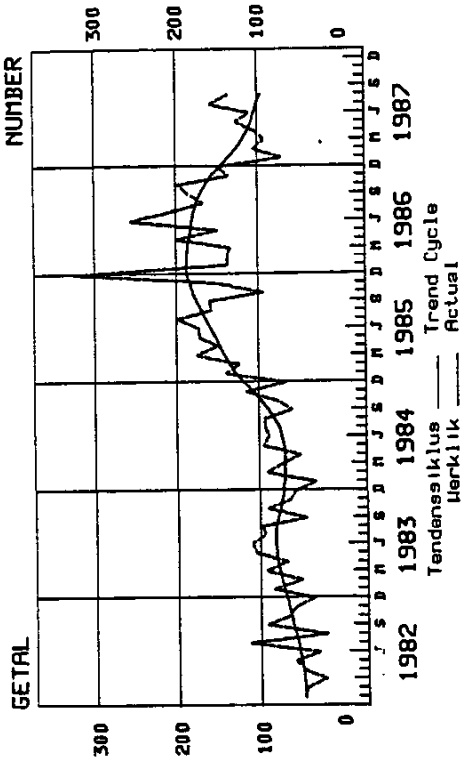

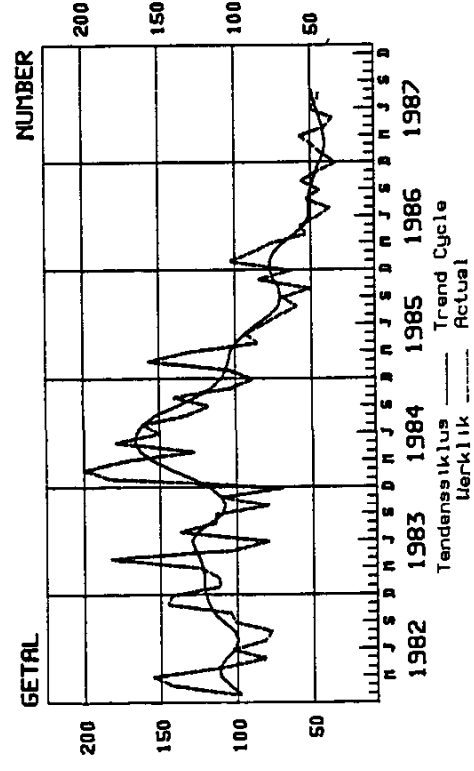

TOTAL



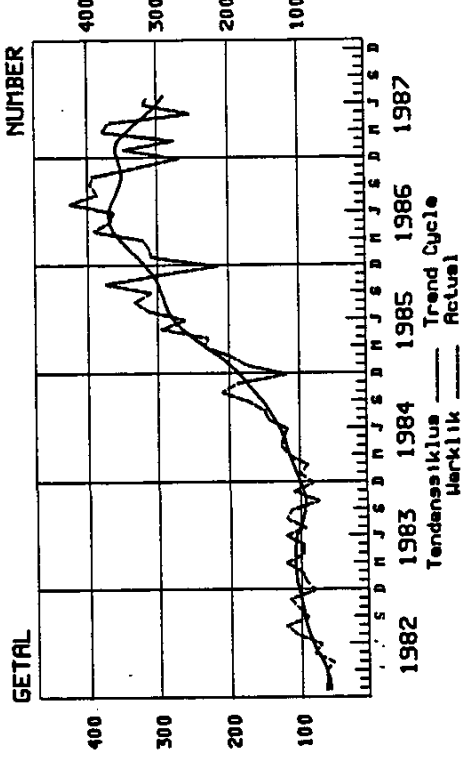
LIKVIDASIES
