Key findings regarding liquidations for August 2008

The total number of liquidations increases during the first eight months of 2008

The total number of liquidations recorded for the eight months ended August 2008 increased by 4,0% (from 1 958 to 2 037) when compared with the eight months ended August 2007. However, the total number of liquidations recorded for August 2008 decreased by 26,4% (from 387 to 285) when compared with August 2007 (see Table A and Tables 14 and 15).

The 4,0% increase in the total number of liquidations for the eight months ended August 2008 was due to an increase of 6,2% in voluntary liquidations (from 1 740 to 1 848). During this period, 31,2% more close corporations were liquidated, with company liquidations decreasing by 17,8%.







Figure 1 below shows the annual percentage change in the number of liquidations for the eight months ended August of the respective years and covers the period from 2002 to 2008. The 4,0% increase reported for 2008 compared with 2007 is the first increase recorded since the beginning of this time series. This increase comes after six consecutive decreases of the same period since 2001.

Key findings regarding insolvencies for July 2008

Total number of insolvencies continues to increase

The total number of insolvencies recorded for July 2008 increased by 18,9% (from 169 to 201) when compared with July 2007. Furthermore, the total number of insolvencies recorded for the seven months ended July 2008 increased by 40,1% (from 1 071 to 1 501) compared with the seven months ended July 2007 (see Table B and Tables 16 and 17).

Figure 3 below shows the annual percentage change in the number of insolvencies for the seven months ended July compared with the corresponding period of the previous year, and covers the period 2002 to 2008. The number of insolvencies increased by 40,1% for the first seven months of 2008 and it is the third increase recorded for this period since 2002.








Figure 4 outlines the trend in the total number of insolvencies from January 2004 to July 2008.

Explanatory notes

Introduction	1	Statistics South Africa (Stats SA) collects administrative information on liquidations from the Registrar of Companies and Close Corporations, Department of Trade and Industry, while information on insolvencies is gathered from Notices of the Master of the Supreme Court which appears in the Government Gazette.
	2	This statistical release reflects voluntary and compulsory liquidations of companies and close corporations and insolvencies of individuals and partnerships.
Purpose of the survey	3	The aggregated data in this release are used by the private and public sectors to measure economic performance and are also an important indicator of the scope of unpaid debt in South Africa.
	4	Due to insolvencies figures being available late, the data on insolvencies are published a month later than liquidations.

Glossary	
Compulsory liquidation	A compulsory liquidation takes place when the affairs of a company or close corporation are wind-up by order of the court.
Insolvency	Insolvency refers to an individual or partnership which is unable to pay its debt and is placed under final sequestration. The number of insolvencies does not refer to the number of persons involved, as a partnership which is unable to pay its debt is regarded as one insolvency, irrespective of the number of partners.
Liquidation	Liquidation refers to the winding-up of the affairs of a company or close corporation when liabilities exceed assets and it can be resolved by voluntary action or by an order of the court.
Voluntary liquidation	A voluntary liquidation takes place when a company or close corporation, by own choice, resolves to wind-up its affairs.
