INFLATION OVERVIEW

The headline CPI annual inflation rate at August 2007 was 6,7%.

The annual change in CPIX, the monetary policy inflation target measure, was 6,3% at August 2007.

The headline inflation rate (year-on-year) was 0,3 of a percentage point lower than the 7,0% recorded at July 2007. The year-on-year increase in the CPIX for August 2007 was 0,2 of a percentage point lower than the 6,5% y/y increase recorded at July 2007.

This lower rate at August 2007 can be explained by decreases in the annual rates of change for:

- The CPI annual rate for non-alcoholic beverages which decreased to 3,6% at August 2007 from 4,5% at July 2007.
- The CPI annual rate for transport which decreased to 1,4% at August 2007 from 4,2% at July 2007.

These decreases were slightly counteracted by increases in the annual rates of change for:

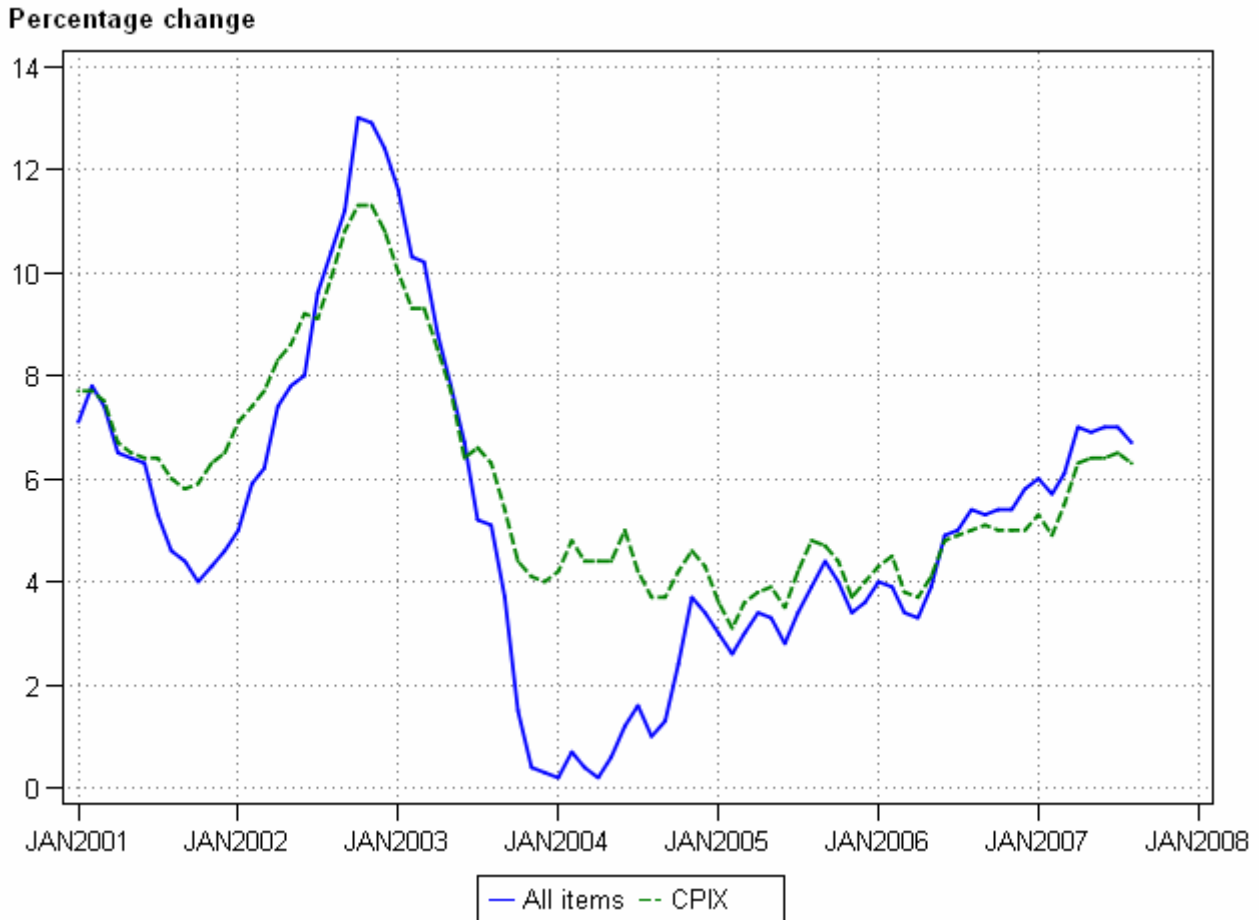
- The CPI annual rate for food which increased to 11,1% at August 2007 from 10,2% at July 2007.
 - The CPI annual rate for milk, cheese and eggs which increased to 16,5% at August 2007 from 14,1% at July 2007.
 - The CPI annual rate for fats and oils which increased to 17,4% at August 2007 from 15,5% at July 2007.
 - The CPI annual rate for vegetables which increased to 14,1% at August 2007 from 9,5% at July 2007.
- The CPI annual rate for communication which increased to 1,9% at August 2007 from 0,3% at July 2007.

The main contributors to the annual increase of 6,7% in the CPI at August 2007 were food (+ 2,4 percentage points), housing (+ 2,0 percentage points), medical care and health expenses (+ 0,5 of a percentage point), household operation (+ 0,4 of a percentage point), education (+ 0,4 of a percentage point) and fuel and power (+ 0,3 of a percentage point). These increases were slightly counteracted by a decrease in the price index for clothing and footwear (- 0,2 of a percentage point) (see table 3.1 on page 18).

The annual rate of increase in food prices for the historical metropolitan areas was 11,1% at August 2007. This rate was 0,9 of a percentage point higher than the corresponding annual rate of 10,2% at July 2007. The increase of 11,1% was due to increases in the prices of meat, grain products, milk, cheese and eggs, vegetables, other food products, fats and oils, fruit and nuts, fish and other seafood, coffee, tea and cocoa and sugar.

The annual rate of increase in the price index for non-food items for metropolitan areas was 5,4% at August 2007. This rate was 0,7 of a percentage point lower than the corresponding annual rate of 6,1% at July 2007. Annual increases occurred in the price indices for cigarettes, cigars and tobacco (+ 10,8%), housing (+ 10,0%), education (+ 8,0%), fuel and power (+ 7,7%), alcoholic beverages (+ 7,2%), household operation (+ 7,2%), personal care (+ 6,0%), reading matter (+ 5,7%), medical care and health expenses (+ 5,2%), non-alcoholic beverages (+ 3,6%), other products (+ 3,2%), communication (+ 1,9%), transport (+ 1,4%) and furniture and equipment (+ 0,8%). These increases were slightly counteracted by a decrease in the price index for clothing and footwear (- 9,0%).

NOTES

CPI for September 2007

As indicated in the planned schedule of price surveys, explanatory notes 15, 16 and 17, electricity tariffs are surveyed in July and August. It has come to Stats SA's attention that price changes in these items will be introduced during September 2007. Additional surveys for these items will be conducted in certain areas in September 2007 to capture these changes.

Amalgamated releases

Stats SA has combined the previously two CPI publications (Headline and Rural) into this one publication from January 2007. All the information that was previously available in the two publications is available in the combined release. In the January 2007 CPI publication (P0141) is a summarised table with the old and new table numbers.

Note on change of practices regarding the pricing of clothing and footwear in the CPI

As from January 2008, Stats SA will amend the criteria employed to collect clothing and footwear prices for the Consumer Price Index

Currently, a particular item of clothing is priced as long as it is available for sale in a particular store. The price is recorded irrespective of whether the item is on sale at a discounted price (sale), or at its regular price. This method is consistent with that used to price all other products available for sale to consumers through retail stores. Stats SA's price collectors do currently indicate on the pricing form whether the price is a regular price or whether it is discounted.

From January 2008, the clothing index of the CPI will not include sale prices. Price collectors will be under instruction that once an item goes on sale a new item should be initiated for pricing. This change is on the grounds that while sale prices are sufficiently significant to affect trends, items on sale are of restricted availability.

Stats SA will construct an index of clothing prices for 2007 which excludes sale prices. This will be used for the comparison with relevant 2008 prices indices to obtain year-on-year changes which will then feed into the CPI.

The rates of change as published in the CPI during 2007 will not be changed. This means that there is no revision of the published CPI.

KEY FINDINGS

A. Consumer Price Index

1. Metropolitan areas

The headline inflation rate at August 2007 (i.e. the Consumer Price Index for the historical metropolitan areas at August 2007 compared with that at August 2006) was 6,7%

The official inflation rate (i.e. the percentage change in the CPI for the historical metropolitan areas at August 2007 compared with that at August 2006) was 6,7% at August 2007. This rate was 0,3 of a percentage point lower than the corresponding annual rate of 7,0% at July 2007 (see table 2.1.1, p.16).

This lower rate at August 2007 can be explained by decreases in the annual rates of change for:

- The CPI annual rate for non-alcoholic beverages which decreased to 3,6% at August 2007 from 4,5% at July 2007.
- The CPI annual rate for transport which decreased to 1,4% at August 2007 from 4,2% at July 2007.

These decreases were slightly counteracted by increases in the annual rates of change for:

- The CPI annual rate for food which increased to 11,1% at August 2007 from 10,2% at July 2007.
 - The CPI annual rate for milk, cheese and eggs which increased to 16,5% at August 2007 from 14,1% at July 2007.
 - The CPI annual rate for fats and oils which increased to 17,4% at August 2007 from 15,5% at July 2007.
 - The CPI annual rate for vegetables which increased to 14,1% at August 2007 from 9,5% at July 2007.
- The CPI annual rate for communication which increased to 1,9% at August 2007 from 0,3% at July 2007.

From July 2007 to August 2007 the Consumer Price Index for the historical metropolitan areas increased by 0,5%.

The main contributors to the annual increase of 6,7% in the CPI at August 2007 were food (+ 2,4 percentage points), housing (+ 2,0 percentage points), medical care and health expenses (+ 0,5 of a percentage point), household operation (+ 0,4 of a percentage point), education (+ 0,4 of a percentage point) and fuel and power (+ 0,3 of a percentage point). The inflation rate for the historical metropolitan and other urban areas was 7,0% at August 2007 (i.e. the CPI at August 2007 compared with that at August 2006). This rate was 0,2 of a percentage point lower than the corresponding annual rate of 7,2% at July 2007.

This lower rate at August 2007 can be explained by decreases in the annual rates of change for:

- **The CPI annual rate for non-alcoholic beverages which decreased to 3,6% at August 2007 from 4,2% at July 2007.**
- **The CPI annual rate for transport which decreased to 1,5% at August 2007 from 4,1% at July 2007.**

These decreases were partially counteracted by an increase in the annual rate of change for:

- **The CPI annual rate for food which increased to 11,3% at August 2007 from 10,2% at July 2007.**

From July 2007 to August 2007 the Consumer Price Index for the historical metropolitan and other urban areas increased by 0,6%.

From July 2007 to August 2007 the Consumer Price Index for the historical metropolitan and other urban areas increased by 0,6%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,4 of a percentage point) and housing (+ 0,3 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,1 of a percentage point, mainly due to a 15c/l decrease in the price of petrol) (see table 3.4, p.18).

3. Rural areas

The inflation rate for the rural areas was 7,9% at August 2007 (i.e. the CPI at August 2007 compared with that at August 2006)

The inflation rate for the rural areas was 7,9% at August 2007 (i.e. the CPI at August 2007 compared with that at August 2006). This rate was 0,1 of a percentage point higher than corresponding annual rate of 7,8% at July 2007. This higher rate at August 2007 can be explained by increases in the annual rates of change for:

- **The CPI for food which increased to 12,9% at August 2007 from 12,1% at July 2007.**
- **The CPI for fuel and power which increased to 9,3% at August 2007 from 7,7% at July 2007.**
- **The CPI for alcoholic beverages which increased to 6,3% at August 2007 from 4,4% at July 2007.**

These increases were partially counteracted by decreases in the annual rates of change for:

- **The CPI for cigarettes, cigars and tobacco which decreased to 8,8% at August 2007 from 12,5% at July 2007.**
- **The CPI for transport which decreased to 0,9% at August 2007 from 2,7% at July 2007.**

From July 2007 to August 2007 the Consumer Price Index for the rural areas increased by 0,8%.

The annual increase of 7,9% in the Consumer Price Index for the rural areas was mainly due to annual contributions in the price indices for food (+ 5,7 percentage points), fuel and power (+ 0,6 of a percentage point), household operation (+ 0,5 of a percentage point), housing (+ 0,3 of a percentage point), personal care (+ 0,3 of a percentage point), alcoholic beverages (+ 0,2 of a percentage point), medical care and health expenses (+ 0,2 of a percentage point), and education (+ 0,2 of a percentage point). These increases were slightly counteracted by decreases in the price indices for clothing and footwear (- 0,2 of a percentage point) and furniture and equipment (- 0,1 of a percentage point) (see table 3.5, p.19).

From July 2007 to August 2007 the Consumer Price Index for the rural areas increased by 0,8%. This monthly increase was due to a monthly contribution in the price index for food (+ 0,8 of a percentage point) (see table 3.6, p.19).

4. Total country

The inflation rate for the total country was 7,0% at August 2007 (i.e. the CPI at August 2007 compared with that at August 2006)

The inflation rate for the total country was 7,0% at August 2007 (i.e. the CPI at August 2007 compared with that at August 2006). This rate was 0,3 of a percentage point lower than the corresponding annual rate of 7,3% at July 2007. This lower rate at August 2007 can be explained by decreases in the annual rates of change for:

- *The CPI for housing which decreased to 9,7% at August 2007 from 10,0% at July 2007.*
- *The CPI for non-alcoholic beverages which decreased to 3,5% at August 2007 from 3,9% at July 2007.*
- *The CPI for transport which decreased to 1,3% at August 2007 from 3,9% at July 2007.*

However, these decreases were partially counteracted by an increase in the annual rate of change for:

- *The CPI for food which increased to 11,6% at August 2007 from 10,6% at July 2007.*

From July 2007 to August 2007 the Consumer Price Index for the total country increased by 0,6%.

The annual increase of 7,0% in the Consumer Price Index for the total country was mainly due to annual contributions in the price indices for food (+ 3,2 percentage points), housing (+ 1,6 percentage points), fuel and power (+ 0,4 of a percentage point), household operation (+ 0,4 of a percentage point), medical care and health expenses (+ 0,4 of a percentage point), education (+ 0,3 of a percentage point) and personal care (+ 0,3 of a percentage point). These increases were slightly counteracted by a decrease in the price index for clothing and footwear (- 0,2 of a percentage point) (see table 3.7, p.19).

From July 2007 to August 2007 the Consumer Price Index for the total country increased by 0,6%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,5 of a percentage point) and housing (+ 0,2 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,1 of a percentage point, mainly due to a 15c/l decrease in the price of petrol) (see table 3.8, p.19).

B. Consumer Price Index excluding interest rates on mortgage bonds (CPIX)

1. Metropolitan areas

The annual percentage change in the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the historical metropolitan areas was 5,9% at August 2007 (i.e. the percentage change in the CPIX at August 2007 compared with that at August 2006)

The annual percentage change in the CPIX for the historical metropolitan areas was 5,9% at August 2007 (i.e. the percentage change in the CPIX at August 2007 compared with that at August 2006). This rate was 0,4 of a percentage point lower than the corresponding annual rate of 6,3% at July 2007.

From July 2007 to August 2007 the CPIX for the historical metropolitan areas increased by 0,2%.

The annual increase of 5,9% in the CPIX for the historical metropolitan areas was mainly due to annual contributions in the price indices for food (+ 2,7 percentage points), housing excluding interest rates on mortgage bonds (+ 0,9 of a percentage point), medical care and health expenses (+ 0,5 of a percentage point), household operation (+ 0,4 of a percentage point), education (+ 0,4 of a percentage point) and fuel and power (+ 0,3 of a percentage point). These increases were slightly counteracted by a decrease in the price index for clothing and footwear (- 0,2 of a percentage point) (see table 3.9, p.20).

From July 2007 to August 2007 the CPIX for the historical metropolitan areas increased by 0,2%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,3 of a percentage point) and communication (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,2 of a percentage point, mainly due to a 15c/l decrease in the price of petrol) (see table 3.10, p.20).

2. Metropolitan and other urban areas

The annual percentage change in the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the historical metropolitan and other urban areas was 6,3% at August 2007 (i.e. the CPIX at August 2007 compared with that at August 2006)

The annual percentage change in the CPIX, which is the Consumer Price Index excluding interest rates on mortgage bonds, for the historical metropolitan and other urban areas was 6,3% at August 2007 (i.e. the CPIX at August 2007 compared with that at August 2006). This rate was 0,2 of a percentage point lower than the corresponding annual rate of 6,5% at July 2007.

From July 2007 to August 2007 the CPIX for the historical metropolitan and other urban areas increased by 0,3%.

The annual increase of 6,3% in the CPIX for the historical metropolitan and other urban areas was mainly due to annual contributions in the price indices for food (+ 3,0 percentage points), housing excluding interest rates on mortgage bonds (+ 0,8 of a percentage point), medical care and health expenses (+ 0,5 of a percentage point), fuel and power (+ 0,4 of a percentage point), household operation (+ 0,4 of a percentage point), education (+ 0,4 of a percentage point) and personal care (+ 0,3 of a percentage point). These increases were slightly counteracted by a decrease in the price index for clothing and footwear (- 0,2 of a percentage point) (see table 3.11, p.20).

From July 2007 to August 2007 the CPIX for the historical metropolitan and other urban areas increased by 0,3%. This monthly increase was due to a monthly contribution in the price index for food (+ 0,4 of a percentage point). This increase was slightly counteracted by a decrease in the price index for transport (- 0,1 of a percentage point, mainly due to a 15c/l decrease in the price of petrol) (see table 3.12, p.20).

3. Rural areas

The annual percentage change in the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the rural areas was 7,6% at August 2007 (i.e. the CPIX at August 2007 compared with that at August 2006)

The annual percentage change in the CPIX, which is the Consumer Price Index excluding the interest rates on mortgage bonds, for the rural areas was 7,6% at August 2007 (i.e. the CPIX at August 2007 compared with that at August 2006). This rate was the same as the corresponding annual rate of 7,6% at July 2007.

From July 2007 to August 2007 the CPIX for the rural areas increased by 0,7%.

The annual increase of 7,6% in the Consumer Price Index excluding the interest rates on mortgage bonds (CPIX) for the rural areas was mainly due to annual contributions in the price indices for food (+ 5,4 percentage points), fuel and power (+ 0,5 of a percentage point), household operation (+ 0,5 of a percentage point), personal care (+ 0,4 of a percentage point), alcoholic beverages (+ 0,2 of a percentage point), housing excluding interest rates on mortgage bonds (+ 0,2 of a percentage point), medical care and health expenses (+ 0,2 of a percentage point) and education (+ 0,2 of a percentage point). These increases were slightly counteracted by decreases in the price indices for clothing and footwear (- 0,2 of a percentage point) and furniture and equipment (- 0,1 of a percentage point) (see table 3.13, p.21).

From July 2007 to August 2007 the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the rural areas increased by 0,7%. This monthly increase was due to a monthly contribution in the price index for food (+ 0,7 of a percentage point) (see table 3.14, p.21).

4. Total country

The annual percentage change in the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the total country was 6,5% at August 2007 (i.e. the CPIX at August 2007 compared with that at August 2006)

The annual percentage change in the CPIX, which is the Consumer Price Index excluding the interest rates on mortgage bonds, for the total country was 6,5% at August 2007 (i.e. the CPIX at August 2007 compared with that at August 2006). This rate was 0,1 of a percentage point lower than the corresponding annual rate of 6,6% at July 2007.

From July 2007 to August 2007 the CPIX for the total country increased by 0,5%.

The annual increase of 6,5% in the Consumer Price Index excluding the interest rates on mortgage bonds (CPIX) for the total country was mainly due to annual contributions in the price indices for food (+ 3,4 percentage points), housing excluding interest rates on mortgage bonds (+ 0,8 of a percentage point), medical care and health expenses (+ 0,5 of a percentage point), fuel and power (+ 0,4 of a percentage point), household operation (+ 0,4 of a percentage point), education (+ 0,3 of a percentage point), personal care (+ 0,3 of a percentage point), cigarettes, cigars and tobacco (+ 0,2 of a percentage point) and transport (+ 0,2 of a percentage point). These increases were slightly counteracted by a decrease in the price index for clothing and footwear (- 0,2 of a percentage point) (see table 3.15, p.21).

From July 2007 to August 2007 the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the total country increased by 0,5%. This monthly increase was due to a monthly contribution in the price index for food (+ 0,6 of a percentage point). This increase was slightly counteracted by a decrease in the price index for transport (- 0,1 of a percentage point, mainly due to a 15c/l decrease in the price of petrol) (see table 3.16, p.21).

C. Core Inflation Rate**1. Metropolitan areas**

The core inflation rate for the historical metropolitan areas was 5,1% at August 2007 (i.e. the core index at August 2007 compared with that at August 2006). This rate was 0,5 of a percentage point lower than the corresponding annual rate of 5,6% at July 2007.

From July 2007 to August 2007 the core index for the historical metropolitan areas increased by 0,1%.

The annual increase of 5,1% in the core index for the historical metropolitan areas was mainly due to annual contributions in the price indices for food (+ 1,6 percentage points), housing (+ 0,7 of a percentage point), medical care and health expenses (+ 0,5 of a percentage point), transport (+ 0,5 percentage points), fuel and power (+ 0,4 of a percentage point), education (+ 0,4 of a percentage point), personal care (+ 0,3 of a percentage point), alcoholic beverages (+ 0,2 of a percentage point), cigarettes, cigars and tobacco (+ 0,2 of a percentage point) and household operation (+ 0,2 of a percentage point). These increases were slightly counteracted by a decrease in the price index for clothing and footwear (- 0,2 of a percentage point) (see table 3.17, p.22).

From July 2007 to August 2007 the core index for the historical metropolitan areas increased by 0,1%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,2 of a percentage point) and communication (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,2 of a percentage point, mainly due to a 15c/l decrease in the price of petrol) (see table 3.18, p.22).

2. Metropolitan and other urban areas

The core inflation rate for the historical metropolitan and other urban areas was 5,5% at August 2007 (i.e. the core index at August 2007 compared with that at August 2006). This rate was 0,3 of a percentage point lower than the corresponding annual rate of 5,8% at July 2007. From July 2007 to August 2007 the core index for the historical metropolitan and other urban areas index increased by 0,2%.

The annual increase of 5,5% in the core index for the historical metropolitan and other urban areas was mainly due to annual contributions in the price indices for food (+ 1,6 percentage points), housing (+ 0,8 of a percentage point), fuel and power (+ 0,6 of a percentage point), medical care and health expenses (+ 0,6 of a percentage point), transport (+ 0,4 of a percentage point), education (+ 0,4 of a percentage point), household operation (+ 0,3 of a percentage point) and personal care (+ 0,3 of a percentage point). These increases were slightly counteracted by a decrease in the price index for clothing and footwear (- 0,1 of a percentage point) (see table 3.19, p.22).

From July 2007 to August 2007 the core index for the historical metropolitan and other urban areas increased by 0,2%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,2 of a percentage point) and communication (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,1 of a percentage point, mainly due to a 15c/l decrease in the price of petrol) (see table 3.20, p.22).

3. Rural areas

The core inflation rate for the rural areas was 6,7% at August 2007 (i.e. the core index at August 2007 compared with that at August 2006). This rate was the same as the corresponding annual rate of 6,7% at July 2007. From July 2007 to August 2007 the core index for the rural areas increased by 0,5%.

The annual increase of 6,7% in the core index for the rural areas was mainly due to annual contributions in the price indices for food (+ 3,7 percentage points), fuel and power (+ 0,8 of a percentage point), personal care (+ 0,5 of a percentage point), household operation (+ 0,4 of a percentage point), medical care and health expenses (+ 0,3 of a percentage point) and education (+ 0,3 of a percentage point). These increases were slightly counteracted by decreases in the price indices for clothing and footwear (- 0,3 of a percentage point) and furniture and equipment (- 0,1 of a percentage point) (see table 3.21, p.23).

From July 2007 to August 2007 the core index for the rural areas increased by 0,5%. This monthly increase was due to a monthly contribution in the price index for food (+ 0,6 of a percentage point). This increase was slightly counteracted by a decrease in the price index for transport (- 0,1 of a percentage point, mainly due to a 15c/l decrease in the price of petrol) (see table 3.22, p.23).

4. Total country

The core inflation rate for the total country was 5,6% at August 2007 (i.e. the core index at August 2007 compared with that at August 2006). This rate was 0,3 of a percentage point lower than the corresponding annual rate of 5,9% at July 2007. From July 2007 to August 2007 the core index for the total country increased by 0,3%.

The annual increase of 5,6% in the core index for the total country was mainly due to annual contributions in the price indices for food (+ 2,2 percentage points), medical care and health expenses (+ 0,7 of a percentage point), housing (+ 0,6 of a percentage point), transport (+ 0,4 of a percentage point), education (+ 0,4 of a percentage point), personal care (+ 0,4 of a percentage point), fuel and power (+ 0,3 of a percentage point), household operation (+ 0,3 of a percentage point), alcoholic beverages (+ 0,2 of a percentage point) and cigarettes, cigars and tobacco (+ 0,2 of a percentage point). These increases were slightly counteracted by a decrease in the price index for clothing and footwear (- 0,3 of a percentage point) (see table 3.23, p.23).

From July 2007 to August 2007 the core index for the total country increased by 0,3%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,3 of a percentage point) and communication (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,1 of a percentage point, mainly due to a 15c/l decrease in the price of petrol) (see table 3.24, p.23).

D. Other indices

1. Area indices

The rural areas of KwaZulu-Natal recorded the highest annual inflation rate at 10,0%, while the lowest annual inflation rate of 4,8% was recorded for the Free State Goldfields area (see table 7.1, p.36).

Regarding food prices, the highest annual inflation rate of 16,8% was recorded for the North West Province, while the lowest annual inflation rate of 7,0% was recorded for the Free State Goldfields area (see table 7.2, p.37).

2. Pensioners

The rural areas of Gauteng recorded the highest annual rate of increase of 11,9%, while the lowest annual rate of change of 4,8% was recorded for the East London area (see table 7.5, p.40).

3. Administered prices

The CPI for administered prices at August 2007 (i.e. the CPI for administered prices for the historical metropolitan areas at August 2007 compared with that at August 2006) was 4,5%. This rate was 2,1 percentage points lower than the corresponding annual rate of 6,6% at July 2007. The annual increase of 4,5% at August 2007 was mainly due to annual contributions in the price indices for school fees (+ 1,1 percentage points), electricity (+ 1,1 percentage points), assessment rates (+ 1,0 percentage point), water tariffs (+ 0,8 of a percentage point) and tertiary fees (+ 0,5 of a percentage point). These increases were slightly counteracted by a decrease in the price index for petrol (- 0,2 of a percentage point).

The CPIX for administered prices at August 2007 (i.e. the CPIX for administered prices for the historical metropolitan and other urban areas at August 2007 compared with that at August 2006) was 5,0%. This rate was 1,6 percentage points lower than the corresponding annual rate of 6,6% at July 2007. The annual increase of 5,0% at August 2007 was mainly due to annual contributions in the price indices for electricity (+ 1,4 percentage points), school fees (+ 1,0 percentage point), water tariffs (+ 0,9 of a percentage point), assessment rates (+ 0,9 of a percentage point) and tertiary fees (+ 0,5 of a percentage point). These increases were slightly counteracted by a decrease in the price index for petrol (- 0,2 of a percentage point).

4. An alternative expression of the change in the Consumer Price Index

An alternative expression of the change in the Consumer Price Index for the historical metropolitan areas is to annualise the percentage change between the average index of the three months up to August 2007 and the average index of the previous three months. This approach, when using unadjusted data, shows an increase of 10,3% (which is 0,6 of a percentage point lower than the corresponding rate of 10,9% for July 2007).

An alternative expression of the change in the Consumer Price Index for the historical metropolitan and other urban areas is to annualise the percentage change between the average index of the three months up to August 2007 and the average index of the previous three months. This approach, when using the unadjusted data, shows an increase of 10,3% (which is 0,2 of a percentage point lower than the corresponding rate of 10,5% for July 2007).

Survey methodology and design

18 Three sampling phases occur. Firstly, a sample of goods and services, based on the information collected through the IES is designed and selected. An indicator product is selected purposively within each product group. To be selected, a product should constitute a large quantity, at least 0, 01% of total expenditure. Furthermore, it must be possible to obtain price quotations for the relevant product throughout the whole year.

Secondly, a geographical sample for price collection is designed and selected. Currently 12 major metropolitan areas, covering all nine provinces, are included in the geographical sample for price collection. The “other urban areas” are covered by nine provincial samples of two to three other urban areas each, depending on the population size of the area. Therefore a total of 28 other urban areas” are sampled.

Thirdly, for each of the 40 sample areas, a retail trade and service outlet sampling frame is constructed, based on available data sources. The main sources are the Business Register of Stats SA, telephone directories and lists obtained from the head offices of chain stores. The sample is purposively distributed geographically within areas. Specific retail trade and service outlets are selected randomly within each area. Prices are collected from department stores, as well as specialist shops.

Currently, an average of 105 000 price quotations are collected each month from approximately 2 100 outlets.

Pricing basis

19 The prices of all items include VAT.

Processing of price information

20 The prices obtained are quality assured to ensure comparability with the information received in the previous month. The current price levels of prices changes between consecutive months that fall outside specified boundaries are confirmed.

Calculating product price indices

21 Price relatives are calculated for each product per respondent by dividing the current price by the price obtained in the previous period. The geometric mean of the price relatives for each respondent is calculated. This price relative for each product is then multiplied with the product index for the previous month in order to obtain a product index for the relevant month.

Calculating group price indices

22 Group price indices are calculated by weighting product indices with the relevant product weight, according to each weighting structure, using a modified Laspeyres formula. This formula is arithmetically equivalent to the standard Laspeyres formula but is considered more versatile, since the chaining process used allows for the introduction of replacement varieties as the need arises.

Contributions of specific items to the total CPI

23 The monthly (annual) contribution of a product or product group to the total CPI is calculated by multiplying the weight of the product or product group with the monthly (annual) change in the index for the product or product group and dividing by the index for ‘All items’.

CPI excluding interest rates on mortgage bonds (CPIX)	24	The CPIX is the CPI excluding interest rates on mortgage bonds. The SARB uses this index for inflation targeting purposes. These figures have been published since February 2000.
Administered prices	25	<p>An administered price can be defined as the price of a product or service, which is set consciously by an individual producer or group of producers and/or any price, which can be determined or influenced by government, either directly, or through one or other government agencies without reference to market forces. Special Data Dissemination Standard (SDDS) of the International Monetary Fund (IMF)	28	<p>South Africa's data dissemination practices are assessed against the IMF's Special Data Dissemination Standard (SDDS). A detailed description of the SDDS can be found on the IMF's Dissemination Standards Bulletin Board on the internet at http://dsbb.imf.org. This is an international best practice standard. It covers the real, fiscal, financial and external sectors of the economy. It covers the following dimensions of data dissemination: data, access, integrity and quality. Reports on Observance of Standards and Codes (ROSC) of the International Monetary Fund (IMF)	29	<p>The IMF has been working actively on producing Reports on Observance of Standards and Codes (ROSC) as a step to strengthen the architecture of the international financial system. One of the ROSC components is the data dissemination module, which falls under the responsibility of the IMF's Statistics Department (STA). In this module, a country is assessed according to the SDDS.</p> <p>The data dissemination module of the ROSC provides a summary of South Africa's practices on the coverage, periodicity and timeliness of the data categories specified in the IMF's SDDS, and on the practices on the provision of advance release calendars for these categories. It is complemented by an assessment of the quality of the CPI, using the Data Quality Assessment Framework (DQAF) developed by the IMF's Statistics Department. GLOSSARY

Annual inflation rate	The annual inflation rate is the change in the CPI for all items of the relevant month of the current year compared with the CPI for all items of the same month in the previous year expressed as a percentage.
Annual percentage change	The annual percentage change is the change in the index of the relevant month of the current year compared with the index of the same month in the previous year expressed as a percentage.
Average annual inflation rate	The average annual inflation rate is the change in the average CPI for all items of one year compared with the average CPI for all items of the previous year expressed as a percentage.
Average annual percentage change	The average annual percentage change is the change in the average index of one year compared with the average index of the previous year expressed as a percentage.
CPI excluding interest rates on mortgage bonds (CPIX)	The CPI excluding interest rates on mortgage bonds (CPIX) is derived by excluding the interest rates on mortgage bonds from the basket of goods and services.
CPI for administered prices	An administered price is defined as the price of a product, which is set consciously by an individual producer or group of producers and/or any price, which can be determined or influenced by government, either directly, or through one or other government agencies/institutions without reference to market forces.
CPI for regulated prices	Regulated prices are those administered prices that are said to be monitored and controlled by government policy. To this end, price regulation does not necessarily imply the presence of an economic regulator, but the restriction on the extent to which prices may vary, depending on government's policy objective.
Core index	<p>The core index is derived by exclusions from the CPI on the basis that changes in their prices are policy. Exclusions from the CPI to obtain the core index, and the reasons for exclusion are as follows:</p> <ul style="list-style-type: none"> • Fresh and frozen meat and fish: Prices may be highly volatile, particularly during and following periods of drought. • Fresh and frozen vegetables and fresh fruit and nuts: Prices may be highly volatile from month to month due to their sensitivity to climatic conditions. • Interest rates on mortgage bonds and overdrafts/personal loans: These are excluded due to their "perverse" effect on the CPI. A tightening in monetary policy to counter inflation pressures would cause interest rates to rise and be reflected in the interest cost component of measured inflation. This, in turn, could provoke a further tightening of monetary policy resulting in excessive movements in the inflation rate. • Changes in VAT (Value Added Tax): VAT is predominantly determined by government (fiscal policy). • Assessment rates: These taxes are predominantly determined by local government.
Core inflation	The core inflation is derived by the change in the Core index of the relevant month of the current year compared with the Core index of the same month in the previous year expressed as a percentage.
Indicator products	Indicator products are those products or services that were selected in the basket, which is used to compile the Consumer Price Index.
Inflation rate	Inflation rate is the annual percentage change in the CPI for all items of the relevant month of the current year compared with the CPI for all items of the same month in the previous year expressed as a percentage.

Monthly percentage change	The monthly percentage change is the change in the CPI of the relevant month compared to the CPI of the previous month expressed as a percentage.
Weights	The weights are the relevant importance of the indicator product. The weight of a product is calculated by dividing the total expenditure by households on that product by the total expenditure on all goods and services by households.
