## INFLATION OVERVIEW

The headline CPI annual inflation rate at August 2008 was 13,7%.

The annual change in CPIX, the monetary policy inflation target measure, was 13,6% at August 2008.

The headline inflation rate (year-on-year) was 0,3 of a percentage point higher than the 13,4% recorded at July 2008. The year-on-year increase in the CPIX for August 2008 was 0,6 of a percentage point higher than the 13,0% y/y increase recorded at July 2008.

This higher headline rate at August 2008 can be explained by increases in the annual rates of change for:

- The CPI for fuel and power which increased to 28,8% at August 2008 from 23,4% at July 2008, mainly due to an increase in electricity tariffs.
- The CPI for food which increased to 18,8% at August 2008 from 17,8% at July 2008.
- The CPI for household operation which increased to 14,6% at August 2008 from 13,4% at July 2008.

These increases were slightly counteracted by decreases in the price indices for:

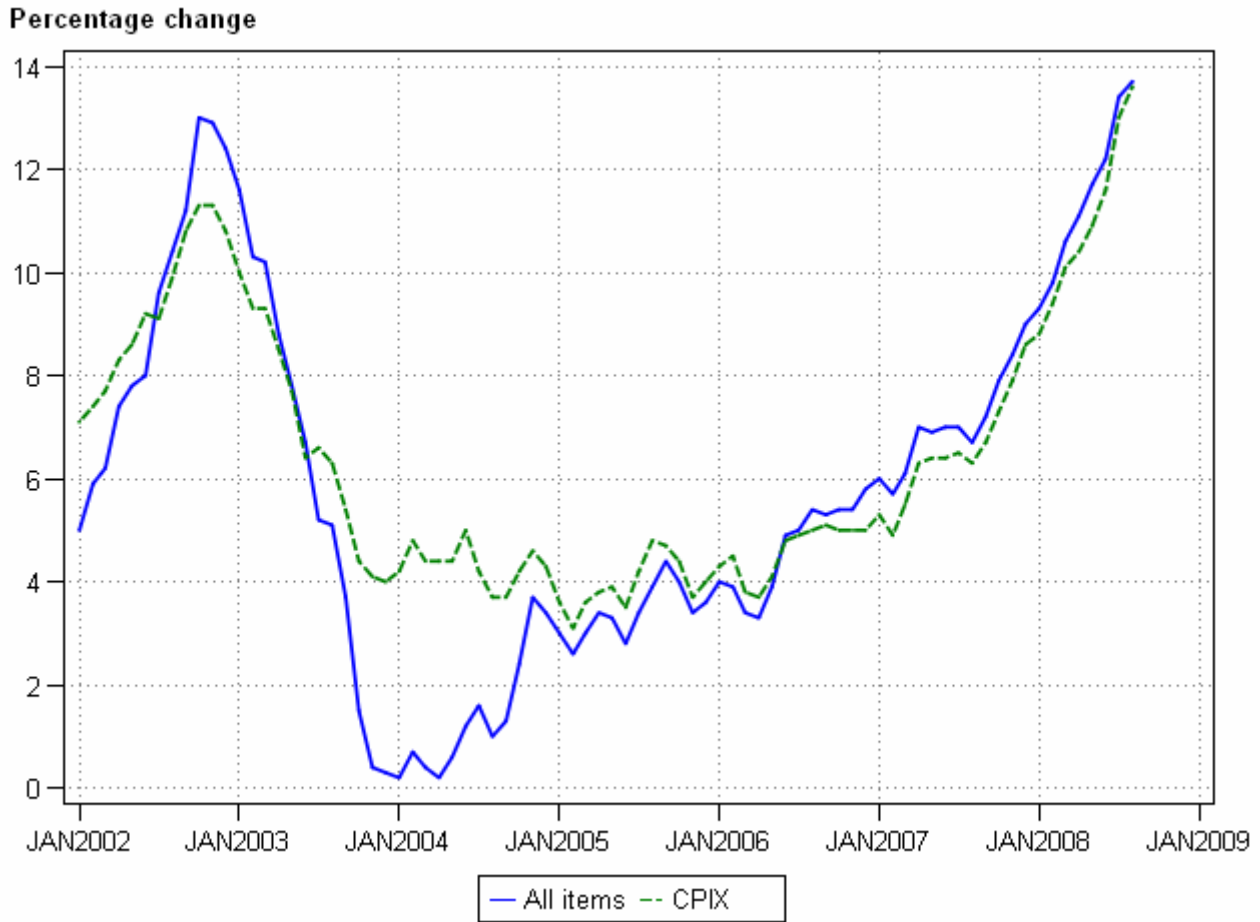
- The CPI for transport which decreased to 22,7% at August 2008 from 23,5% at July 2008, mainly due to a decrease in the price of petrol.
- The CPI for housing which decreased to 9,7% at August 2008 from 11,0% at July 2008.

The main contributors to the annual increase of 13,7% in the CPI at August 2008 were food (+ 4,4 percentage points), transport (+ 3,4 percentage points), housing (+ 2,1 percentage points), fuel and power (+ 1,1 percentage points), household operation (+ 0,7 of a percentage point), medical care and health expenses (+ 0,6 of a percentage point) and education (+ 0,4 of a percentage point) (see table 3.1 on page 18).

The annual rate of increase in food prices for the historical metropolitan areas was 18,8% at August 2008. This rate was 1,0 percentage point higher than the corresponding annual rate of 17,8% at July 2008. The increase of 18,8% was due to increases in the prices of grain products, meat, other food products, fats and oils, milk, cheese and eggs, vegetables, coffee, tea and cocoa, fruit and nuts, fish and other seafood and sugar.

The annual rate of increase in the price index for non-food items for metropolitan areas was 12,2% at August 2008. This rate was 0,1 of a percentage point higher than the corresponding annual rate of 12,1% at July 2008. Annual increases occurred in the price indices for fuel and power (+ 28,8%), transport (+ 22,7%), clothing and footwear (+ 17,2%), household operation (+ 14,6%), housing (+ 9,7%), education (+ 8,8%), cigarettes, cigars and tobacco (+ 8,4%), non-alcoholic beverages (+ 8,0%), personal care (+ 6,9%), medical care and health expenses (+ 6,6%), alcoholic beverages (+ 6,5%), reading matter (+ 5,4%), other products (+ 4,1%), communication (+ 3,2%) and recreation and entertainment (+ 1,6%). These increases were slightly counteracted by a decrease in the price index for furniture and equipment (- 0,1%).

## NOTES

### CPI for September 2008

As indicated in the planned schedule of price surveys, explanatory notes 15, 16 and 17, sanitary fees are surveyed in July and electricity and water tariffs are surveyed in January, July and August. It has come to Stats SA's attention that price changes in these items will be introduced during September 2008. Additional surveys for these items will be conducted in certain areas in September 2008 to capture these changes.

### Electricity

It has come to Stats SA's attention that price changes in the electricity tariffs will be introduced in the rest of 2008 and additional surveys will therefore be conducted throughout the rest of 2008.

### Clothing and footwear

The January 2008 CPI release contained changes to the methods used for collecting prices for and compiling the clothing and footwear index. Following the release of the January 2008 figures, Stats SA published an explanatory note on this matter. This note is available on the Stats SA website.

In order to assist users in understanding the impact of the change in method for clothing and footwear, Stats SA has committed to publishing the 'non-discounted' indices and rates of change for information purposes. We will also publish the impact of comparing the old 'discounted' index with the new 'non-discounted' index on the year on year rates of change of the various aggregate indices. This information follows below.

## KEY FINDINGS

### A. Consumer Price Index

#### 1. Metropolitan areas

*The headline inflation rate at August 2008 (i.e. the Consumer Price Index for the historical metropolitan areas at August 2008 compared with that at August 2007) was 13,7%*

*The official inflation rate (i.e. the percentage change in the CPI for the historical metropolitan areas at August 2008 compared with that at August 2007) was 13,7% at August 2008. This rate was 0,3 of a percentage point higher than the corresponding annual rate of 13,4% at July 2008 (see table 2.1.1, p.16).*

*This higher headline rate at August 2008 can be explained by increases in the annual rates of change for:*

- *The CPI for fuel and power which increased to 28,8% at August 2008 from 23,4% at July 2008, mainly due to an increase in electricity tariffs.*
- *The CPI for food which increased to 18,8% at August 2008 from 17,8% at July 2008.*
- *The CPI for household operation which increased to 14,6% at August 2008 from 13,4% at July 2008.*

*These increases were slightly counteracted by decreases in the price indices for:*

- *The CPI for transport which decreased to 22,7% at August 2008 from 23,5% at July 2008, mainly due to a decrease in the price of petrol.*
- *The CPI for housing which decreased to 9,7% at August 2008 from 11,0% at July 2008.*

**The inflation rate for the historical metropolitan and other urban areas was 13,6% at August 2008 (i.e. the CPI at August 2008 compared with that at August 2007)**

**This higher rate at August 2008 can be explained by increases in the annual rates of change for:**

- *The CPI annual rate for fuel and power which increased to 28,2% at August 2008 from 23,9% at July 2008.*
- *The CPI annual rate for food which increased to 19,2% at August 2008 from 18,5% at July 2008.*
- *The CPI annual rate for communication which increased to 3,4% at August 2008 from 2,1% at July 2008.*

**These increases were slightly counteracted by decreases in the price indices for:**

- *The CPI for transport which decreased to 21,0% at August 2008 from 21,8% at July 2008, mainly due to a decrease in the price of petrol.*
- *The CPI for housing which decreased to 9,5% at August 2008 from 10,8% at July 2008.*

**From July 2008 to August 2008 the Consumer Price Index for the historical metropolitan and other urban areas increased by 0,8.**

The annual increase of 13,6% in the Consumer Price Index for the historical metropolitan and other urban areas was mainly due to annual contributions in the price indices for food (+ 4,9 percentage points), transport (+ 2,9 percentage points), housing (+ 1,8 percentage points), fuel and power (+ 1,2 percentage points), household operation (+ 0,7 of a percentage point), medical care and health expenses (+ 0,6 of a percentage point) and education (+ 0,4 of a percentage point) (see table 3.3, p.18).

From July 2008 to August 2008 the Consumer Price Index for the historical metropolitan and other urban areas increased by 0,8%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,5 of a percentage point), fuel and power (+ 0,2 of a percentage point), cigarettes, cigars and tobacco (+ 0,1 of a percentage point), communication (+ 0,1 of a percentage point) and personal care (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,2 of a percentage point, mainly due to a 30c/l decrease in the price of petrol) (see table 3.4, p.18).

### 3. Rural areas

**The inflation rate for the rural areas was 15,1% at August 2008 (i.e. the CPI at August 2008 compared with that at August 2007)**

***The inflation rate for the rural areas was 15,1% at August 2008 (i.e. the CPI at August 2008 compared with that at August 2007). This rate was 0,8 of a percentage point higher than corresponding annual rate of 14,3% at July 2008.***

***This higher rate at August 2008 can be explained by increases in the annual rates of change for:***

- The CPI for fuel and power which increased to 29,0% at August 2008 from 20,9% at July 2008.
- The CPI for food which increased to 20,3% at August 2008 from 20,2% at July 2008.
- The CPI for household operation which increased to 17,5% at August 2008 from 15,5% at July 2008.
- The CPI for personal care which increased to 12,0% at August 2008 from 10,2% at July 2008.

***These increases were slightly counteracted by a decrease in the price index for:***

- ***The CPI for transport which decreased to 14,2% at August 2008 from 14,7% at July 2008, mainly due to a decrease in the price of petrol.***

**From July 2008 to August 2008 the Consumer Price Index for the rural areas increased by 1,5%.**

The annual increase of 15,1% in the Consumer Price Index for the rural areas was mainly due to annual contributions in the price indices for food (+ 8,6 percentage points), fuel and power (+ 1,8 percentage points), household operation (+ 1,2 percentage points), transport (+ 1,2 percentage points), personal care (+ 0,6 of a percentage point), housing (+ 0,4 of a percentage point) and clothing and footwear (+ 0,3 of a percentage point) (see table 3.5, p.19)

From July 2008 to August 2008 the Consumer Price Index for the rural areas increased by 1,5%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,9 of a percentage point), fuel and power (+ 0,5 of a percentage point), household operation (+ 0,1 of a percentage point) and personal care (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,1 of a percentage point, mainly due to the 30c/l decrease in the price of petrol) (see table 3.6, p.19).

### 4. Total country

**The inflation rate for the total country was 14,0% at August 2008 (i.e. the CPI at August 2008 compared with that at August 2007)**

***The inflation rate for the total country was 14,0% at August 2008 (i.e. the CPI at August 2008 compared with that at August 2007). This rate was 0,3 of a percentage point higher than the corresponding annual rate of 13,7% at July 2008.***



***This higher rate at August 2008 can be explained by increases in the annual rates of change for:***

- ***The CPI for fuel and power which increased to 28,3% at August 2008 from 23,2% at July 2008.***
- ***The CPI for food which increased to 19,4% at August 2008 from 18,9% at July 2008.***
- ***The CPI for household operation which increased to 15,4% at August 2008 from 14,0% at July 2008.***
- ***The CPI for personal care which increased to 9,4% at August 2008 from 8,0% at July 2008.***
- ***The CPI for communication which increased to 3,4% at August 2008 from 1,8% at July 2008.***

***These increases were slightly counteracted by decreases in the price indices for:***

- ***The CPI for transport which decreased to 20,6% at August 2008 from 21,3% at July 2008, mainly due to a decrease in the price of petrol.***
- ***The CPI for housing which decreased to 9,5% at August 2008 from 10,7% at July 2008.***

**From July 2008 to August 2008 the Consumer Price Index for the total country increased by 0,9%.**

The annual increase of 14,0% in the Consumer Price Index for the total country was mainly due to annual contributions in the price indices for food (+ 5,7 percentage points), transport (+ 2,6 percentage points), housing (+ 1,7 percentage points), fuel and power (+ 1,2 percentage points), household operation (+ 0,8 of a percentage point) and medical care and health expenses (+ 0,5 of a percentage point) (see table 3.7, p.19).

From July 2008 to August 2008 the Consumer Price Index for the total country increased by 0,9%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,5 of a percentage point), fuel and power (+ 0,2 of a percentage point), cigarettes, cigars and tobacco (+ 0,1 of a percentage point), household operation (+ 0,1 of a percentage point), communication (+ 0,1 of a percentage point) and personal care (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,2 of a percentage point, mainly due to a 30c/l decrease in the price of petrol) (see table 3.8, p.19).

## **B. Consumer Price Index excluding interest rates on mortgage bonds (CPIX)**

### **1. Metropolitan areas**

**The annual percentage change in the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the historical metropolitan areas was 13,6% at August 2008 (i.e. the percentage change in the CPIX at August 2008 compared with that at August 2007)**

This rate was 0,6 of a percentage point higher than the corresponding annual rate of 13,0% at July 2008.***

**From July 2008 to August 2008 the CPIX for the historical metropolitan areas increased by 0,8%.**

The annual increase of 13,6% in the CPIX for the historical metropolitan areas was mainly due to annual contributions in the price indices for food (+ 4,8 percentage points), transport (+ 3,7 percentage points), fuel and power (+ 1,2 percentage points), housing excluding interest rates on mortgage bonds (+ 1,0 percentage point), household operation (+ 0,8 of a percentage point), medical care and health expenses (+ 0,6 of a percentage point) and education (+ 0,4 of a percentage point) (see table 3.9, p.20).

From July 2008 to August 2008 the CPIX for the historical metropolitan areas increased by 0,8%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,5 of a percentage point), fuel and power (+ 0,2 of a percentage point), cigarettes, cigars and tobacco (+ 0,1 of a percentage point), household operation (+ 0,1 of a percentage point), communication (+ 0,1 of a percentage point) and personal care (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,3 of a percentage point, mainly due to a 30c/l decrease in the price of petrol) (see table 3.10, p.20).

## 2. Metropolitan and other urban areas

The annual percentage change in the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the historical metropolitan and other urban areas was 13,6% at August 2008 (i.e. the CPIX at August 2008 compared with that at August 2007)

*The annual percentage change in the CPIX, which is the Consumer Price Index excluding interest rates on mortgage bonds, for the historical metropolitan and other urban areas was 13,6% at August 2008 (i.e. the CPIX at August 2008 compared with that at August 2007). This rate was 0,6 of a percentage point higher than the corresponding annual rate of 13,0% at July 2008.*

From July 2008 to August 2008 the CPIX for the historical metropolitan and other urban areas increased by 0,9%.

The annual increase of 13,6% in the CPIX for the historical metropolitan and other urban areas was mainly due to annual contributions in the price indices for food (+ 5,3 percentage points), transport (+ 3,1 percentage points), fuel and power (+ 1,3 percentage points), housing excluding interest rates on mortgage bonds (+ 0,9 of a percentage point), household operation (+ 0,8 of a percentage point), medical care and health expenses (+ 0,6 of a percentage point), education (+ 0,4 of a percentage point), clothing and footwear (+ 0,3 of a percentage point) and personal care (+ 0,3 of a percentage point) (see table 3.11, p.20).

From July 2008 to August 2008 the CPIX for the historical metropolitan and other urban areas increased by 0,9%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,5 of a percentage point), fuel and power (+ 0,2 of a percentage point), cigarettes, cigars and tobacco (+ 0,1 of a percentage point), household operation (+ 0,1 of a percentage point), communication (+ 0,1 of a percentage point) and personal care (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,2 of a percentage point, mainly due to a 30c/l decrease in the price of petrol) (see table 3.12, p.20).

## 3. Rural areas

The annual percentage change in the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the rural areas was 15,2% at August 2008 (i.e. the CPIX at August 2008 compared with that at August 2007)

*The annual percentage change in the CPIX, which is the Consumer Price Index excluding the interest rates on mortgage bonds, for the rural areas was 15,2% at August 2008 (i.e. the CPIX at August 2008 compared with that at August 2007). This rate was 0,8 of a percentage point higher than the corresponding annual rate of 14,4% at July 2008.*

From July 2008 to August 2008 the CPIX for the rural areas increased by 1,4%.

The annual increase of 15,2% in the Consumer Price Index excluding the interest rates on mortgage bonds (CPIX) for the rural areas was mainly due to annual contributions in the price indices for food (+ 8,5 percentage points), fuel and power (+ 1,8 percentage points), household operation (+ 1,3 percentage points), transport (+ 1,3 percentage points), personal care (+ 0,6 of a percentage point), clothing and footwear (+ 0,3 of a percentage point) and education (+ 0,3 of a percentage point) (see table 3.13, p.21).

From July 2008 to August 2008 the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the rural areas increased by 1,4%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,8 of a percentage point), fuel and power (+ 0,5 of a percentage point), household operation (+ 0,1 of a percentage point) and personal care (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,1 of a percentage point, mainly due to a 30c/l decrease in the price of petrol) (see table 3.14, p.21).

#### 4. Total country

The annual percentage change in the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the total country was 13,8% at August 2008 (i.e. the CPIX at August 2008 compared with that at August 2007)

*The annual percentage change in the CPIX, which is the Consumer Price Index excluding the interest rates on mortgage bonds, for the total country was 13,8% at August 2008 (i.e. the CPIX at August 2008 compared with that at August 2007). This rate was 0,5 of a percentage point higher than the corresponding annual rate of 13,3% at July 2008.*

**From July 2008 to August 2008 the CPIX for the total country increased by 0,9%.**

The annual increase of 13,8% in the Consumer Price Index excluding the interest rates on mortgage bonds (CPIX) for the total country was mainly due to annual contributions in the price indices for food (+ 5,9 percentage points), transport (+ 2,8 percentage points), fuel and power (+ 1,3 percentage points), housing excluding interest rates on mortgage bonds (+ 0,8 of a percentage point), household operation (+ 0,8 of a percentage point), medical care and health expenses (+ 0,5 of a percentage point), education (+ 0,4 of a percentage point), personal care (+ 0,4 of a percentage point) and clothing and footwear (+ 0,3 of a percentage point) (see table 3.15, p.21).

From July 2008 to August 2008 the Consumer Price Index excluding interest rates on mortgage bonds (CPIX) for the total country increased by 0,9%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,5 of a percentage point), fuel and power (+ 0,2 of a percentage point), cigarettes, cigars and tobacco (+ 0,1 of a percentage point), household operation (+ 0,1 of a percentage point), communication (+ 0,1 of a percentage point) and personal care (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,2 of a percentage point, mainly due to a 30c/l decrease in the price of petrol) (see table 3.16, p.21).

### C. Core Inflation Rate

#### 1. Metropolitan areas

The core inflation rate for the historical metropolitan areas was 14,3% at August 2008 (i.e. the core index at August 2008 compared with that at August 2007). This rate was 0,6 of a percentage point higher than the corresponding annual rate of 13,7% at July 2008.

**From July 2008 to August 2008 the core index for the historical metropolitan areas increased by 0,6%.**

The annual increase of 14,3% in the core index for the historical metropolitan areas was mainly due to annual contributions in the price indices for transport (+ 4,7 percentage points), food (+ 3,9 percentage points), fuel and power (+ 1,4 percentage points), housing (+ 0,9 of a percentage point), household operation (+ 0,9 of a percentage point), medical care and health expenses (+ 0,7 of a percentage point), education (+ 0,5 of a percentage point), clothing and footwear (+ 0,4 of a percentage point) and personal care (+ 0,4 of a percentage point) (see table 3.17, p.22).

From July 2008 to August 2008 the core index for the historical metropolitan areas increased by 0,6%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,3 of a percentage point), fuel and power (+ 0,2 of a percentage point), cigarettes, cigars and tobacco (+ 0,1 of a percentage point), household operation (+ 0,1 of a percentage point), communication (+ 0,1 of a percentage point) and personal care (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,3 of a percentage point, mainly due to a 30c/l decrease in the price of petrol) (see table 3.18, p.22).

#### 2. Metropolitan and other urban areas

The core inflation rate for the historical metropolitan and other urban areas was 14,2% at August 2008 (i.e. the core index at August 2008 compared with that at August 2007). This rate was 0,6 of a percentage point higher than the corresponding annual rate of 13,6% at August 2008.

**From July 2008 to August 2008 the core index for the historical metropolitan and other urban areas index increased by 0,7%.**

The annual increase of 14,2% in the core index for the historical metropolitan and other urban areas was mainly due to annual contributions in the price indices for food (+ 4,2 percentage points), transport (+ 3,9 percentage points), fuel and power (+ 1,6 percentage points), housing (+ 0,9 of a percentage point), household operation (+ 0,9 of a percentage point), medical care and health expenses (+ 0,7 of a percentage point), education (+ 0,4 of a percentage point), personal care (+ 0,4 of a percentage point), non-alcoholic beverages (+ 0,3 of a percentage point) and clothing and footwear (+ 0,3 of a percentage point) (see table 3.19, p.22).

From July 2008 to August 2008 the core index for the historical metropolitan and other urban areas increased by 0,7%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,3 of a percentage point), fuel and power (+ 0,2 of a percentage point), cigarettes, cigars and tobacco (+ 0,1 of a percentage point), household operation (+ 0,1 of a percentage point), communication (+ 0,1 of a percentage point) and personal care (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,2 of a percentage point, mainly due to a 30c/l decrease in the price of petrol) (see table 3.20, p.22).

### 3. Rural areas

**The core inflation rate for the rural areas was 15,9% at August 2008 (i.e. the core index at August 2008 compared with that at August 2007). This rate was 1,1 percentage points higher than the corresponding annual rate of 14,8% at August 2008.**

**From July 2008 to August 2008 the core index for the rural areas increased by 1,5%.**

The annual increase of 15,9% in the core index for the rural areas was mainly due to annual contributions in the price indices for food (+ 6,3 percentage points), transport (+ 2,5 percentage points), fuel and power (+ 2,1 percentage points), household operation (+ 1,6 percentage points), personal care (+ 0,9 of a percentage point), clothing and footwear (+ 0,6 of a percentage point), housing (+ 0,4 of a percentage point), medical care and health expenses (+ 0,4 of a percentage point), cigarettes, cigars and tobacco (+ 0,3 of a percentage point) and education (+ 0,3 of a percentage point) (see table 3.21, p.23).

From July 2008 to August 2008 the core index for the rural areas increased by 1,5%. This monthly increase was due to monthly contributions in the indices for food (+ 0,9 of a percentage point), fuel and power (+ 0,4 of a percentage point), cigarettes, cigars and tobacco (+ 0,1 of a percentage point), household operation (+ 0,1 of a percentage point) and personal care (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,1 of a percentage point, mainly due to a 30c/l decrease in the price of petrol) (see table 3.22, p.23).

### 4. Total country

**The core inflation rate for the total country was 14,6% at August 2008 (i.e. the core index at August 2008 compared with that at August 2007). This rate was 0,7 of a percentage point higher than the corresponding annual rate of 13,9% at August 2008.**

**From July 2008 to August 2008 the core index for the total country increased by 0,9%.**

The annual increase of 14,6% in the core index for the total country was mainly due to annual contributions in the price indices for food (+ 4,8 percentage points), transport (+ 4,1 percentage points), household operation (+ 1,1 percentage points), fuel and power (+ 0,9 of a percentage point), medical care and health expenses (+ 0,8 of a percentage point), housing (+ 0,6 of a percentage point), personal care (+ 0,6 of a percentage point), education (+ 0,5 of a percentage point) and clothing and footwear (+ 0,4 of a percentage point) (see table 3.23, p.23).

From July 2008 to August 2008 the core index for the total country increased by 0,9%. This monthly increase was due to monthly contributions in the price indices for food (+ 0,6 of a percentage point), cigarettes, cigars and tobacco (+ 0,1 of a percentage point), fuel and power (+ 0,1 of a percentage point), household operation (+ 0,1 of a percentage point), communication (+ 0,1 of a percentage point) and personal care (+ 0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (- 0,2 of a percentage point, mainly due to a 30c/l decrease in the price of petrol) (see table 3.24, p.23).

## D. Other indices

### 1. Area indices

The Pietermaritzburg area recorded the highest annual inflation rate at 16,8%, while the lowest annual inflation rate of 12,1% was recorded for the Free State Goldfields area (see table 7.1, p.36).

Regarding food prices, the highest annual inflation rate of 22,5% was recorded for the North West province, while the lowest annual inflation rate of 16,8% was recorded for the Port Elizabeth/Uitenhage area and Pretoria/Centurion/Aksia area (see table 7.2, p.37).

### 2. Pensioners

The rural areas of Gauteng recorded the highest annual rate of increase of 17,6%, while the lowest annual rate of change of 11,3% was recorded for the Pretoria/Centurion/Akasia area (see table 7.5, p.40).

### 3. Administered prices

The CPI for administered prices at August 2008 (i.e. the CPI for administered prices for the historical metropolitan areas at August 2008 compared with that at August 2007) was 24,2%. This rate was 0,8 of a percentage point higher than the corresponding annual rate of 23,4% at July 2008. The annual increase of 24,2% at August 2008 was mainly due to annual contributions in the price indices for petrol (+ 16,4 percentage points), electricity (+ 4,6 percentage points), school fees (+ 1,2 percentage points), assessment rates (+ 0,8 of a percentage point), water tariffs (+ 0,7 of a percentage point), paraffin (+ 0,7 of a percentage point) and tertiary fees (+ 0,5 of a percentage point).

The CPIX for administered prices at August 2008 (i.e. the CPIX for administered prices for the historical metropolitan and other urban areas at August 2008 compared with that at August 2007) was 22,1%. This rate was 0,9 of a percentage point higher than the corresponding annual rate of 21,2% at July 2008. The annual increase of 22,1% at August 2008 was mainly due to annual contributions in the price indices for petrol (+ 13,5 percentage points), electricity (+ 5,0 percentage points), school fees (+ 1,1 percentage points), paraffin (+ 0,8 of a percentage point), water tariffs (+ 0,8 of a percentage point), assessment rates (+ 0,7 of a percentage point) and tertiary fees (+ 0,5 of a percentage point).

### 4. An alternative expression of the change in the Consumer Price Index

An alternative expression of the change in the Consumer Price Index for the historical metropolitan areas is to annualise the percentage change between the average index of the three months up to August 2008 and the average index of the previous three months. This approach, when using unadjusted data, shows an increase of 18,5% (which is 0,6 of a percentage point lower than the corresponding rate of 19,1% for July 2008).

An alternative expression of the change in the Consumer Price Index for the historical metropolitan and other urban areas is to annualise the percentage change between the average index of the three months up to August 2008 and the average index of the previous three months. This approach, when using the unadjusted data, shows an increase of 18,6% (which is 0,1 of a percentage point higher than the corresponding rate of 18,5% for July 2008).

The CPI is a measure of pure price change; hence it excludes the effect of changes in quality or quantity of goods and services. | <b>Uses and users of the CPI</b>                            | <b>3</b> | The South African Reserve Bank (SARB) and the Department of Finance use the CPI when formulating monetary and fiscal policy. The National Accounts component of Statistics South Africa (Stats SA) uses the CPI when calculating the Gross Domestic Product (GDP). **Survey methodology and design**

18 Three sampling phases occur. Firstly, a sample of goods and services, based on the information collected through the IES is designed and selected. An indicator product is selected purposively within each product group. To be selected, a product should constitute a large quantity, at least 0, 01% of total expenditure. Furthermore, it must be possible to obtain price quotations for the relevant product throughout the whole year.

Secondly, a geographical sample for price collection is designed and selected. Currently 12 major metropolitan areas, covering all nine provinces, are included in the geographical sample for price collection. The “other urban areas” are covered by nine provincial samples of two to three other urban areas each, depending on the population size of the area. Therefore a total of 28 other urban areas” are sampled.

Thirdly, for each of the 40 sample areas, a retail trade and service outlet sampling frame is constructed, based on available data sources. The main sources are the Business Register of Stats SA, telephone directories and lists obtained from the head offices of chain stores. The sample is purposively distributed geographically within areas. Specific retail trade and service outlets are selected randomly within each area. Prices are collected from department stores, as well as specialist shops.

Currently, an average of 105 000 price quotations are collected each month from approximately 2 100 outlets.

**Pricing basis**

19 The prices of all items include VAT.

**Processing of price information**

20 The prices obtained are quality assured to ensure comparability with the information received in the previous month. The current price levels of prices changes between consecutive months that fall outside specified boundaries are confirmed.

**Calculating product price indices**

21 Price relatives are calculated for each product per respondent by dividing the current price by the price obtained in the previous period. The geometric mean of the price relatives for each respondent is calculated. This price relative for each product is then multiplied with the product index for the previous month in order to obtain a product index for the relevant month.

**Calculating group price indices**

22 Group price indices are calculated by weighting product indices with the relevant product weight, according to each weighting structure, using a modified Laspeyres formula. This formula is arithmetically equivalent to the standard Laspeyres formula but is considered more versatile, since the chaining process used allows for the introduction of replacement varieties as the need arises.

**Contributions of specific items to the total CPI**

23 The monthly (annual) contribution of a product or product group to the total CPI is calculated by multiplying the weight of the product or product group with the monthly (annual) change in the index for the product or product group and dividing by the index for ‘All items’.

**CPI excluding interest rates on mortgage bonds (CPIX)**

24 The CPIX is the CPI excluding interest rates on mortgage bonds. The SARB uses this index for inflation targeting purposes. These figures have been published since February 2000.

<b>Administered prices</b>	<b>25</b>	<p>An administered price can be defined as the price of a product or service, which is set consciously by an individual producer or group of producers and/or any price, which can be determined or influenced by government, either directly, or through one or other government agencies without reference to market forces. This is an international best practice standard. It covers the real, fiscal, financial and external sectors of the economy. ## GLOSSARY

<b>Annual inflation rate</b>	The annual inflation rate is the change in the CPI for all items of the relevant month of the current year compared with the CPI for all items of the same month in the previous year expressed as a percentage.
<b>Annual percentage change</b>	The annual percentage change is the change in the index of the relevant month of the current year compared with the index of the same month in the previous year expressed as a percentage.
<b>Average annual inflation rate</b>	The average annual inflation rate is the change in the average CPI for all items of one year compared with the average CPI for all items of the previous year expressed as a percentage.
<b>Average annual percentage change</b>	The average annual percentage change is the change in the average index of one year compared with the average index of the previous year expressed as a percentage.
<b>CPI excluding interest rates on mortgage bonds (CPIX)</b>	The CPI excluding interest rates on mortgage bonds (CPIX) is derived by excluding the interest rates on mortgage bonds from the basket of goods and services.
<b>CPI for administered prices</b>	An administered price is defined as the price of a product, which is set consciously by an individual producer or group of producers and/or any price, which can be determined or influenced by government, either directly, or through one or other government agencies/institutions without reference to market forces.
<b>CPI for regulated prices</b>	Regulated prices are those administered prices that are said to be monitored and controlled by government policy. To this end, price regulation does not necessarily imply the presence of an economic regulator, but the restriction on the extent to which prices may vary, depending on government's policy objective.
<b>Core index</b>	<p>The core index is derived by exclusions from the CPI on the basis that changes in their prices are policy. Exclusions from the CPI to obtain the core index, and the reasons for exclusion are as follows:</p> <ul style="list-style-type: none"> <li>• Fresh and frozen meat and fish: Prices may be highly volatile, particularly during and following periods of drought.</li> <li>• Fresh and frozen vegetables and fresh fruit and nuts: Prices may be highly volatile from month to month due to their sensitivity to climatic conditions.</li> <li>• Interest rates on mortgage bonds and overdrafts/personal loans: These are excluded due to their "perverse" effect on the CPI. A tightening in monetary policy to counter inflation pressures would cause interest rates to rise and be reflected in the interest cost component of measured inflation. This, in turn, could provoke a further tightening of monetary policy resulting in excessive movements in the inflation rate.</li> <li>• Changes in VAT (Value Added Tax): VAT is predominantly determined by government (fiscal policy).</li> <li>• Assessment rates: These taxes are predominantly determined by local government.</li> </ul>
<b>Core inflation</b>	The core inflation is derived by the change in the Core index of the relevant month of the current year compared with the Core index of the same month in the previous year expressed as a percentage.
<b>Indicator products</b>	Indicator products are those products or services that were selected in the basket, which is used to compile the Consumer Price Index.
<b>Inflation rate</b>	Inflation rate is the annual percentage change in the CPI for all items of the relevant month of the current year compared with the CPI for all items of the same month in the previous year expressed as a percentage.

<b>Monthly percentage change</b>	The monthly percentage change is the change in the CPI of the relevant month compared to the CPI of the previous month expressed as a percentage.
<b>Weights</b>	The weights are the relevant importance of the indicator product. The weight of a product is calculated by dividing the total expenditure by households on that product by the total expenditure on all goods and services by households.
