INFLATION RATE INCREASES FOR THE FOURTH CONSECUTIVE MONTH

The official inflation rate, i.e. the annual rate of change in the Consumer Price Index, is 7,5% at August 1996. This is 0,4 of a percentage point higher than the corresponding annual rate of 7,1% at July 1996.

The Consumer Price Index, as well as the seasonally adjusted index, increased by 0,5% from July 1996 to August 1996.

An alternative expression of the change in the CPI is to annualise the change between the average index of the three months up to August 1996 and the average index of the previous three months. This approach should use seasonally adjusted data, yielding a 9,3% increase and 9,5% unadjusted.

MONTHLY INCREASE OF 0,5%

The contributors to the monthly increase of 0,5% are the increases in the price indices for food (+0,4 of a percentage point), housing (+0,1 of a percentage point) and all other items (+0,1 of a percentage point). These increases were slightly counteracted by a decrease in the price index for transport (contributing -0,1 of a percentage point, mainly due to a decrease of 6c per litre in petrol prices).

FOOD PRICES

The price index for food shows an annual rate of increase of 7,9% at August 1996. This rate is 3,1 percentage points higher than the corresponding annual rate of 4,8% at July 1996.

From July 1996 to August 1996 food prices increased by 1,7%. This increase was caused by increases in the prices of grain products (+1,1%), meat (+1,5%), milk, cheese and eggs (+1,7%), fats and oils (+0,1%), fruit and nuts (+1,4%), vegetables (+6,4%), sugar (+0,3%), coffee, tea and cocoa (+0,3%) and "other" food items (+0,9%). These increases were slightly counteracted by a decrease in the prices for fish and other seafood (-0,6%).

THE MONTHLY INCREASE IN THE PRICE INDEX FOR ALL ITEMS EXCLUDING FOOD IS 0,2%

The monthly increase of 0,2% in the index for all items excluding food is the result of monthly increases in the price indices for non-alcoholic beverages (+0,5%), alcoholic beverages (+0,2%), cigarettes, cigars and tobacco (+2,2%), clothing and footwear (+0,2%), housing (+0,3%), fuel and power (+0,9%), furniture and equipment (+0,1%), household operation (+0,8%), recreation and entertainment (+0,3%) and "other" items (+0,9%), counteracted by a decrease in the price index for transport (-0,5%).

INCOME GROUP INDICES

An inflation rate of 7,5% was recorded for the lower income group, 7,9% for the middle income group and 7,3% for the higher income group.

URBAN AREAS INDICES

The highest inflation rate of 8,1% was recorded for Durban/Pinetown, while the lowest inflation rate of 6,6% was recorded for Kimberley.

Regarding food, the highest annual rate of increase of 9,8% was recorded for East Londen, while the lowest rate of 5,2% was recorded for Kimberley.

INFLATION RATE FOR PENSIONERS

The inflation rate for pensioners is 7,7% at August 1996. The highest rate of increase of 8,3% was recorded for the Cape Peninsula and for the Nelspruit/Witbank-area, while the lowest rate of increase of 6,5% was recorded for Pietersburg.

FOOD INFLATION AS MEASURED AT CHAIN-STORES AND OTHER RETAILERS

Food prices at chain-stores show an annual rate of increase of 8,0%, while food prices at other retailers show an annual rate of increase of 7,7%. From July 1996 to August 1996, food prices at chain-stores increased by 1,7%, while food prices at other retailers increased by 2,1%.

CPI FOR SEPTEMBER 1996

In addition to the normal price surveys for September 1996, it has come to the attention of the CSS that changed prices apply with effect from September 1996 with regard to certain urban areas' water tariffs, electricity, assessment rates, refuse removal and sanitary services.

EXPLANATORY NOTES

1. All price information refers to the first seven days of the relevant month.
2. The Consumer Price Indices relating to different urban areas as shown in Table 4 do not permit inter-urban comparison of price levels or living costs. The indices do not indicate whether it is more expensive to live in one city than in another. The indices indicate for each urban area, independently of any of the other urban areas, the price changes which have taken place from time to time.
3. Consumer Price Indices have been compiled for the areas Pietersburg and Nelspruit/Witbank as from July 1994. Although prices are collected in each of the respective areas, the indices for June 1994 and the weighting structure of Pretoria were used as basis for the CPI for Pietersburg and those of the Vaal Triangle as basis for Nelspruit/Witbank. The weighting structure of the said areas will be used until the results of the Survey of the Expenditure of Households, which took place in 1995 are available, and the weighting structure for each of the new areas will then be determined accordingly. Furthermore, it should be noted that the indices for the weighted average have been calculated excluding the new areas. The new areas will be taken into account in the calculation of the weighted average as soon as a weighting structure for each has been brought into effect.

4. The indices for all items excluding food, Table 4.4, have been calculated for each area separately as from July 1994. These indices are calculated by means of the index for all items and the index for food of each area.

5. Value Added Tax (VAT) is included in general in the prices of all items on which VAT is applicable.

6. A more comprehensive description of the weighting system, seasonal adjustment, price collection methodology, etc., appears in the brochure "Inflation" as well as in the notes to Chapter 3 of the Bulletin of Statistics.
