INFLATION RATE FOR OCTOBER 1996 THE HIGHEST SINCE JUNE 1995

The official inflation rate, i.e. the annual rate of change in the Consumer Price Index, is 9,1% for October 1996. This rate is 0,7 of a percentage point higher than the corresponding annual rate of 8,4% for September 1996.

The monthly increase (i.e. from September 1996 to October 1996) in the Consumer Price Index is 1,0%, while the seasonally adjusted index shows an increase of 1,1% for the same period.

An alternative expression of the change in the CPI is to annualise the change between the average index of the three months up to October 1996 and the average index of the previous three months. This approach when using seasonally adjusted data show an increase of 9,2%, while unadjusted data show a 9,9% increase.

CONTRIBUTIONS TO THE MONTHLY INCREASE OF 1,0%

The monthly increase of 1,0% can be attributed to increases in the price indices for food (contributing +0,5 of a percentage point), transport (+0,1 of a percentage point), "other" (+0,1 of a percentage point) and all other items (+0,3 of a percentage point).

FOOD PRICES

The price index for food shows an annual rate of increase of 12,4% for October 1996. This rate is 2,0 percentage points higher than the corresponding annual rate of 10,4% for September 1996.

The monthly rate of increase of 2,1% was caused by increases in the price indices for vegetables (+11,0%), grain products (+1,9%), meat (+1,4%), fats and oils (+0,8%), coffee, tea and cocoa (+0,5%), fish and other seafood (+0,4%), milk, cheese and eggs (+0,3%), sugar (+0,2%), and "other" items (+1,3%). These increases were partially counteracted by a decrease in the price index for fruit and nuts (-1,7%).

THE MONTHLY INCREASE IN THE PRICE INDEX FOR ALL ITEMS EXCLUDING FOOD IS 0,6%

The monthly rate of increase of 0,6% in the index for all items excluding food was caused by increases in the price indices for cigarettes, cigars and tobacco (+1,2%), household operation (+1,2%), reading matter (+0,9%), personal care (+0,7%), transport (+0,5%), non-alcoholic beverages (+0,5%), recreation and entertainment (+0,4%), alcoholic beverages (+0,2%), clothing and footwear (+0,2%), housing (+0,2%), fuel and power (+0,2%), furniture and equipment (+0,1%) and "other" items (+1,5%).

INCOME GROUP INDICES

An inflation rate of 9,4% was recorded for the lower income group, 9,6% for the middle income group and 8,8% for the higher income group.

URBAN AREA INDICES

The highest inflation rate of 10,3% was recorded for the Cape Peninsula, while the lowest rate of 7,6% was recorded for the Free State Goldfields.

Regarding food, the highest annual rate of increase of 14,4% was recorded for Pretoria/Centurion/Akasia, while the lowest rate of 9,2% was recorded for the Free State Goldfields.

INFLATION RATE FOR PENSIONERS

The inflation rate for pensioners is 9,6% for October 1996. The highest rate of increase of 10,9% was recorded for the Cape Peninsula, while the lowest rate of increase of 7,2% was recorded for the Free State Goldfields.

FOOD INFLATION AS MEASURED AT CHAIN-STORES AND OTHER RETAILERS

Food prices at chain-stores show an annual rate of increase of 13,0% and food prices at other retailers show an annual rate of increase of 11,2%. From September 1996 to October 1996, food prices at chain-stores increased by 2,6% and those at other retailers increased by 1,1%.

CPI FOR NOVEMBER 1996

In addition to the normal price surveys for November 1996, it has come to the attention of the CSS that changed prices apply with effect from November 1996 with regard to assessment rates in certain urban areas.

EXPLANATORY NOTES

1. All price information refers to the first seven days of the reference month.
2. The Consumer Price Indices relating to various urban areas as shown in Table 4 do not permit inter-urban comparison of price levels or living costs. The indices do not indicate whether it is more expensive to live in one city than in another. The indices indicate for each urban area, independently of any of the other urban areas, the price changes which have taken place from time to time.
3. Consumer Price Indices have been compiled for the urban areas Pietersburg and Nelspruit/Witbank as from July 1994. Although prices are collected in each of the respective areas, the indices for June 1994 and the weighting structure of Pretoria were used as basis for the CPI for Pietersburg and those of the Vaal Triangle as basis for Nelspruit/Witbank. The weighting structure of the said areas will be used until the results of the Survey of the Expenditure of Households, which took place in October 1995 are available, and the weighting structure for each of the new areas will then be determined accordingly. Furthermore, it should be noted that the indices for the weighted average have been calculated excluding these new areas. The new areas will be taken into account in the calculation of the weighted average as soon as a weighting structure for each has been brought into effect.
4. The indices for all items excluding food, Table 4.4, have been calculated for each area separately as from July 1994. These indices are calculated by means of the index for all items and the index for food of each area.
5. Value Added Tax (VAT) is included in general in the prices of all items on which VAT is applicable.
6. A more comprehensive description of the weighting system, seasonal adjustment, price collection methods, etc., appears in the brochure "Inflation" as well as in the notes to Chapter 3 of the Bulletin of Statistics.
7. The three income group categories were defined according to average direct annual income per household as in October 1990 as:

Lower income group - up to R15 999
Middle income group - R16 000 up to R39 999
Higher income group - R40 000 and more

When these average annual incomes are inflated the income group categories will be defined according to 1995 values as:

Lower income group - up to R27 295
Middle income group - R27 296 up to R68 239
Higher income group - R68 240 and more
