1. AVERAGE ANNUAL RATE OF INCREASE IN PPI FOR 1996 AT 6,9%

The production price index (PPI) for all commodities for South African consumption showed an annual rate of increase of 8,8% at December 1996, i.e. for the period December 1995 to December 1996, which brings the average annual rate of increase for 1996 to 6,9%. It is only the second time in 23 years that the average annual rate of increase in this index is below 7,0%. The rate of 6,9% for 1996 is 2,7 percentage points lower than the corresponding rate of 9,6% for 1995 and 1,3 percentage points lower than the corresponding rate of 8,2% for 1994.

The average annual rate of increase in the PPI for locally produced commodities is 7,5% for 1996. This is 2,4 percentage points lower than the corresponding rate of 9,9% for 1995, and 1,4 percentage points lower than the corresponding rate of 8,9% for 1994.

The average annual rate of increase in the PPI for imported commodities is 5,3% for 1996, compared with 7,6% for 1995 and 5,5% for 1994.

2. ANNUAL RATE OF INCREASE IN THE PPI AT DECEMBER 1996 THE HIGHEST SINCE JULY 1995

The production price index (PPI) for all commodities for South African consumption shows an annual rate of increase of 8,8% at December 1996, the highest annual rate since July 1995 when it was 9,0%. The rate of 8,8% is 0,3 of a percentage point higher than the annual rate of increase of 8,5% at November 1996.

The monthly increase in this index as well as in the seasonally adjusted index during the period November 1996 to December 1996, is 1,0%.

LOWER ANNUAL PERCENTAGE INCREASE IN THE PPI FOR LOCALLY PRODUCED COMMODITIES

The annual rate of increase in the PPI for locally produced commodities is 8,5% at December 1996. This rate is 0,3 of a percentage point lower than the corresponding annual rate of 8,8% at November 1996. The monthly increase in this index is 0,7%, while the seasonally adjusted index increased by 1,0%.

ANNUAL RATE OF INCREASE IN THE PPI FOR IMPORTED COMMODITIES AT 9,3%

The annual rate of increase of 9,3% at December 1996 in the PPI for imported commodities, is 1,5 percentage points higher than the annual rate of 7,8% at November 1996, and is substantially higher than the average annual rate of increase of 5,3% for 1996. From November 1996 to December 1996 this index as well as the seasonally adjusted index increased by 1,8%.

MONTHLY CHANGES IN THE PPI FOR ALL COMMODITIES FOR SOUTH AFRICAN CONSUMPTION

Relatively large monthly increases occurred in the price indices for other agricultural products (+1,3%), fishing products (+1,1%), mining and quarrying products (+5,2%), wearing apparel (+2,3%), leather and leather products (+1,2%), products of petroleum and coal (+4,0%), medical, precision and optical instruments (+1,1%, due to an increase of 6,0% in the prices of other precision and optical instruments, including watches and clocks) and transport equipment (+1,8%).

MONTHLY CHANGES IN THE PPI FOR IMPORTED COMMODITIES

Monthly increases occurred in the prices of agricultural products (+2,4%), mining and quarrying products (+8,2%, due to an increase of 9,5% in the prices of crude petroleum), food at manufacturing (+1,1%), tobacco products (+0,9%), leather and leather products (+2,9%), paper, paper products and printing (+1,3%), chemicals and chemical products (+0,1%), metal products (+0,5%), non-electrical machinery and equipment (+1,5%), medical, precision and optical instruments (+1,4%) and transport equipment (+5,3%), while the prices of textiles and made-up goods (+0,0%) and wood and wood products (+0,0%) remained virtually unchanged.


The zero's (0,0) reported for specific categories in the special table on imported commodities (see page 4), imply that there were either no price changes in comparable items, or that no items (of the same type and quality) comparable to the preceding month were imported by the various respondents in the survey. In the latter case, no valid price movement could therefore be reported on by the CSS.

The distribution of item-prices which are collected for imported commodities is being reviewed, to ensure that the number of data points gathered is in better proportion to the weights of the relative categories. Provided that importers are helpful with the requisite information, there should therefore be an improvement in future in the availability of price data of comparable items with which price changes can be monitored.

PERCENTAGE







It should be noted that, in calculating the percentage change in a group of commodities, the CSS does not weigh the percentage changes, but rather weigh the underlying indices for the respective months and then calculates the percentage change in the weighted indices.

2. PRICING BASIS

All indices are based on producer prices at the point of production in the case of commodities produced in South Africa, and wholesale prices "ex-warehouse", in the case of imported commodities. Prices "delivered" or "free on rail" are accepted if this is the normal basis of quotation. Price information refers to the first seven days of the relevant month. General sales tax is excluded but can be accounted for by multiplying a particular index by 1,04 prior to March 1982; 1,05 from March 1982; 1,06 from September 1982; 1,07 from February 1984; 1,10 from July 1984; 1,12 from April 1985; and 1,13 from April 1989. Value added tax can be added by multiplying the relevant index by 1,10 from October 1991; and by 1,14 from April 1993.
