PRODUCER INFLATION LOWER AT 7,5%

The Production Price Index (PPI) for all commodities for South African consumption shows an annual rate of increase of 7,5% at June 1997, i.e. for the period June 1996 to June 1997. This rate is 0,9 of a percentage point lower than the annual rate of increase at May 1997, which was 8,4%. From May 1997 to June 1997 this index decreased by 0,2%, compared with an increase of 0,9% for May 1997.

SLIGHTLY LOWER ANNUAL PERCENTAGE INCREASE IN THE PPI FOR LOCALLY PRODUCED COMMODITIES

The annual rate of increase in the PPI for locally produced commodities is 8,5% at June 1997. This rate is 0,4 of a percentage point lower than the corresponding annual rate of 8,9% at May 1997. The monthly increase in this index is 0,2%, while the seasonally adjusted index increased by 0,4%.

ANNUAL RATE OF INCREASE IN THE PPI FOR IMPORTED COMMODITIES LOWEST IN MORE THAN A YEAR

The PPI for imported commodities reflects an annual increase of 4,1% at June 1997. This rate is 2,3 percentage points lower than the corresponding annual rate of 6,4% at May 1997, and is the lowest rate since April 1996, when it was 3,2%. The monthly decrease of 3,2% for April 1997 was followed by an increase of 2,7% for May 1997 and a decrease of 1,4% for June 1997. The decrease of 1,4% for June 1997 is mainly due to a 9,5% drop in the average price of imported crude petroleum.

The actual information received from Customs and Excise for June 1997, reflects a decrease of 18,9%. However Customs and Excise also reported that a number of crude petroleum consignments worth approximately R1bn still have to be cleared at the Cape Town harbour. Due to this lack of information for June 1997, the CSS used the average prices of May 1997 and June 1997 to calculate an average price for June 1997, which then reflects a decrease of 9,5%.

MONTHLY CHANGES IN THE PPI FOR ALL COMMODITIES FOR SOUTH AFRICAN CONSUMPTION

Relatively large monthly increases occurred in the price indices for agricultural products (+1,0%), food at manufacturing (+0,5%), textiles and made-up goods (+0,4%), wearing apparel (+1,0%) and rubber and plastic products (+0,3%). In contrast, there were relatively large monthly decreases in the price indices for fishing (-2,5%), mining and quarrying products (-1,5%, mainly due to the large decrease in the average price of imported crude petroleum), products of petroleum and coal (-0,4%) and electricity (-2,1%).

MONTHLY CHANGES IN THE PPI FOR IMPORTED COMMODITIES

Monthly increases occurred in the prices of agricultural non-food products (+0,9%) and rubber and plastic products (+1,5%), while the prices of textiles and made-up goods and transport equipment remained virtually unchanged. In contrast, monthly decreases were reported in the prices of agricultural food products (-4,9%), mining and quarrying products (-8,2%, mainly due to the large decrease in the average price of imported crude petroleum), food at manufacturing (-0,9%), beverages (-0,1%), chemicals and chemical products (-0,1%) and "other" manufactures (-0,7%).

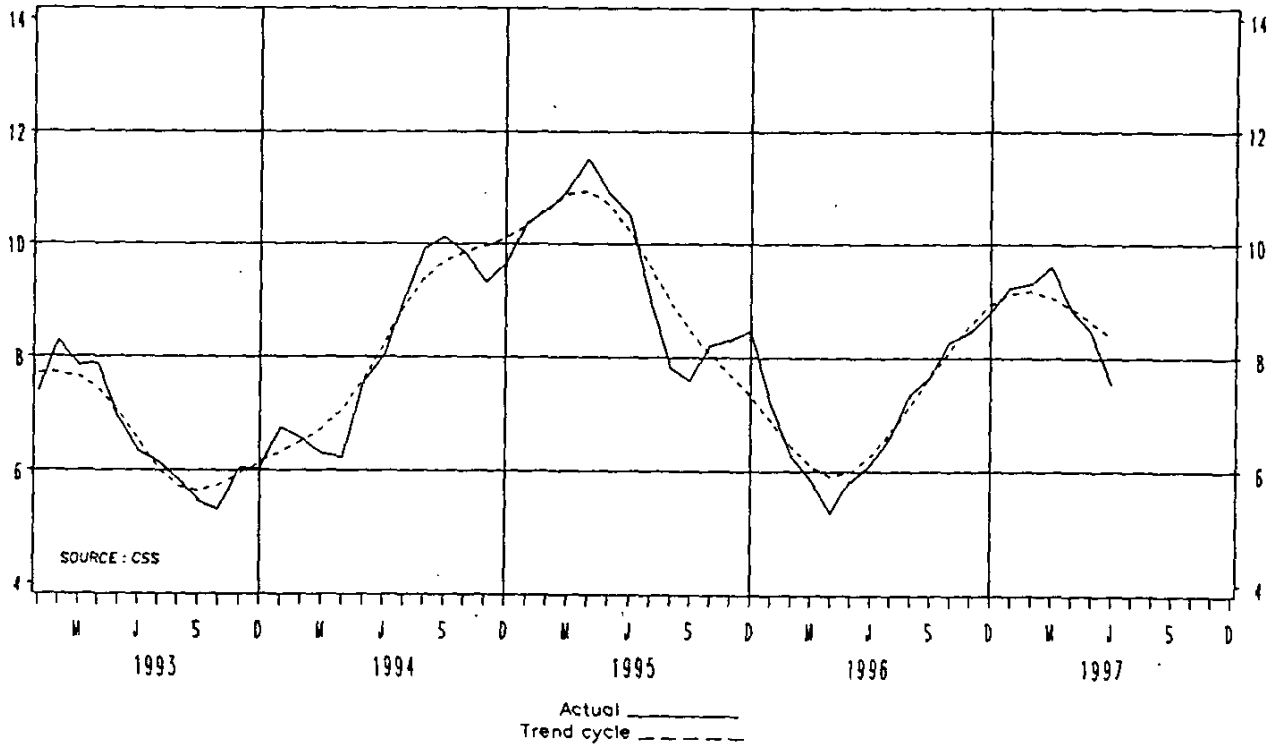

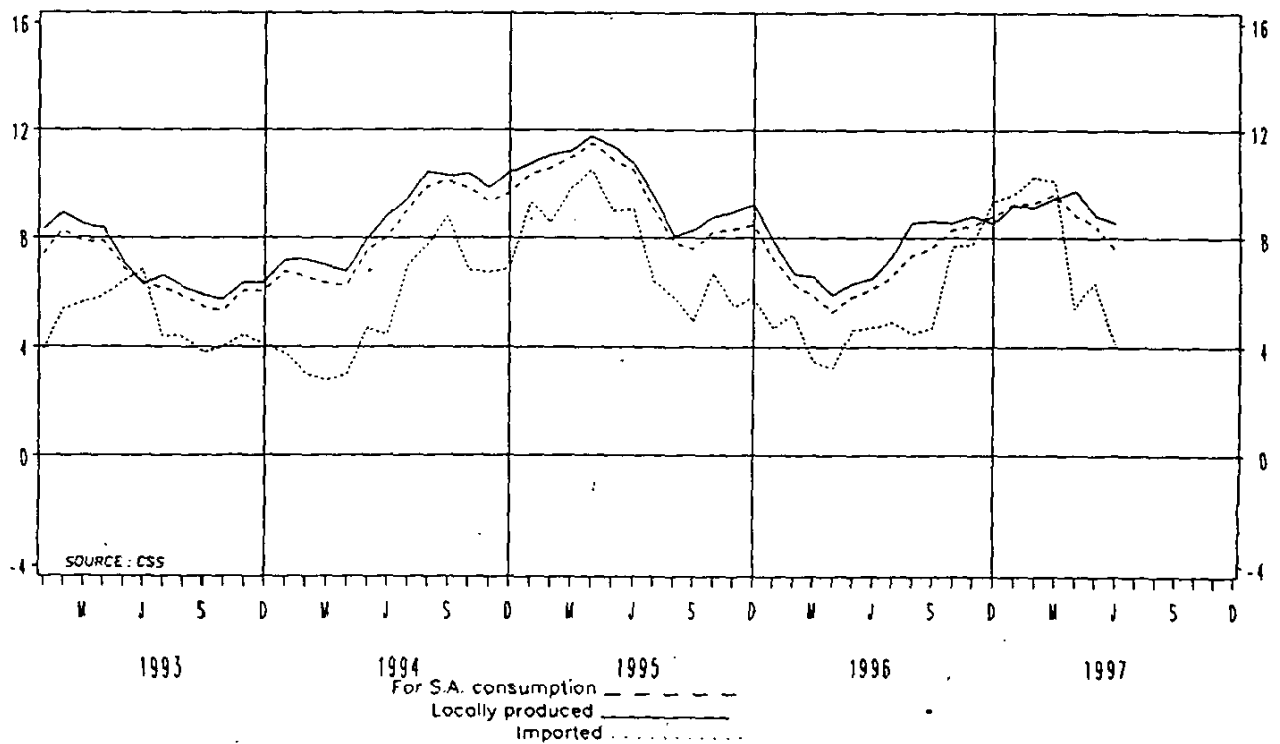

2. PRICING BASIS

All indices are based on producer prices at the point of production in the case of commodities produced in South Africa, and wholesale prices "ex-warehouse", in the case of imported commodities. Prices "delivered" or "free on rail" are accepted if this is the normal basis of quotation. Price information refers to the first seven days of the relevant month, except in the case of mining and most of the agriculture products, where it refers to the average price for the month. General sales tax is excluded but can be accounted for by multiplying a particular index by 1,04 prior to March 1982; 1,05 from March 1982; 1,06 from September 1982; 1,07 from February 1984; 1,10 from July 1984; 1,12 from April 1985; and 1,13 from April 1989. Value added tax can be added by multiplying the relevant index by 1,10 from October 1991; and by 1,14 from April 1993.

Average price of imported crude petroleum

The average price of imported crude petroleum, used in the compilation of the import component of the PPI, is calculated as the value (in rands) divided by the quantity of imported crude for the relevant month.
