KEY FINDINGS AS AT MARCH 2023**Exports**

The UVI for exported commodities shows an annual rate of change of 3,4% in March 2023. From February 2023 to March 2023 the UVI for exported commodities decreased by 0,1%.

The main contributors to the annual rate of 3,4% were metal products, machinery and equipment (1,5 percentage points), other transportable goods (1,4 percentage points) and beverages (0,6 of a percentage point) (see Figure 4.1).

The main negative contributors to the monthly decrease of 0,1% were agriculture (-0,2 of a percentage point) and ores and minerals (-0,2 of a percentage point) (see Figure 4.2).

Imports

The UVI for imported commodities shows an annual rate of change of 11,2% in March 2023. From February 2023 to March 2023 the UVI for imported commodities increased by 1,3%.

The main contributors to the annual rate of 11,2% were metal products, machinery and equipment (5,8 percentage points) and other transportable goods (4,7 percentage points) (see Figure 5.1).

The main contributors to the monthly increase of 1,3% were metal products, machinery and equipment (0,6 of a percentage point), food products (0,3 of a percentage point) and other transportable goods (0,2 of a percentage point) (see Figure 5.2).

Figure 1 - Export and import unit value indices

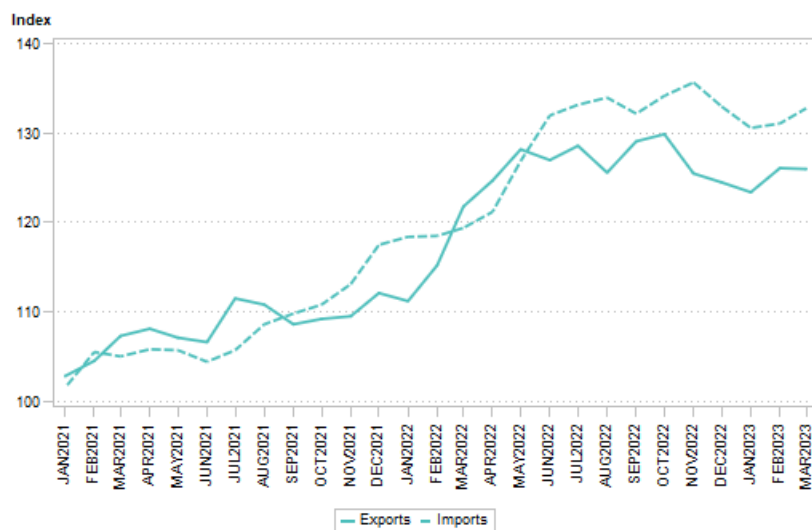


Figure 2 - Export UVI rates of change (%)

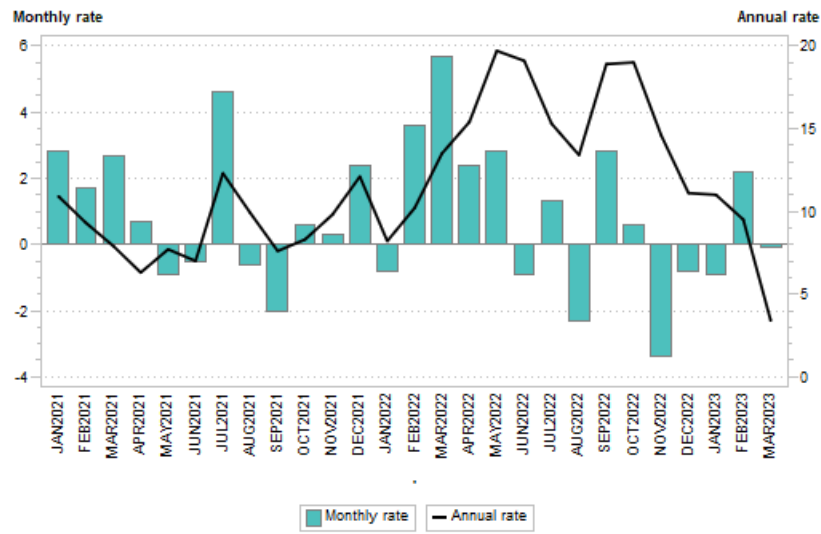
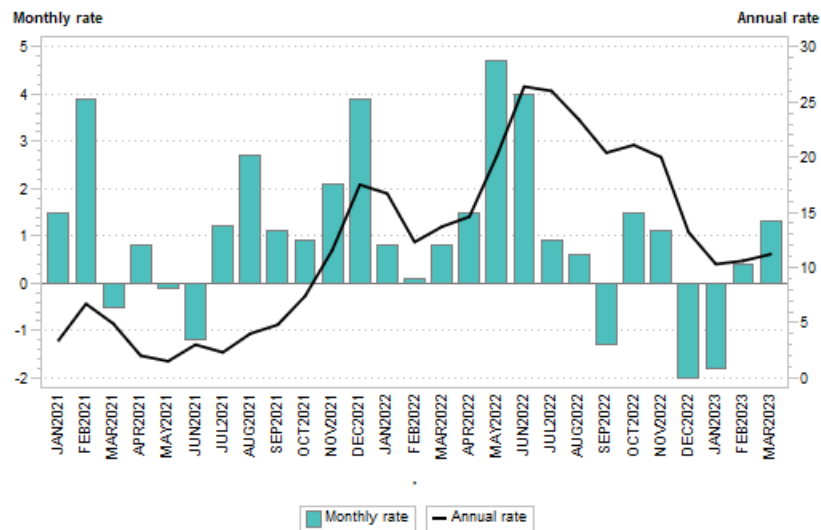


Figure 3 - Import UVI rates of change (%)

Figure 4.1 - Contributions to the annual percentage change in exports

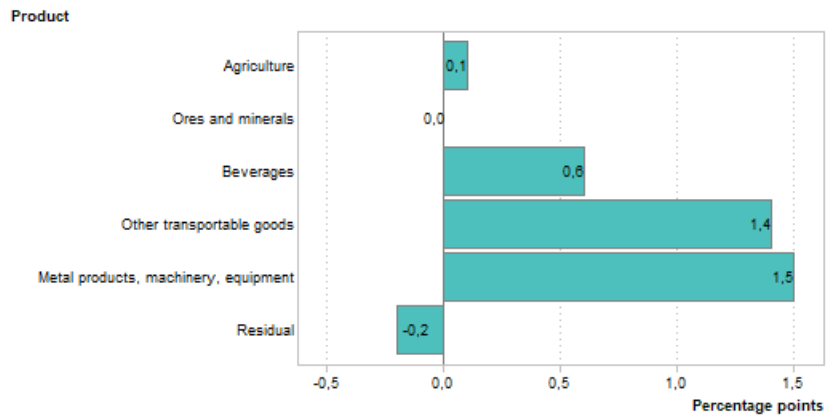


Figure 4.2 - Contributions to the monthly percentage change in exports

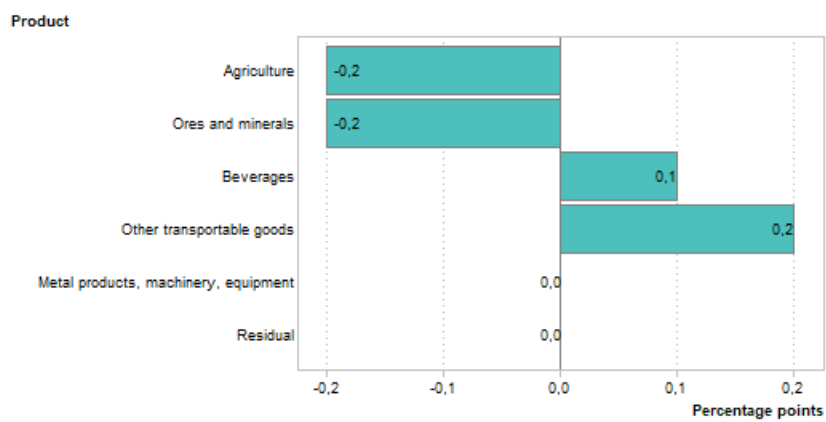

Figure 5.1 - Contributions to the annual percentage change in imports

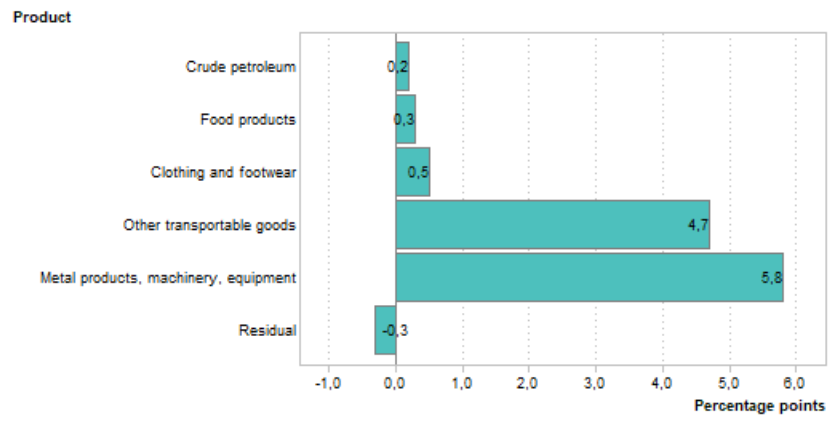
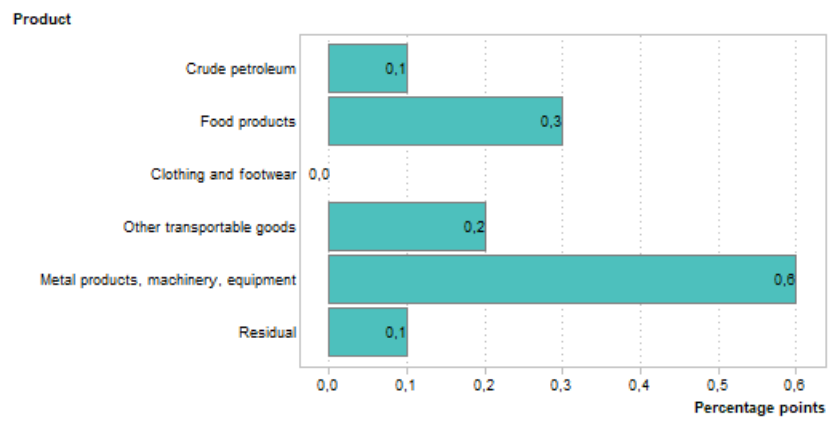


Figure 5.2 - Contributions to the monthly percentage change in imports



EXPLANATORY NOTES

Purpose and results	The unit value index provides information on the trends in import and export unit values that are weighted with quantities of the current reference period. The calculation of unit value indices of commodities in exports and imports covers transactions reported by the South African Revenue Service. The results are used to compile export and import unit value indices, which are a measure of changes in export prices of locally produced commodities and changes in prices of imported commodities. Source	South African Revenue Service (SARS).
Gold	The export unit value index for gold is calculated from net gold values and quantities obtained from the South African Reserve Bank (SARB) quarterly. The index changes quarterly and is published in this publication with a one quarter lag (e.g. the November 2013 gold value and quantity will only be included in the December 2013 publication).

GLOSSARY

Chain linking	The construction of a continuous price series by multiplying together price indices that have been using different weights for different periods. The resulting index is referred to as a chained index (<i>Practical Guide to Producing Consumer Price Indices, 2009</i>). Linking is intended to ensure that the individual indices on all levels show the correct development through time, but leads to non-additivity (IMF, 2005).
Contributions	The contribution (percentage points) of a sub-index to the percentage change in the total index for a given period is calculated by multiplying the difference (i.e. change) in the sub index by its weight and then dividing by the previous period's total index. In the case of annual percentage changes, the contributions are approximations owing to annual changes in weights.
Percentage change	The percentage change in an index for any given period is the change between that period's index value and the previous period's index value expressed as a percentage of the latter.

GENERAL INFORMATION
