CALCULATION OF THE WEIGHTS

Industry weights

The industry weights are derived from the estimates of value added from the national accounts and are updated on an annual basis.

Product weights

The primary sources of weighting information for the PPI are large sample surveys of businesses, national accounts, and information from relevant government departments. The criterion for use is the level of detail available. In some instances supplementary data is required to select indicator products. These include administrative sources, association surveys, and customs data. The PPI manufacturing product weights and basket were updated using the 2017 manufacturing large sample survey, published in 2019. These changes were implemented with effect from the January 2021 PPI release.
