Key findings

Table 1: Contract price adjustment provisions (CPAP) work group indices

Noteworthy month-on-month changes in November 2024 were as follows:

Work group 125 – metal roofing (aluminium): the index increased by 7,3%. There was a change of 8,2% in the SEIFSA index for aluminium products 99.7 EC grade rod (accounting for 90,0% of this group).

Work group 162 – electrical reticulation: the index increased by 3,2%. There were changes of 2,6% in the SEIFSA index for copper 7.9 mm rod (Table N) (accounting for 45,0% of this group) and 8,2% in the SEIFSA index for aluminium products 99.7 EC grade rod (accounting for 25,0% of this group).

Work group 104 – earthworks: the index decreased by 0,2%. There was a change of -0,4% in the index for plant and equipment (accounting for 50,0% of this group).

Work group 114 – reinforcement: the index decreased by 1,0%. There was a change of -1,3% in the PPI index for reinforcing metal work (accounting for 75,0% of this group).

Tables 2 and 3: Construction input price index (CIPI)

The annual change in the total construction index was 3,9% in November 2024. The index increased by 0,5% month-on-month.

The following indices recorded noteworthy month-on-month changes:

- cement (6,3%);
- ceiling boards (2,2%);
- ready-mix concrete (1,8%);
- prefabricated concrete and cement (1,6%);
- bituminous mixtures (0,5%);
- construction electric motors, generators or transformers (0,5%);
- electrical cable (-0,6%); and
- construction structural and reinforcing steel (-0,7%).

Table 4: Mining and construction plant and equipment price indices

The annual change in the plant and equipment index was 7,3% in November 2024. The index decreased by 0,4% month-on-month.

Table 5: Mechanical and electrical engineering input price indices

The annual change in the mechanical engineering index was 0,8% in November 2024. The index decreased by 0,3% month-on-month.

The annual change in the electrical engineering index was 7,5% in November 2024. The index increased by 0,5% month-on-month.

Table 6: Civil engineering material price indices

The annual change in the total index (civil engineering material) was 1,8% in November 2024. The index increased by 1,6% month-on-month.

Glossary

Construction Input Price Indices (CIPI)	The index reflects material purchases in the construction industry.
Contract Price Adjustment Provisions (CPAP)	The CPAP work group indices are used for making adjustments based on cost fluctuations in labour, plant and materials.
Contract Price Adjustment Provisions Steering Committee	The committee is the oversight structure for the Construction Price Adjustment Provisions published by Statistics South Africa (Stats SA) and includes representatives from the following industry associations and organisations: The Association of South African Quantity Surveyors (ASAQS), Electrical Contractors' Association (SA), Master Builders South Africa, South African Institute of Architects, Department of Public Works and Stats SA.
CPAP manuals	The updated CPAP manuals "CPAP Application Manual" and "CPAP Work Groups Composition and Weighting of Sub-Indices" are obtainable from ASAQS' website: www.asaqs.co.za – search for CPAP, or by phoning (012) 406 3304.
Respondent response rate	The respondent response rate for November 2024 was 98,7%. The rate was calculated using the total number of companies where prices were collected as a percentage of the total sample.
Sources for CPAP	The CPAP work group indices are derived from changes in the cost structures prevailing in 38 different work activities of the building industry and are published by Stats SA on a monthly basis. The indices reported on in this publication are mainly based on a combination of PPI, SEIFSA and CPI indices for the particular month.
Tax	Value-added tax (VAT) is not included in these indices.
Weights	Weights are updated according to the availability of new information, as follows: <ul style="list-style-type: none"> • Tables 1 and 6 are updated periodically in consultation with industry expert committees. • Tables 2, 3 and 5 are partially updated annually using Stats SA's supply and use tables, with effect from the January statistical release each year. • Table 4 is updated periodically using Stats SA's large sample survey for the manufacturing industry and SARS trade data. • Tables 2, 3, 4 and 5 are updated on a detailed level, using Stats SA's large sample surveys for the construction and manufacturing industries, approximately every three to four years.
Revised figures	The SEIFSA data is continuously updated and therefore Stats SA allows for revisions of the CPAP work group indices. Revisions will be promptly indicated in relevant tables to maintain transparency and accuracy.
