Preface

This monthly statistical release provides information on South African residents and foreign travellers who entered or left South Africa in September 2024. Specific focus is on foreign tourists who entered the country in September 2024. Tourists are classified by region and country of residence. Details of their mode of travel; purpose of visit; age and sex distribution are also provided.

The March, June, September and December releases include summaries of the number of tourists for the current quarter and comparisons with previous periods.

NB: Users are advised that some of the ports of entry/exit are missing data (such as Maseru Bridge) this could be due to data capturing system changes being introduced by the Departments of Home Affairs. Stats SA is currently in constant communication with the department and it may be necessary to revise the data once the matter is concluded in the future.

1. Highlights of the results

In September 2024, 2 331 485 travellers (arrivals, departures and transits) entered and exited South Africa. They were made up of 699 100 (30,0%) South African residents and 1 632 385 (70,0%) foreign travellers. Foreign arrivals were made up of 20 934 (2,4%) non-visitors and 838 427 (97,6%) visitors. Visitors consisted of 171 709 (20,5%) same-day visitors and 666 718 (79,5%) overnight visitors (tourists).

Tourists

Overseas tourists constituted 21,4% (142 510) of all tourists. United States of America (USA) (28 717), United Kingdom (UK) (18 868) and Germany (13 964) contributed 43,2% to overseas tourists. Tourists from Southern African Development Community (SADC) countries constituted 76,3% (509 017) of all tourists. Zimbabwe (155 461), Mozambique (131 756) and Eswatini (75 373) contributed 71,2% to SADC tourists. 'Other' African countries (non-SADC) tourists were 2,1% (14 227) of all tourists. Kenya (3 979), Ghana (3 323) and Nigeria (1 919) contributed 64,8% to 'other' African tourists. The country of residence of 964 (0,1%) tourists was classified as unspecified.

Purpose of visit

'Holiday'¹ continues to be the main purpose of visit. About 96,9% of all the tourists were in South Africa for holiday purposes.

2. Key findings

2.1 Travellers

2.1.1 Number of travellers

The routine data collected by the Department of Home Affairs' (DHA) immigration officers at the ports of entry into and out of South Africa shows that a total of 2 331 485 travellers (arrivals, departures and transits) passed through South African ports in September 2024. As presented in Table 1 below, these travellers were made up of 699 100 South African residents and 1 632 385 foreign travellers. A further breakdown of the figures for South African residents indicates that there were 341 582 arrivals, 356 924 departures and 594 travellers in transit. The corresponding volume for foreign arrivals, departures and travellers in transit was 859 361, 729 710 and 43 314 respectively.

A comparison between the movements in August 2024 and September 2024 indicates that the volume of arrivals, departures and transits increased for South African residents but decreased for foreign travellers. For South African residents, the volume of arrivals increased by 11,5% (from 306 442 in August 2024 to 341 582 in September 2024). Departures increased by 6,4% (from 335 433 in August 2024 to 356 924 in September 2024) and transits increased by 3,7% (from 573 in August 2024 to 594 in September 2024). For foreign travellers, arrivals decreased by 7,0% (from 924 111 in August 2024 to 859 361 in September 2024), departures decreased by 3,6% (from 757 052 in August 2024 to 729 710 in September 2024), and transits decreased by 18,4% (from 53 100 in August 2024 to 43 314 in September 2024).

A comparison between the movements in September 2023 and September 2024 indicates that the volume of arrivals and departures decreased for South African residents and foreign travellers but the volume of transits increased for both groups of travellers. For South African residents, the volume of arrivals decreased by 6,1% (from 363 659 in September 2023 to 341 582 in September 2024), departures decreased by 11,4% (from 402 641 in September 2023 to 356 924 in September 2024) and transits increased by 26,7% (from 469 in September 2023 to 594 in September 2024). For foreign travellers, arrivals decreased by 8,9% (from 943 387 in September 2023 to 859 361 in September 2024), departures decreased by 10,3% (from 813 196 in September 2023 to 729 710 in September 2024) and transits increased by 8,1% (from 40 058 in September 2023 to 43 314 in September 2024).

2.1.2 Mode of travel of travellers

Information presented in Table 2 below shows the number of South African residents and foreign travellers by travel direction and mode of travel. In September 2024, road was the most common mode of travel used by 1 508 888 (64,7%) of the 2 331 485 travellers. The total number of air travellers was 817 417 (35,1%). Compared to air and road, a smaller number of travellers, 5 180 (0,2%) used sea into and out of South Africa. Information on arrivals of South African residents shows that 152 867 (44,8%) came by air, 188 666 (55,2%) came by road and 49 (less than 0,1%) arrived by sea. For departures, 173 028 (48,5%) used air, 183 764 (51,5%) used road and 132 (less than 0,1%) left by sea. All travellers in transit, 594 (100,0%) used air.

In the case of foreign travellers, 209 993 (24,4%) arrived by air, 647 817 (75,4%) came by road and 1 551 (0,2%) arrived by sea. When departing South Africa, 237 621 (32,6%) foreign travellers left by air, 488 641 (67,0%) left by road and 3 448 (0,5%) left by sea. Of all travellers in transit, 43 314 (100,0%) used air.

2.2 Visitors

Detailed information on the departure of travellers is not available in the movement control system. Data on the purpose of travel and the number of days South African residents intend to spend or spent abroad are not collected by the DHA. It is therefore not possible to categorise South African residents as tourists or non-tourists. However, some data are available on foreign arrivals for this categorisation.

As presented in Table 3 on page 4, in September 2024, 20 934 (2,4%) of foreign arrivals were classified as non-visitors, while 838 427 (97,6%) were classified as visitors. Visitors were categorised into three groups:

- i. Arrivals only – comprising visitors who entered the country in September 2024 but did not depart in September 2024 [334 311 (39,9%)];
- ii. Single trips – visitors who came to South Africa once in September 2024 and left in September 2024 [270 258 (32,2%)]; and
- iii. Multiple trips – visitors who came to and left South Africa more than once in September 2024 [233 858 (27,9%)].

² Note that the September 2024 data for King Shaka International Airport was not received.

Visitors were further grouped as same-day visitors and overnight visitors (tourists). In September 2024, there were 171 709 (20,5%) same-day visitors and 666 718 (79,5%) tourists. Between August 2024 and September 2024, the volume of same-day visitors decreased by 6,7% (from 183 960 in August 2024 to 171 709 in September 2024) and that of tourists decreased by 7,2% (from 718 508 in August 2024 to 666 718 in September 2024). Between September 2023 and September 2024, the volume of same-day visitors decreased by 26,6% (from 233 986 in September 2023 to 171 709 in September 2024) and that of tourists decreased by 2,5% (from 684 161 in September 2023 to 666 718 in September 2024).

Table 2 on page 3 further shows that of the 171 709 same-day visitors, a majority, 152 642 (88,9%) arrived in the country by road, 19 065 (11,1%) arrived by air and two (less than 0,1%) arrived by sea. Information on tourists shows that 482 115 (72,3%) came by road, 184 601 (27,7%) used air and two (less than 0,1%) used sea.



2.3 Tourists

2.3.1 Sex and age distribution of tourists

Sex


Figure 1 on page 5 shows that there were more male [388 305 (58,2%)] than female [278 413 (41,8%)] tourists. Male tourists constituted the majority of tourists for all three regions, SADC countries [304 659 (59,9%)], overseas countries [73 953 (51,9%)] and ‘other’ African countries [9 097 (63,9%)]. Similarly, the largest portion of female tourists was from SADC countries [204 358 (40,1%)], followed by overseas countries 68 557 (48,1%) and ‘other’ African countries 5 130 (36,1%).

Age


Figure 2 – Percentage distribution of tourists by region of residence and age, September 2024

The age distribution indicates that out of all tourists, [24 510 (3,7%)] were aged younger than 15 years; [50 437 (7,6%)] were aged between 15 and 24 years; [162 754 (24,4%)] were aged between 25 and 34 years; [200 206 (30,0%)] were aged between 35 and 44 years; [121 785 (18,3%)] were aged between 45 and 54 years; [64 509 (9,7%)] were aged between 55 and 64 years; [42 517 (6,4%)] were aged 65 years and older (see Figure 2 on page 6).

Taking the region of residence into consideration, the results show that the highest proportion of tourists from SADC countries [173 038 (34,0%)] and those from 'other' African countries [4 659 (32,7%)] were aged between 35 and 44 years, whereas those from overseas countries [29 482 (20,7%)] were aged between 55 and 64 years. The second highest proportion of tourists from SADC countries [133 636 (26,3%)] and those from 'other' African countries [3 653 (25,7%)] were aged between 25 and 34 years, whereas those from overseas countries [29 243 (20,5%)] were aged 65 years and above. The proportion of tourists aged younger than 15 years was higher among tourists from SADC countries, 3,7% (18 989) compared to those from overseas countries, 3,5% (5 017) and those from 'other' African countries, 3,5% (496). The median ages of tourists from overseas, SADC and 'other' African countries were 49, 38 and 38 years, respectively.

2.3.2 Regional and national distribution of tourists

In September 2024, the distribution of overseas tourists was as follows: Europe, 73 140 (51,3%); North America, 33 007 (23,2%); Asia, 16 764 (11,8%); Australasia, 10 696 (7,5%); Central and South America, 6 208 (4,4%) and Middle East, 2 695 (1,9%) (see Table 4 on page 9).


Figure 3 on page 7 indicates that the 10 leading overseas countries in terms of the number of tourists visiting South Africa in September 2024 were: USA, 28 717 (20,2%); UK, 18 868 (13,2%); Germany, 13 964 (9,8%); The Netherlands, 9 698 (6,8%); Australia, 8 968 (6,3%); France, 7 481 (5,2%); India, 5 520 (3,9%); Canada, 4 290 (3,0%); Brazil, 4 078 (2,9%) and China, 3 991 (2,8%). Tourists from these 10 countries constituted 74,1% of all tourists from overseas countries. A comparison of movements in the 10 leading countries between September 2023 and September 2024 shows that the number of tourists increased for 2 of 10 leading countries. Brazil had the highest increase of 44,2% (from 2 828 tourists in September 2023 to 4 078 tourists in September 2024).

Figure 3 – Number of tourists from the 10 leading overseas countries in September 2023 and September 2024




Virtually, most tourists from Africa, 509 017 (97,3%), came from SADC countries. The distribution of the remaining tourists from Africa was as follows: East and Central Africa, 6 875 (1,3%); West Africa, 6 347 (1,2%) and North Africa 1 005 (0,2%). Ten leading SADC countries in terms of the number of tourists visiting South Africa in September 2024 were: Zimbabwe, 155 461 (30,5%); Mozambique, 131 756 (25,9%); Eswatini, 75 373 (14,8%); Lesotho, 57 851 (11,4%); Botswana, 36 932 (7,3%); Malawi, 15 049 (3,0%); Namibia, 15 007 (2,9%); Zambia, 12 597 (2,5%); Angola, 2 870 (0,6%) and Tanzania, 2 851 (0,6%) (see Figure 4 below). Tourists from these 10 countries constituted 99,4% of all tourists from the SADC countries. A comparison of movements in the 10 leading countries between September 2023 and September 2024 shows that the number of tourists increased for 7 of the 10 leading countries. Mozambique showed the highest increase of 22,6% (from 107 496 tourists in September 2023 to 131 756 tourists in September 2024).

The 10 leading countries in terms of the number of tourists visiting South Africa in September 2024 from 'other' African countries, as shown in Figure 5 below, were: Kenya, 3 979 (28,0%); Ghana, 3 323 (23,4%); Nigeria, 1 919 (13,5%); Uganda, 1 126 (7,9%); Ethiopia, 561 (3,9%); Egypt, 514 (3,6%); Cameroon, 343 (2,4%); Gabon, 291 (2,0%); Côte d'Ivoire, 223 (1,6%) and Benin, 195 (1,4%). Tourists from these 10 countries constituted 87,7% of all tourists from 'other' African countries. A comparison between movements in September 2023 and September 2024 shows that the number of tourists increased for 8 of 10 leading countries. Ghana showed the highest increase of 475,9% (from 577 tourists in September 2023 to 3 323 tourists in September 2024).

2.3.3 Purpose of visit of tourists

Table 4 on page 9, shows the number of tourists by region and sub-region. Detailed data on the country of residence and purpose of visit is presented in Annexure C on pages 21 to 24. It is observed that in September 2024, the majority of tourists, 645 764 (96,9%), were in South Africa for holiday compared to 18 590 (2,8%); 2 169 (0,3%) and 195 (less than 0,1%) who were in South Africa for business, study and medical treatment respectively.

Within the overseas regions, Australasia, 99,4% (10 636) had the highest proportion of tourists who came for holiday followed by North America, 99,0% (32 677); Central and South America, 98,6% (6 121); Europe, 98,3% (71 897); Middle East, 95,7% (2 579) and Asia, 94,3% (15 812).

Asia, 4,8% (798) had the highest proportion of tourists who came to South Africa for business, followed by Middle East, 3,4% (91); Europe, 1,3% (924); Central and South America, 1,1% (71); North America, 0,9% (294) and Australasia, 0,4% (47).

Middle East, 0,9% (25) had the highest proportion of tourists who came to study, followed by Asia, 0,9% (153); Europe, 0,4% (293); Central and South America, 0,3% (16); Australasia, 0,1% (11) and North America, 0,1% (29).

Europe (26), North America (7), Australasia (2) and Asia (1) had less than 0,1% of medical treatment tourists, whereas Central and South America and Middle East had none.

Majority of African tourists, 505 183 (96,5%) came to South Africa for holiday. However, the following differences in terms of reasons for travel were observed between tourists from the SADC countries and 'other' African countries, namely:

- Holiday makers constituted 96,7% (492 014) of tourists from SADC countries compared to 92,6% (13 169) from 'other' African countries. Information on the regions of 'other' African countries shows that 93,3% (5 924) of tourists from West Africa were on holiday, followed by tourists from East and Central Africa, 92,6% (6 369) and those from North Africa, 87,2% (876).
- Business persons constituted 3,1% (15 583) of tourists from SADC countries compared to 4,8% (678) from 'other' African countries. North Africa, 8,5% (85) had the highest proportion of tourists who came to South Africa for business purposes, followed by East and Central Africa, 4,8% (327) and West Africa, 4,2% (266).
- Students constituted 0,3% (1 291) of tourists from SADC countries compared with 2,5% (351) from 'other' African countries. North Africa, 4,3% (43) had the highest proportion of tourists who came to South Africa for study purposes, followed by East and Central Africa, 2,3% (161) and West Africa, 2,3% (147).
- Tourists who came for medical treatment constituted less than 0,1% (129) of tourists from SADC countries, while those from 'other' African countries constituted 0,2% (29). East and Central Africa, 0,3% (18) had the highest proportion of tourists who came for medical treatment, followed by West Africa, 0,2% (10) and North Africa, 0,1% (1).



2.3.4 Mode of travel of tourists

Tourists are categorised by their countries of residence and regions. Information on the specific region and country of residence of tourists and the mode of travel used to enter South Africa is provided in Annexure B on pages 17 to 20, whereas the port of entry used by tourists is provided in Annexure G on page 37. As shown in Figure 6 below, 129 858 (91,1%) overseas tourists arrived in the country by air, whilst 12 650 (8,9%) came in by road and two (less than 0,1%) arrived by sea. Tourists from the SADC countries, on the other hand, came predominantly by road, 467 458 (91,8%), 41 559 (8,2%) came by air and none arrived by sea. The number of tourists who came into South Africa by air from 'other' African countries was 12 415 (87,3%); while 1 812 (12,7%) used road transport and none preferred sea. Most tourists who arrived by road came through Lebombo port (134 123) and Beit Bridge port (123 003). The majority of tourists who came by air entered through OR Tambo International Airport (141 930) and Cape Town International Airport (42 462). Tourists who arrived by sea came through Cape Town Harbour (2).

2.3.5 Quarterly and annual trends


Figure 7 – Number of tourists from overseas countries by quarter: 2016 – 2024

Figures 7, 8, and 9 on pages 11 and 12 show quarterly changes in the number of tourists from overseas, SADC and 'other' African countries, respectively. Figure 7 on page 11, shows that the number of overseas tourists who come to South Africa is generally highest in quarter one and quarter four of each year except the period between 2020 and 2022 where they are highest in quarter one for 2020 and quarter four for 2021 and 2022. Between quarter two and quarter three of 2024 (Annexure E, pages 29 to 30), the number of tourists from overseas increased by 1,3% (from 442 532 in quarter two to 448 505 in quarter three). A year-on-year comparison between 2023 and 2024 for quarter three (Annexure F, pages 33 to 34) shows that the number of overseas tourists decreased by 7,6% (from 485 488 in quarter three of 2023 to 448 505 in quarter three of 2024).



Figure 8 – Number of tourists from SADC countries by quarter: 2016 – 2024

Figure 8 below, shows that the number of SADC tourists are highest in quarter one between 2016 and 2020 except in 2017 and the period between 2021 and 2023 where they are highest in quarter four. The quarter two movement pattern is slightly different between 2021 and 2022 where quarter one is the lowest. Between quarter two and quarter three of 2024, the number of tourists increased by 5,5% (from 1 508 990 in quarter two to 1 592 322 in quarter three) (see Annexure E on pages 30 to 31). Comparisons between the third quarters of 2023 and 2024 show that the number of SADC tourists increased by 1,8% (from 1 564 315 in quarter three of 2023 to 1 592 322 in quarter three of 2024) (see Annexure F on pages 34 to 35).

Figure 9 below, shows that the number of tourists from 'other' African countries is highest in quarter four overtime except in 2016, 2017 and 2019 where they are highest in quarter three in 2016 and highest in quarter one in year 2017 and 2019. The quarter-two movement pattern is generally the lowest across all years except in 2016 and 2022. Between quarter two and quarter three of 2024 (see Annexure E on pages 31 to 32), the number of tourists from 'other' African countries increased by 8,1% (from 38 195 in quarter two to 41 303 in quarter three). West Africa increased by 17,1% (from 15 633 in quarter two to 18 307 in quarter three) followed by East and Central Africa which increased by 5,2% (from 19 134 in quarter two to 20 135 in quarter three). On the other hand, North Africa decreased by 16,5% (from 3 428 in quarter two to 2 861 in quarter three). A year-on-year comparison for quarter three (see Annexure F on pages 35 to 36) shows that the number of tourists from 'other' African countries increased by 30,5% (from 31 647 in quarter three of 2023 to 41 303 in quarter three of 2024). West Africa had the largest increase of 75,0% (from 10 460 in quarter three of 2023 to 18 307 in quarter three of 2024), followed by East and Central Africa which increased by 9,9% (from 18 327 in quarter three of 2023 to 20 135 in quarter three of 2024) and North Africa which increased by less than 0,1% (from 2 860 in quarter three of 2023 to 2 861 in quarter three of 2024).

4. Explanatory notes

4.1 Introduction

Legal movements across South African borders, as well as legal immigration into South Africa, fall under the jurisdiction of the DHA. Stats SA then processes, analyses and publishes this information.

Administrative data sources from the DHA, that is, information from all the country's ports of entry and applications for permanent residence, constitute the only comprehensive source of information on foreign arrivals and departures, documented immigrants and emigrants. The information from this source of data provides the best national coverage (in terms of both space and time) of the population movements of South African residents and foreign travellers. The data can be used for the following:

- To estimate, monitor and understand salient characteristics of foreign travellers and volumes of South African residents travelling outside South Africa.
- To provide information that can be used to (a) assess the extent of government's progress in strengthening bilateral political and economic relations by assessing the number of international tourist arrivals, and (b) benchmark surveys focusing on the demand for local tourism services by foreign travellers.

4.2 Purpose of the statistical release

This release reports on arrivals, departures and transit travellers of South African residents and foreign travellers. Detailed information on the age and sex distribution; mode of travel; national and regional distribution; and purpose of travel of overnight visitors or tourists are also provided.

4.3 Scope and coverage

The release covers data collected by DHA officials on travellers who departed from or entered the Republic of South Africa (RSA). It is crucial to note that unlike data from census or sample surveys that count individual persons, border statistics by their nature, measure events i.e. movements of persons rather than the physical persons. The reason is that the same person can cross the border several times during a specified time and his or her information is recorded every time he or she passes through the border.

4.4 Data

Information published in this release is based on data obtained from the following data sources within the DHA:

- Data routinely collected by immigration officers at all road, air and sea entry ports on all travellers (South African residents and foreign travellers) arriving into or departing from South Africa are captured into the DHA's population Movement Control System (MCS). The counts/statistics relate to the number of individual movements, rather than to the number of people. Hence, the multiple movements of individual people during the calendar month are each counted separately. Generally, the data are collected directly from travel documents either by scanning or capturing onto the ports' electronic database. No forms or cards are used (except on rare occasions when the capturing system is down) to collect information from travellers. Individual ports regularly transmit data onto the national database at the head office of the DHA.
- Stats SA receives downloaded data covering a particular calendar month from the DHA.
- As part of data interrogation, data from OR Tambo International Airport, which has the highest volume of travellers, are compared with passenger statistics from the Airports Company of South Africa (ACSA). As expected, in any specific month, an increase in the volume of passengers reported by ACSA is also reflected in an increase in the volume of travellers recorded by DHA. A similar pattern has also been observed when the volume of travellers decreased. In September 2024, the DHA data was 7,6% lower than that of ACSA.

4.5 Limitations

4.5.1 Outbound tourists

The information on the total number of arrivals and departures of South African residents is collected from the scanning of passports. However, data on the country visited are not collected from passengers; country of final destination; intended duration of stay and purpose of visit. With this limitation, it is impossible to identify the number of tourists from the data on South African residents.

4.6 Definition of terms

4.6.1 Definitions used by the United Nations Tourism (UN Tourism)

Traveller is someone who moves between different geographical locations for any purpose and any duration.

Visitor refers to any person travelling to a place other than that of his/her usual environment for less than 12 months and whose main purpose of the trip is other than the exercise of an activity remunerated from within the place visited.

Same-Day visitor is a visitor who visits a place for less than one night.

Tourist (overnight visitor) is a visitor who stays at least one night in collective or private accommodation in the place visited.

Tourism comprises the activities of persons travelling to, and staying in places outside their usual environment, for not more than one consecutive year, for leisure, business and other purposes. The usual environment of a person consists of a certain area around his/her place of residence, plus all the other places he/she frequently visits.

4.6.2 Definitions used specifically in this release

South African resident refers to either a South African citizen or a non-South African citizen with a South African permanent residence permit.

Foreign traveller refers to a traveller who is not a South African citizen or permanent resident.

Region refers to the following country classification:

- Overseas: Europe, North America, Central and South America, Australasia, the Middle East and Asia.
- Africa: SADC and 'other' Africa (East and Central Africa, West Africa and North Africa).

Country refers to individual countries within a region. The country of residence is used. The country of residence should not be confused with the country from which the visitor travelled.

Africa refers to all the countries in Africa (both mainland and island countries).

SADC refers to the fourteen countries, excluding South Africa, which belong to the Southern African Development Community.

'Other' African refers to all non-SADC African countries.

Overseas refers to all countries outside Africa.

Trip refers to the arrival and departure of a visitor in a specified month.
