BBP TOON POSITIEWE GROEI IN DIE TWEDE KWARTAAL VAN 1994

Na 'n afname van 3,5% in die eerste kwartaal (hoofsaaklik as gevolg van landbou) het die totale seisoensaangesuiwerde reële BBP teen markpryse in die tweede kwartaal van 1994 met 1,9% toegeneem vergeleke met die eerste kwartaal. Hierdie positiewe groei koerse in die tweede kwartaal kan hoofsaaklik toegeskryf word aan 'n toename in die landbouproduksie nadat dit in die eerste kwartaal, relatief skerp afgeneem het.

Wat die seisoensverloop van die nie-landbou sektor betref, is die patroon van positiewe groei koerse van die afgelope vyf kwartale voortgesit en wel met 'n groei koerse van 0,9% in die tweede kwartaal van 1994 vergeleke met die 0,3% groei in die eerste kwartaal. Al die sektore het positiewe groei koerse in die tweede kwartaal getoon met die uitsondering van mynswese en fabriekswese wat afnames in hul reële seisoensaangesuiwerde produksie getoon het. Finansiering (5,0%) en vervoer (2,9%) het die hoogste groei koerse getoon, terwyl die handelssektor 'n positiewe groei koerse van 2,0% getoon, het na 'n afname van 1,2% in die eerste kwartaal.

Daar is al heelwat gespekuleer oor 'n moontlik haalbare groei koerse van 3,0% vir 1994. Ten einde hierdie groei koerse te realiseer, beteken dit dat die totale seisoensaangesuiwerde reële BBP in elk van die laaste twee kwartale van 1994 teen 'n jaarkoerse van ten minste 8,2% sal moet toeneem. Uit die bygaande sektorale data is dit egter duidelik dat veral fabriekswese en mynswese beter groeiresultate sal moet lewer ten einde hierdie mikpunt te verwesenlik. (Die moontlike invloed van die huidige arbeidsonrus en die gepaardgaande stakings op die verwagte groei prestasie van die ekonomie, behoort dus teen hierdie agtergrond gespieël te word.)

NOTE:

All growth rates in this statistical release are quarterly percentage changes which are indicated at annual rates.

GDP SHOWS POSITIVE GROWTH IN THE SECOND QUARTER OF 1994

After a decline of 3,5% in the first quarter (mainly as a result of agriculture) the total seasonally adjusted real GDP at market prices increased by 1,9% in the second quarter of 1994 compared with the first quarter. This positive growth rate in the second quarter can mainly be ascribed to an increase in agricultural production after a relatively sharp decline in the first quarter.

Regarding the seasonal trend of the non-agricultural sector, the pattern of positive growth rates over the last five quarters continued with a growth rate of 0,9% in the second quarter of 1994 compared with a growth of 0,3% in the first quarter. All the sectors showed positive growth rates in the second quarter except for mining and manufacturing which showed decreases in their real seasonally adjusted production. Finance (5,0%) and transport (2,9%) showed the highest growth rates while the trade sector showed a positive growth rate of 2,0% after a decrease of 1,2% in the first quarter.

There has been much speculation as to whether a growth rate of 3,0% could be realised for 1994. In order to realise this growth rate, the total seasonally adjusted real GDP has to grow by an annualised rate of at least 8,2% in each of the last two quarters of 1994. It is, however, clear from the accompanying sectoral data that mainly manufacturing and mining will have to show better growth results in order to achieve this goal. (The possible effect of the current labour unrest and the accompanying strikes on the expected growth performance of the economy should thus be seen against this background.)


