



EKONOMIESE GROEI IN NIE-LANDBOUSEKTOR STERKER IN
TWEDE KWARTAAL

NOTA:

Alle groeikoerse in hierdie statistiese vrystelling is kwartaallikse persentuele veranderings wat uitgedruk word teen jaarkoerse.

Volgens voorlopige aanwysers het die totale seisoens-aangesuiwerde reële BBP teen markpryse in die tweede kwartaal van 1995 met 0,8% toegeneem na 'n toename van 1,4% in die eerste kwartaal. Hierdie laer groeikoers in die tweede kwartaal is hoofsaaklik toe te skryf aan die afname van 41,7% (teen 'n jaarkoers) in die seisoensaangesuiwerde reële landbouproduksie na 'n afname van 18,0% in die eerste kwartaal.

Indien landbou egter buite rekening gelaat word, het die seisoensaangesuiwerde reële BBP van die nie-lanbousektor sterker in die tweede kwartaal van 1995 gegroei as in die eerste kwartaal en wel met 3,1% teenoor 2,1% (beide teen jaarkoerse). Die sektore wat grootliks tot hierdie sterker groei bygedra het is fabrieksweise met 'n groeikoers van 7,0% teenoor 4,7% in die eerste kwartaal; handel met 4,6% teenoor 3,6%; vervoer met 6,9% teenoor 4,8% en finansiering met 5,1% teenoor 3,7%. Die ander sektore het naastenby dieselfde positiewe groei as in die eerste kwartaal getoon met die uitsondering van die mynbousektor wat weereens 'n afname getoon het.

Die kwartaallikse veranderings in die BBP teen konstante 1990-pryse teen seisoensaangesuiwerde jaarkoerse is soos volg:

ECONOMIC GROWTH IN NON-AGRICULTURAL SECTOR STRONGER
IN SECOND QUARTER

NOTE:

All growth rates in this statistical release are quarterly percentage changes which are indicated at annual rates.

According to preliminary indicators the total seasonally adjusted real GDP at market prices increased by 0,8% in the second quarter of 1995 following an increase of 1,4% in the first quarter. This lower growth rate in the second quarter can mainly be ascribed to the decline of 41,7% (at an annualised rate) in the seasonally adjusted real agricultural production after a decline of 18,0% in the first quarter.

Should agriculture be excluded however, the seasonally adjusted real GDP of the non-agricultural sector increased more in the second quarter of 1995 than in the first quarter, namely by 3,1% as against 2,1% (both at annualised rates). The sectors that contributed most to this higher growth are manufacturing with a growth-rate of 7,0% as against 4,7% in the first quarter; trade with 4,6% as against 3,6%; transport with 6,9% as against 4,8% and finance with 5,1% as against 3,7%. The other sectors recorded more or less the same positive growth as in the first quarter except for the mining sector which showed a decline once more.


