Alle groeiakoerse in hierdie Statistiese vrystelling is kwartaalike persentuele veranderinge wat uitgedruk word teen jaarakoerse.

BBP VIR DERDE AGEREENVOLGENDE KWARTAAL HOER

Ná groeiakoerse van onderskeidelik 1,5% en 5,5% vir die eerste twee kwartale van 1993, het die totale seisoensaangesuiwerde reële BBP verder met 'n jaarakoerse van 8,2%, teen markpryse, in die derde kwartaal toegeneem, vergeleke met die tweede kwartaal. Soos in die geval van die eerste twee kwartale kan die toename in die derde kwartaal weer eens hoofsaaklik toegeskryf word aan die volgehoue groei in reële landbouproduksie, naamlik met 196,0% (teen 'n jaarakoerse) teenoor stygings van onderskeidelik 53,9% en 235,9% vir die eerste twee kwartale.

Ten spyte van dié relatief hoë kwartaalike groeiakoerse was die gemiddelde vlak van die totale seisoensaangesuiwerde reële BBP (teen markpryse) in die eerste nege maande van 1993 nog 0,4% laer as in die ooreenstemmende nege maande van 1992. Dit illustreer die besondere lae vlak van die BBP vanwaar die bogemelde kwartaalike groeiakoerse gemeet is.

Wat die nie-landbousektor betref, het die verloop van die reële BBP in die derde kwartaal van 1993 'n betekenisvolle positiewe groeiakoerse van 2,0% (teen 'n jaarakoerse) getoon nadat dit, met die uitsondering van onbeduidende positiewe groeiakoerse in die eerste twee kwartale van 1993, ononderbroke sedert die eerste kwartaal van 1991 afgeneem het. Die sektore wat hoofsaaklik tot hierdie positiewe groeiakoerse bygedra het, is fabriekswese, elektrisiteit en vervoer met kwartaalike groeiakoerse (jaarakoerse) van onderskeidelik 5,5%; 5,5% en 5,4%. Die ander sektore het klein positiewe groeiakoerse getoon met die uitsondering van mynbou en konstruksie wat met onderskeidelik 2,0% en 2,8% (jaarakoerse) in die kwartaal afgeneem het.

Die kwartaalike veranderinge in die BBP teen konstante 1985-pryse teen seisoensaangesuiwerde jaarakoerse is soos volg:

All growth rates in this Statistical release are quarterly percentage changes which are indicated at annualised rates.

GDP UP FOR THIRD CONSECUTIVE QUARTER

Following growth rates of 1,5% and 5,5% in the first two quarters of 1993 respectively, the total seasonally adjusted real GDP increased further at an annualised rate of 8,2% at market prices in the third quarter, compared with the second quarter. As in the case of the first two quarters the increase in the third quarter can once again be attributed mainly to the sustained growth in real agricultural production, namely by 196,0% (at an annualised rate) as against increases of 53,9% and 235,9% for the first two quarters respectively.

Despite this relatively high quarterly growth rates the average level of the total seasonally adjusted real GDP (at market prices) for the first nine months of 1993 was still 0,4% lower than in the corresponding nine months of 1992. This illustrates the particularly low level of the GDP from which the abovementioned quarterly growth rates were measured.

As far as the non-agricultural sector is concerned, the trend of the real GDP in the third quarter of 1993, showed a significant positive growth rate of 2,0% (an annualised rate) after, with the exception of insignificant positive growth rates in the first two quarters of 1993, it had declined continuously since the first quarter of 1991. The sectors which contributed mainly to this positive growth rate, are manufacturing, electricity and transport with quarterly growth rates (annualised rates) of 5,5%; 5,5% and 5,4%, respectively. The other sectors showed small positive growth rates, except mining and construction which declined by 2,0% and 2,8% (annualised rates) respectively in the quarter.


