THE DECLINING TREND IN MANUFACTURING PRODUCTION LEVELS OFF

The declining trend in manufacturing production which started in the middle of 1997 appears to be levelling off. The manufacturing production for the last three months up to February 1999 remained at the same level, after seasonal adjustment, compared with the previous three months. Higher manufacturing production was reported by 17 of the 27 manufacturing major divisions.

The major manufacturing divisions which reflected relatively large increases for the last three months up to February 1999 after seasonal adjustment compared with the preceding three months were the petroleum (+0,3 of a percentage point), the metal (+0,2 of a percentage point), the furniture (+0,2 of a percentage point) and the radio, television and communication (+0,1 of a percentage point) divisions. However, the major manufacturing divisions which reflected relatively large decreases, after seasonal adjustment, during the same period were the basic iron and steel (-0,4 of a percentage point), the food (-0,2 of a percentage point) and the paper (-0,1 of a percentage point) divisions.

The total value of sales of manufactured products for the last three months up to February 1999 reflected an increase of 2,2% (R2 065 million) after seasonal adjustment compared with the preceding three months. The largest increases were reported by the motor vehicle (+15,8% or R1 259 million), the metal (+15,8% or R853 million) and the electrical machinery (+6,9% or R200 million) divisions.

Increased levels of unfilled orders for February 1999 compared with February 1998 were reported by the other metal products (+R543 million), the electric motors, generators and transformers (+R176 million) and the television, radio and communication (+R123 million) subgroups.

NOTES

1. This statistical release shows the indices of the physical volume of manufacturing production and the value of sales and unfilled orders, **after benchmarking**, according to manufacturing divisions and major groups. Furthermore, in accordance with international practice, the indices were recalculated on the basis of 1995=100. Both actual and seasonally adjusted figures are shown. **The former TBVC states are included.**
2. In order to improve timeliness, some information for the current month may have been estimated due to late response. These estimates will be revised in the next issue(s) as soon as better information is available.
3. The calculation of the monthly production indices is based on the value of products and articles manufactured, after the effect of price changes has been eliminated through deflation by using appropriate sub-indices of the Production Price Index (PPI). The value of the manufactured products is obtained from a monthly sample survey of manufacturing establishments in the private and public sectors.
4. **The results of the 1991 and 1993 Manufacturing Censuses were used to adjust the level of the indices and the value of sales.** This process is known as benchmarking. The total value of gross output of the manufacturing major groups (which represents the total value of work done by the establishments in these groups) as obtained from the respective manufacturing censuses, was deflated with appropriate subindices of the Production Price Index in order to calculate the real gross output. The latter served as benchmarks to verify or adjust the level of the monthly volume indices. The level adjustments were done on the volume indices for January of the relevant census year (e.g. the 1993 census year covers the period 1 July 1992 to 30 June 1993 and therefore the benchmarking was done using the index of January 1993 as reference point).
5. The 1988 Manufacturing Census provided the framework for the selection of a revised sample implemented as from January 1995. A stratified systematic sample design based on gross output was used. Establishments which commenced operations after the census have also been taken into account.

6. Production indices for the various manufacturing subgroups, that were previously published in the **Bulletin of Statistics**, were discontinued as from January 1993. The production indices on a subgroup basis can be obtained through approximation by deflating the value of sales according to manufacturing subgroups (as published in Chapter 6 of the Bulletin of Statistics) by the production price indices for the relevant manufacturing subgroups (statistical release P0142.1, entitled **Production Price Index**).

7. More comprehensive detail on the method of calculation and historical data in respect of the production indices according to manufacturing major groups and the value of sales for the period January 1990 to August 1997 was published in statistical releases P3041.3 (entitled **Manufacturing statistics: Indices of the physical volume of manufacturing production, Base: 1995=100, January 1990 to August 1997**) on 12 November 1997 and P3041.4 (entitled **Manufacturing statistics: Value of sales, January 1990 to July 1997**) on 6 November 1997.

8. Stats SA has adopted the confidential pre-release policy in respect of selected economic indicators and specific government departments. The policy accords with practice among leading statistical agencies. The statistical integrity of the indices and strict observance of the release time has been assured by the following procedure:

In respect of this statistical release, an official representative from the Office of the President, the Deputy President, the Department of Trade and Industry, the Department of Finance, and the South African Reserve Bank will receive a copy of the release on a strictly confidential basis two hours in advance of the public issue.
