FABRIEKSESE STYD MERKBAAR

Produksie in die fabriekswesektor toon weer 'n oplewing in Mei 1995 met 'n toename van 2,7% vir die jongste drie maande tot Mei 1995 vergeleke met die voorafgaande drie maande na seisoenaanpassing (as die bydrae van die voormalige TBVC-state buite rekening gelaat word). Inligting tot die beskikking van die SSD dui egter daarop dat 'n beduidende insinking weer in Junie 1995 plaasgevind het.

Toenames in die fisiese volume van fabrieksproduksie vir die jongste drie maande tot Mei 1995 vergeleke met die drie maande tot Februarie 1995 na seisoenaanpassing, is gerapporteer in 18 van die 28 fabriekswese-hoofgroepe. Die grootste bydraers tot die totale toename van 2,7% in die tydperk was die petroleum- en steenkoolprodukte (+0,55 van 'n persentasiepunt), papier- (0,35 van 'n persentasiepunt), nywerheidschemikalieë- (0,29 van 'n persentasiepunt), metaalprodukte- (0,23 van 'n persentasiepunt) en die klerasienywerheid (0,20 van 'n persentasiepunt). Vervaardigers in hierdie bedrywe skryf die toenames in die periode toe aan verhoogde vraag na produkte, beide vir die plaaslike en uitvoermark, sowel as die langer produksie maand in Mei 1995.

Verkope van vervaardigde produkte het na seisoenaanpassing in Mei 1995 met R1 330 miljoen toeneem vergeleke met April 1995. Motorvoertuigverkope het met R415 miljoen toeneem tussen die twee maande, terwyl basiese nie-systermetaalprodukte (+R156 miljoen) en basiese yster- en staalprodukte (+R114 miljoen) verder bygedra het tot voornoemde toename. Toenames van ongeveer R80 miljoen is deur elk van die nywerheidschemikalieë- en elektriese masjienerienywerhede gerapporteer.

Die voormalige TBVC-state is vanaf die Januarie 1995-opname ingesluit. Inligting tot die SSD se beskikking dui daarop dat die totale waarde van fabrieksproduksie van dié state vir Januarie 1995 ongeveer 1,8% van die totaal uitgemaak het. Vergelykings met die vorige maande moet dus met omsigtigheid hanteer word, aangesien die voormalige state voor Januarie 1995 uitgesluit is.

SIGNIFICANT INCREASE IN MANUFACTURING

Production in the manufacturing sector again shows a revival in May 1995 with an increase of 2,7% for the latest three months up to May 1995 compared with the preceding three months after seasonal adjustment (if the contributions of the former TBVC states are not taken into account). Information at the disposal of the CSS shows, however, that a significant slump again occurred in June 1995.

Increases in the physical volume of manufacturing production for the latest three months up to May 1995 as compared with the three months up to February 1995 after seasonal adjustment were reported by 18 of the 28 manufacturing major groups. The largest contributors to the total increase of 2,7% during this period were the petroleum and coal products (+0,55 of a percentage point), paper (0,35 of a percentage point), industrial chemicals (0,29 of a percentage point), metal products (0,23 of a percentage point) and the wearing apparel industries (0,20 of a percentage point). Manufacturers in these industries attribute the increases in this period to an increase in demand for products, both for the local and export market, as well as May 1995 being a longer production month.

Sales of manufactured products increased by R1 330 million in May 1995 after seasonal adjustment compared with April 1995. Sales of motor vehicles increased by R415 million between these two months, whereas basic non-ferrous metal products (+R156 million) and basic iron and steel products (+R114 million) contributed further to the aforementioned increase. Increases of approximately R80 million were reported by each of the industrial chemicals and electrical machinery industries.

The former TBVC states were included as from the January 1995 survey. Information available to the CSS indicates that the total value of manufacturing production of the states for January 1995 amounted to approximately 1,8% of the total. Comparisons with the previous months must thus be handled with circumspection, as the former states were excluded before January 1995.





SUBGROEPINDEKSE

1. Produksie-indekse vir die onderskeie fabriekswesesubgroepe, wat in die verlede in die *Bulletin van Statistieke* gepubliseer is, is sedert die indekse vir Januarie 1993 gestaak. Aangesien sub-indekse van die Produksieprysindeks (PPI) wat as deflators vir die waarde van produksie gebruik word tans slegs op 'n hoofgroepgrondslag beskikbaar is, kan produksieindekse nie op 'n subgroepgrondslag volgens die nuwe metode van berekening verkry word nie. Die berekening van die PPI op 'n subgroepgrondslag word tans ondersoek. Die hervatting van die berekening en publikasie van die produksieindekse op 'n subgroepgrondslag sal oorweeg word sodra toepaslike PPI-subindekse beskikbaar is.
2. Die produksie-indekse op 'n subgroepgrondslag kan egter by benadering verkry word deur die waarde van verkope volgens fabriekswesesubgroepe (kyk Tabel 6.2.2, *Bulletin van Statistieke*) te defleer met die produksieprysindekse (Tabel 3.1.2, *Bulletin van Statistieke*) vir die betrokke fabriekswesehoofgroep. Daar moet egter in gedagte gehou word dat die verloop van die produksieprysindeks vir 'n bepaalde hoofgroep nie noodwendig die verloop van die produksieprys in elk van die onderskeie subgroepe weerspieël nie.

OPMERKINGS

1. Hierdie statistiese vrystelling toon indekse van die fisiese volume van fabrieksproduksie en die waarde van verkope en onvoltooide bestellings volgens fabriekswesehoofgroepe. Beide werklike en seisoensaangepaste syfers word getoon. Verkope- en produksieyfers t.o.v. Walvisbaai is uitgesluit vanaf 1 Maart 1994.
2. Die berekening van die maandelikse fabrieksproduksie-indekse is gebaseer op die waarde van vervaardigde produkte en artikels nadat die effek van prysveranderinge uitgeskakel is met deflering deur gebruik te maak van toepaslike subindekse van die produksieprysindeks (PPI). Die waarde van vervaardigde produkte word verkry uit 'n maandelikse steekproefopname van die fabrieks-inrigtings in die private en openbare sektore.
3. Die 1988-fabriekswesensus het die raamwerk verskaf vir die keuse van 'n hersiene steekproef wat vanaf Januarie 1995 in werking gestel is. 'n Gestratifiseerde sistematiese steekproefontwerp gebaseer op bruto opbrengs is gebruik. Inrigtings wat na die sensus met bedrywighede begin het, is ook in aanmerking geneem. Die beswaringsfaktore vir die samevoeging van die produksie-indekse vir die fabriekswesehoofgroepe na die vir die totale fabriekswese is bereken op grond van die netto opbrengsgegewens verkry uit die 1988-fabriekswesensus.
4. Die resultate van die 1988-fabriekswesensus is gebruik om die vlak van die indekse en die waarde van verkope te bepaal. Hierdie proses word hoogtemerkbepaling ("benchmarking") genoem.

SUBGROUP INDICES

1. Production indices for the various manufacturing subgroups that were previously published in the *Bulletin of Statistics* were discontinued as from the indices for January 1993. As the sub-indices of the Production Price Index (PPI) that are used as deflators for the value of production are at present available on a major group basis only, the production indices can not be obtained on a subgroup basis according to the new method of calculation. The calculation of the PPI on a subgroup basis is currently being investigated. The recommencement of the calculation and publication of the production indices on a subgroup basis will be considered as soon as the appropriate PPI sub-indices are available.
2. The production indices on a subgroup basis can however be obtained by approximation by deflating the value of sales according to manufacturing subgroups (see Table 6.2.2, *Bulletin of Statistics*) with the production price indices (Table 3.1.2, *Bulletin of Statistics*) for the relevant manufacturing major group. It must, however, be remembered that the trend of the production price index for a specific major group will not necessarily reflect the trend of the production prices for each of the various subgroups.

NOTES

1. This statistical release shows indices of the physical volume of manufacturing production and the value of sales and unfilled orders according to manufacturing major groups. Both actual and seasonally adjusted figures are shown. Sales and production figures for Walvis Bay are excluded as from 1 March 1994.
2. The calculation of the monthly manufacturing indices is based on the value of manufactured products and articles after the effect of price changes has been eliminated by deflation by using appropriate sub-indices of the production price index (PPI). The value of the manufactured products is obtained from a monthly sample survey of manufacturing establishments in the private and public sectors.
3. The 1988 Manufacturing Census provided the framework for the selection of a revised sample implemented as from January 1995. A stratified systematic sample design based on gross output was used. Establishments which commenced operations after the census have also been taken into account. The weighting factors for the combining of the production indices for the manufacturing major groups to those for total manufacturing were calculated on the basis of the net output data obtained from the 1988 Manufacturing Census.
4. The results of the 1988 Manufacturing Census were used to determine the level of the indices and the value of sales. This process is known as benchmarking.

5. Meer volledige besonderhede oor die berekeningswyse en historiese gegewens ten opsigte van die produksie-indekse volgens fabriekswese hoof-groepe en die waarde van verkope vir die periode Januarie 1978 tot Julie 1993 is in statistiese vrystellings P3041.3 (getiteld Fabriekswese-statistieke: Indekse van die fisiese volume van fabrieksproduksie, Basis: 1990=100, Januarie 1978 tot Julie 1993) en P3041.4 (getiteld Fabriekswesestatistieke: Waarde van verkope, Januarie 1978 tot Julie 1993) gepubliseer.

5. More comprehensive detail on the method of calculation and historical data in respect of the production indices according to manufacturing major groups and the value of sales for the period January 1978 to July 1993 were published in statistical releases P3041.3 (entitled Manufacturing statistics: Indices of the physical volume of manufacturing production, Base: 1990=100, January 1978 to July 1993) and P3041.4 (entitled Manufacturing statistics: Value of sales, January 1978 to July 1993).
