SUMMARY OF FINDINGS

BUILDING PLANS PASSED

The downward trend in the value of building plans passed which started around the middle 1996 is continuing

Building plans to the value of R10 227,3 million (at current prices) were passed during the first seven months of 1997. This represents a decrease of 4,6% (R496,5 million) compared with the same period in 1996. The total value of plans passed for residential buildings and for additions and alterations decreased by 9,4% (R494,4 million) and 7,9% (R211,8 million) respectively, whereas the total value of plans passed for non-residential buildings increased by 7,5% (R209,7 million).

The total value of plans passed for residential buildings during the first seven months of 1997 was R4 755,6 million. The largest provincial contributors were Gauteng (R1 909,3 million or 40,1%), the Western Cape (R1 246,6 million or 26,2%) and KwaZulu-Natal (R695,7 million or 14,6%). R3 122,3 million or almost two thirds of the total value of plans passed for residential buildings was for dwelling-houses, whereas R1 002,2 million (21,1%) was for townhouses, R398,4 million (8,4%) for flats and R232,7 million (4,9%) for other residential buildings. Regarding dwelling-houses, a total of 30 079 plans were passed during the above mentioned period. A large portion (58,3% or 17 536 plans) of the 30 079 dwelling-house plans passed was for dwelling-houses smaller than 81 square meters.

The total value of non-residential buildings plans passed during the first seven months of 1997 was R3 015,7 million. The largest provincial contributors were Gauteng (51,5%), KwaZulu-Natal (15,6%) and the Western Cape (15,2%) while the other six provinces contributed only 17,7%, ranging from 5,0% for the North West to 0,6% for the Northern Cape.

Regarding additions and alterations, the total value of plans passed during the first seven months of 1997 amounted to R2 456,0 million.

The total value of buildings completed during the first seven months of 1997 was R6 056,2 million (at current prices), resulting in an increase of 11,7% (R636,1 million) compared with the same period in 1996. The total value of non-residential buildings and of additions and alterations increased by 41,1% and 24,4% respectively, whereas residential buildings decreased by 4,2%.

Non-residential buildings to the value of R1 667,2 million were completed during the first seven months of 1997. This is R488,5 million higher than the value for the corresponding period of 1996. Of the R488,5 million, R338,1 million (69,2%) was for office space, followed by industrial space (R92,1 million or 18,9%), shopping space (R35,5 million or 7,2%), and other non-residential buildings (R22,8 million or 4,7%). Furthermore, the largest provincial contributors were Gauteng (R280,9 million or 57,5%), the Western Cape (R100,1 million or 20,5%) and KwaZulu-Natal (R74,4 million or 15,2%).

The total value of residential buildings and of additions and alterations completed during the first seven months of 1997 was R2 978,4 million and R1 410,6 million, respectively.

1. GENERAL NOTES

The data in the tables relate to building activities financed by the public and private sectors (Tables 1.1 and 1.2) according to provinces as well as those financed only by the private sector (Tables 2 to 11.3). The data for activities financed by the private sector are given according to provinces (Tables 2.1 and 2.2) and according to the 22 principal municipalities, their surrounding areas and smaller urban areas.

The monthly survey covers roughly 181 local authorities in South Africa. The sample for the monthly series is drawn using the rand value of buildings completed as measure of size. The largest local authorities in South Africa, i.e. those that account for approximately 80% of the total value of buildings completed are included in the monthly survey. The various areas, as well as the method of computation of values at constant 1990 prices, are described in the Bulletin of Statistics.

A survey of buildings completed is undertaken each year and covers all those areas not included in this monthly survey (including those in the former self-governing territories and trust areas). The data are published in the report series 5011, building plans passed and buildings completed, which covers roughly 673 local authorities in South Africa.

Statistics on dwelling-houses smaller than 81m² on provincial basis are shown in Tables 1.1, 1.2 (private and public sector) and Tables 2.1, 2.2 (private sector). More detailed information on dwelling-houses smaller than 81m² for the private sector is shown in Table 9.

The figures for the latest month are subject to revision.

2. INCLUSION OF FORMER TBVC STATES

As from January 1995 selected local authorities of the former TBVC states are included. Comparisons with the previous years must thus be handled with circumspection. The contribution of selected local authorities in the former TBVC states to the total value of building plans passed amounted to 0,8% (R144,5 million) during 1995. Contributors to this increase are local authorities in North West (R83,7 million), Eastern Cape (R47,7 million) and the Northern Province (R13,1 million).

3. DEFINITIONS

3.1 Blocks of flats are high-density housing consisting of a number of self-contained dwelling-units (including at least one living-room together with a kitchen and bathroom), conjoined to similar units in one building.

3.2 Townhouses are multiple, medium-density dwelling-units and include cluster housing, group housing, simplexes, duplexes, triplexes and other similar dwelling-units which are usually grouped together, with one level of each unit on ground level.
