## SHARP INCREASE IN THE VALUE OF NON-RESIDENTIAL BUILDINGS COMPLETED

*The total value of non-residential buildings completed during the first quarter of 1997 amounted to R748,0 million - a considerable increase of 93,9% (+R362,2 million) compared with the corresponding quarter of 1996. The largest contributor to the increase is Gauteng (+R323,1 million), where increases occurred in respect of office space (+R241,0 million), shopping space (+R41,1 million) and industrial space (+R32,3 million). In the case of office space, increases were reported by Johannesburg (+R127,0 million), Pretoria (+R50,3 million) and Sandton (+R49,5 million).*

The relative importance of the value of non-residential buildings completed as a percentage of the non-agricultural gross domestic product during the first quarter of 1996 was the highest in the Northern Cape followed by the Western Cape and KwaZulu-Natal. However, for the first quarter of 1997 Gauteng took the lead, whereas in the Northern Cape and North West the relative importance of the value of non-residential buildings completed as a percentage of the non-agricultural gross domestic product decreased substantially (cf. figure).

The total value of buildings completed during the first quarter of 1997 decreased by 20,7% (+R445,1 million) to R2 597,7 million compared with the first quarter of 1996. The total value of residential buildings completed decreased by 3,8% (-R48,7 million), non-residential buildings increased by 93,9% (+R362,2 million), whereas additions and alterations increased by 26,4% (+R131,7 million). Regarding additions and alterations, the largest contributors were KwaZulu-Natal (+R69,8 million), the Western Cape (+R38,0 million) and Gauteng (+R13,0 million).

The total value of building plans passed for the first quarter of 1997 decreased by 3,3% (R137,2 million) compared with the corresponding quarter of 1996. This decrease can mainly be attributed to a decrease of R231,3 million (11,4%) in the value of residential building plans passed. However, the value of building plans passed for non-residential buildings and additions and alterations increased by 7,8% (+R90,6 million) and 0,4% (+R3,6 million) respectively.

## 1. GENERAL NOTES

The data in the tables relate to building activities financed by the public and private sectors (Tables 1.1 and 1.2) according to provinces as well as those financed only by the private sector (Tables 2 to 11.3). The data for activities financed by the private sector are given according to provinces (Tables 2.1 and 2.2) and according to the 22 principal municipalities, their surrounding areas and smaller urban areas. In the case of building activities financed by the private sector, the monthly survey represents approximately 80 percent of total building activities financed by the private sector, which also includes public corporations. The various areas, as well as the method of computation of values at constant 1990 prices, are described in the **Bulletin of Statistics**

Statistics on dwelling-houses smaller than 81<sup>2</sup> are shown in Table 9.

The figures for the latest month are subject to revision.

A survey of buildings completed is undertaken each year and covers all those areas not included in this monthly survey (including those in the former self-governing territories and trust areas). The data are published in the report series 5011, building plans passed and buildings completed.

## 2. INCLUSION OF FORMER TBVC STATES

As from January 1995 selected local authorities of the former TBVC states are included. Comparisons with the previous years must thus be handled with circumspection. The contribution of selected local authorities in the former TBVC states to the total value of building plans passed amounted to 0,8% (R144,5 million) during 1995. Contributors to this increase are local authorities in North West (R83,7 million), Eastern Cape (R47,7 million) and the Northern Province (R13,1 million).

### 3. DEFINITIONS

3.1 Blocks of flats are high-density housing consisting of a number of self-contained dwelling-units (including at least one living-room together with a kitchen and bathroom), conjoined to similar units in one building.

3.2 Townhouses are multiple, medium-density dwelling-units and include cluster housing, group housing, simplexes, duplexes, triplexes and other similar dwelling-units which are usually grouped together, with one level of each unit on ground level.
