


1. Summary of findings for the year 2009

Figure 1 – Income in the wholesale trade industry, 2009



The total income for the wholesale trade industry in 2009 was R1 008 253 million. The largest contributor to the total income was 'wholesale trade in machinery, equipment and supplies' (R213 819 million or 21%), followed by 'wholesale trade in food, beverages and tobacco' (R177 691 million or 18%) and 'wholesale trade in other household goods' (R125 304 million or 12%) (Figure 1 and Table 2, page 7).


Figure 2 - Income by enterprise size in the wholesale trade industry, 2009



Large enterprises (those with a turnover equal to or greater than R64 million) generated R820 271 million or 81% of the total income of the wholesale trade industry in 2009, followed by small enterprises (R88 266 million or 9%), medium enterprises (R72 079 million or 7%) and micro enterprises (R27 637 million or 3%) (Figure 2 and Table 3, page 8).



The total expenditure in the wholesale trade industry in 2009 was R976 102 million. The largest contributor to the total expenditure was 'purchases' (R803 676 million or 83%), followed by 'salaries and wages' (R62 565 million or 6%) (Figure 3 and Table 4, page 9).


Figure 4 - Profit margin in the wholesale trade industry, 2009



The profit margin for the wholesale trade industry was 3,3% in 2009. 'Wholesale trade on a fee or contract basis' had the highest profit margin at 5,4%, followed by 'wholesale trade in metals and metal ores' at 5,2% and 'wholesale trade in machinery, equipment and supplies' at 4,6% (Figure 4 and Table 1, page 6).



Figure 5 – Capital expenditure on new assets in the wholesale trade industry, 2009




The total capital expenditure on new assets in the wholesale trade industry in 2009 was R11 280 million. The largest category of capital expenditure was 'plant, machinery and other office equipment' (R4 853 million or 43%), followed by 'other capital expenditure' (R2 363 million or 21%), 'vehicles' (R2 059 million or 18%) and 'buildings and construction' (R1 260 million or 11%) (Figure 5 and Table 8, page 15).

Figure 6 - Employment in the wholesale trade industry, 2009




The total number of persons employed in the wholesale trade industry at the end of June 2009 was 444 677. 'Other wholesale trade' had the largest number of employees (102 479 or 23%), followed by 'wholesale trade in machinery, equipment and supplies' (95 241 or 21%) and 'wholesale trade in food, beverages and tobacco' (59 855 or 13%) (Figure 6 and Table 9, page 16).

Employment by enterprise size indicates that the large enterprises (those with turnover equal to or greater than R64 million) had 229 828 employees (52%), followed by small enterprises with 105 823 employees (24%), micro enterprises with 64 394 employees (14%) and medium enterprises with 44 632 employees (10%) (Figure 7 and Table 10, page 17).

The proportion of males out of the total persons employed was 66% and that of females was 34%. The industry with the highest proportion of females employed was 'wholesale trade in textile, clothing and footwear' (45%) whilst 'wholesale trade in construction materials, hardware, plumbing and heating equipment and supplies' had the highest proportion of males employed (73%) (Figure 8 and Table 9, page 16).

Explanatory notes

Background

The results presented in this publication have been derived from the 2009 wholesale trade large sample survey. This is a periodic survey, which measures economic activity in the wholesale trade industry of the South African economy. This survey is based on a sample of private and public enterprises operating in the wholesale trade industry.

The sample was drawn from Stats SA's business register. Stats SA continuously upgrades its business register, based on units registered for value added tax (VAT) and income tax (IT) at the South African Revenue Service (SARS).

All figures exclude value added tax (VAT).

Reference period

The information was collected from enterprises for their financial year, which ended on any date between 1 July 2008 and 30 June 2009.

Purpose of the survey

Results of the survey are used within Stats SA for compiling South Africa's national accounts, e.g. the gross domestic product (GDP) and gross fixed capital formation. These statistics are also used by the private sector in analyses of comparative business and industry performance.

Scope and coverage

This survey covers the following income tax-registered private and public enterprises that are mainly engaged in wholesale trade:

- Wholesale trade on a fee or contract basis (SIC 6110).
- (ii) Wholesale trade in agricultural raw materials and livestock (SIC 6121).
- (iii) Wholesale trade in food, beverages and tobacco (SIC 6122).
- (iv) Wholesale trade in textiles, clothing and footwear (SIC 6131).
- (v) Wholesale trade in other household goods (SIC 6139).
- (vi) Wholesale trade in solid, liquid and gaseous fuels and related products (SIC 6141).
- (vii) Wholesale trade in metals and metal ores (SIC 6142).
- (viii) Wholesale trade in construction materials, hardware, plumbing and heating equipment and supplies (SIC 6143).
- (ix) Wholesale trade in other intermediate products, waste and scrap (SIC 6149).
- (x) Wholesale trade in machinery, equipment and supplies (SIC 6150).
- (xi) Other wholesale trade (SIC 6190).

Classification by industry

The 1993 edition of the Standard Industrial Classification of all Economic Activities (SIC), Fifth Edition, Report No. 09-09-02, was used to classify the statistical units in the survey. The SIC is based on the 1990 International Standard Industrial Classification of all Economic Activities (ISIC) with suitable adaptations for local conditions. Statistics in this publication are presented at 4-digit SIC level (group). Each enterprise is classified to an industry, which reflects its predominant activity.

Statistical unit

The statistical unit for the collection of the information is an enterprise. An enterprise is a legal unit (or a combination of legal units) that includes and directly controls all functions necessary to carry out its activities.

Size groups

The enterprises are divided into four size groups according to the value of their business register turnover. Large enterprises are enterprises with an annual turnover of R64 million and more. Table A presents the size groups defined using the Department of Trade and Industry (DTI) cut-off points.

Survey methodology and design

The survey was conducted by post, email, fax, telephone and personal visits.

A sample of approximately 3 000 enterprises was drawn from a frame of approximately 36 000 enterprises using stratified simple random sampling. The enterprises were first stratified at 4-digit level according to the SIC and then by size of enterprise. All large enterprises were completely enumerated. Business register turnover was used as the measure of size for stratification. The response rate was 82,6%.

Weighting methodology

For those size groups not completely enumerated, the weights to produce estimates are the inverse ratio of the sampling fraction, modified to take account of non-response in the survey. Stratum estimates were calculated and then aggregated with the completely enumerated stratum to form group estimates. These procedures, which are in line with international best practice, are described in more detail on the Stats SA website at www.statssa.gov.za/publications/publicationsearch.asp.

Relative standard error

Data presented in this publication are based on information obtained from a sample and are, therefore, subject to sampling variability; that is they may differ from the figures that would have been produced if the data had been obtained from all enterprises in the wholesale trade industry in South Africa.

One measure of the likely difference is given by the standard error (SE), which indicates the extent to which an estimate might have varied by chance because only a sample of enterprises was used. The relative standard error (RSE) provides an immediate indication of the percentage errors likely to have accrued due to sampling.

Non-sampling errors

Inaccuracies may occur because of imperfections in reporting by enterprises and errors made in the collection and processing of the data. Inaccuracies of this kind are referred to as non-sampling errors. Every effort is made to minimise non-sampling errors by careful design of questionnaires, testing them in pilot studies, editing reported data and implementing efficient operating procedures. Non-sampling errors occur in both sample surveys and censuses.

Rounding-off of figures

The figures in the tables have, where necessary, been rounded off to the nearest final digit shown. There may therefore be slight discrepancies between the sums of the constituent items and the totals shown.

Glossary

Casual employees

Casual employees are employees who fall neither within the 'permanent employees' category nor the 'temporary employees' category. Such employees are typically working daily or hourly.

Current assets

Assets on the balance sheet which are expected to be sold or otherwise used up in the near future, usually within one year. They include:

- trade and other receivables:
- cash and bank:
- inventories; and
- · other current assets.

Current liabilities

Current liabilities are debts or obligations that are due within one year. They include:

- trade and other payables;
- · bank overdraft; and
- · other current liabilities.

Employees

Employees are those people employed by the business or organisation who received payment (in salaries, wages, commission, piece rates or payments in kind) for the last pay period ended on or before 30 June 2009.

Leasing income

Leasing income includes:

- leasing and hiring of motor vehicles and other transport equipment;
- leasing and hiring of plant, machinery, equipment and vehicles; and
- · rental of land, buildings and other structures.

Net profit or loss before tax

Net profit or loss before tax is derived as:

Total income plus closing value of inventories minus total expenditure minus opening value of inventories

Non-current assets

Non-current assets are assets which are not easily convertible to cash or not expected to become cash within the next year. They include:

- property, plant and equipment and intangible assets;
- long-term investments; and
- other non-current assets.

Non-current liabilities

Non-current liabilities are liabilities not due to be paid within one year during the normal course of business. They include:

- long-term loans; and
- other non-current liabilities.

Other expenditure

Other expenditure includes:

- accommodation;
- bursaries;
- · containers and packaging materials;
- · donations;
- entertainment:
- excise and customs duty;
- losses on liabilities;
- losses on foreign exchange;
- mineral rights leases;
- postal and courier services;
- property tax;
- provisions;
- research and development;
- royalties;
- severance, termination and redundancy payments;
- skills development levy;
- staff training (payment to outside organisations)
- · subcontracting expenses;
- subscriptions;
- travelling; and
- other.

Other income

Other income includes:

- profit for redemption, liquidation or revaluation of liabilities;
- mineral rights;
- provisions;
- subsidies; and
- other.

Owners' equity Owners' equity is the residual interest in the entity's assets after deducting its liabilities.

Permanent employees are employees appointed on an open-ended contract with no stipulated termination date or a fixed-term contract for periods

of more than one year.

Profit margin Profit margin is derived as:

Net profit after tax divided by turnover multiplied by 100

Statistical unit A statistical unit is a unit about which statistics are tabulated, compiled or published. The statistical units are derived from and linked to the South

African Revenue Service (SARS) administrative data.

Stratum A stratum is constructed by concatenating the SIC classification and size group variables.

Temporary employees are employees appointed on a short-term contract basis with a stipulated termination date for periods not exceeding one

year.

Turnover Turnover includes:

value of sales of goods;

· amount received for services rendered;

rent and lease payments received for land and buildings; and

· rent, leasing and hiring received for machinery, vehicles and other equipment.

General information

Stats SA publishes approximately 300 different statistical releases each year. It is not economically viable to produce them in more than one of South Africa's eleven official languages. Since the releases are used extensively, not only locally but also by international economic and social-scientific communities, Stats SA releases are published in English only.
