

REËLE GROOTHANDELVERKOPE NEEM TOE IN 1994


Die reële groothandelverkope (diamante uitgesluit) teen konstante 1990-pryse vir die jaar 1994 toon 'n toename van 3,9% teenoor 1993.

Toenames in die reële groothandelverkope vir 1994 vergeleke met 1993 het by al die soorte besighede, behalwe dié van voedsel, drank en tabak voorgekom. Die grootste toename het by die groothandelverkope van kantoor- en winkeltoerusting, boeke en skryfbehoefte (19,7%) voorgekom, gevolg deur die grootandelverkope van lewende hawe en landbouprodukte (19,2%). Die totale waarde van groothandelverkope (diamante uitgesluit) teen heersende pryse vir Desember 1994 bedra R14 269,3 miljoen, wat na seisoensaanpassing egter 1,5% laer is as vir November 1994.

Die groothandelverkope (diamante uitgesluit) vir Desember 1994 is 0,5% laer as die verwagte verkope vir Desember 1994 soos deur die groothandelaars in die vooruitsig gestel*.

Die gegewens in hierdie statistiese vrystelling sluit die voormalige TBVC-state uit. Gegewens van die voormalige state sal vanaf die Januarie 1995-opname ingesluit word.

REAL WHOLESALE TRADE SALES INCREASE IN 1994


The real wholesale trade sales (excluding diamonds) at constant 1990 prices for the year 1994 reflect an increase of 3,9% compared with 1993.

Increases in the real wholesale trade sales for 1994 compared with 1993 occurred in respect of all the kinds of businesses, except those of foodstuffs, beverages and tobacco. The largest increase occurred in respect of the wholesale trade sales of office and shop equipment, books and stationery (19,7%), followed by the wholesale trade sales of livestock and produce (19,2%). The total value of wholesale trade sales (excluding diamonds) at current prices for December 1994 amounts to R14 269,3 million which, after seasonal adjustment, is 1,5% lower than for November 1994.

The wholesale trade sales (excluding diamonds) for December 1994 are 0,5% lower than the expected sales for December 1994 as foreseen by the wholesalers*.

The data in this statistical release exclude the former TBVC states. Data of the former states will be included as from the January 1995 survey.

OPMerkINGS

Hierdie statistiese vrystelling toon finale rameings van die groothandelverkope (die voormalige TBVC-state uitgesluit). Die opname word op 'n firmabasis gedoen. Die resultate van die steekproefopname word verhef om die totale groothandelverkope te verteenwoordig. Beide die werklike en seisoensaangepaste waardes van groothandelverkope volgens soort besigheid teen heersende sowel as konstante 1990-pryse word getoond. Die waarde van verkope teen konstante 1990-pryse ten opsigte van elke soort besigheid is verkry deur die verkoopwaarde teen heersende pryse met behulp van sub-indeksie van die produksieprysindeks op basis 1990 = 100 te deelfeer.

Groothandelverkope teen heersende pryse sluit BIW in.

'n Voorlopige raming van totale groothandelverkope word in statistiese vrystelling P6141.1 gepubliseer.

NOTES

This statistical release shows final estimates of the wholesale trade sales (excluding the former TBVC states). The survey is conducted on a firm basis. The results of the sample survey are raised to represent the total wholesale trade sales. Both actual and seasonally adjusted values of wholesale trade sales according to kind of business at current as well as constant 1990 prices are shown. The value of sales at constant 1990 prices in respect of each kind of business is obtained by deflating the sales value at current prices by means of sub-indices of the production price index on base 1990 = 100.

Wholesale trade sales at current prices include VAT.

A preliminary estimate of total wholesale trade sales is published in statistical release P6141.1.
