

REAL WHOLESALE TRADE SALES DECREASE FOR 1997

The real wholesale trade sales (at constant June 1995 prices), excluding diamonds, for 1997 show a decrease of 1,2% compared with 1996.

The total wholesale trade sales (at current prices), excluding diamonds, for 1997 amounted to R237 990,9 million, which is 7,5% higher than that for 1996. Eight of the nine wholesaler categories showed increases in their sales over this period. The largest percentage increase occurred in respect of the sales of wholesalers in textiles, clothing and footwear (+17,4%), followed by wholesalers in machinery (+15,3%). The sales of wholesalers in pharmaceutical and chemical products show a decrease of 0,6%.



The wholesale trade sales (excluding diamonds) for December 1997 amounted to R19 671,4 million, which is 0,8% higher than for November 1997 after seasonal adjustment. This represents an increase of 0,9% in real terms (at constant June 1995 prices).

There is a declining trend in the growth rate of real wholesale trade sales. The real sales reflected an increase of 7,9% between 1994 and 1995, an increase of 2,3% between 1995 and 1996 and a decrease of 1,2% between 1996 and 1997 (see table).

EXPLANATORY NOTES

This statistical release shows final estimates of the wholesale trade sales in the Republic of South Africa (the former TBVC states are included). The survey is conducted on a firm basis. The results of the sample survey are raised to represent the total wholesale trade sales. Both actual and seasonally adjusted values of wholesale trade sales according to type of business at current as well as at constant June 1995 prices are shown. The value of sales at constant June 1995 prices in respect of each type of business is obtained by deflating the sales value at current prices by means of sub-indices of the production price index on base June 1995=100.

Wholesale trade sales at current prices include VAT.
