GROOTHANDELVERKOPE NEEM TOE VIR 1995

Die totale waarde van groothandelverkope (diamante uitgesluit) vir die jaar 1995 bedra R196 495,6 miljoen, wat 17,4% hoër is as vir 1994. Dit verteenwoordig 'n toename van 7,4% in reële terme (teen konstante 1990-pryse).

Die groothandelverkope (diamante uitgesluit) vir Desember 1995 bedra R16 896,3 miljoen, wat na seisoensaangepassing 3,1% hoër is as vir November 1995. Groothandelaars in diverse goedere, wat die grootste marktaandeel het, toon die grootste persentasie toename (+9,9%) in hul seisoensaangepaste verkope. Afname in seisoensaangepaste verkope het voorgekom by groothandelaars in kantoor- en winkeltoerusting, boeke en skryfbehoeftes (-6,9%) en groothandelaars in farmaseutiese en chemiese produkte (-2,0%).

Die waarde van groothandelverkope (diamante uitgesluit) vir Desember 1995 is 1,2% hoër as die verwagte verkope vir Desember 1995 soos deur die groothandelaars in die vooruitsig gestel (kyk statistiese vrystelling P6141.1 van 25 Januarie 1996).

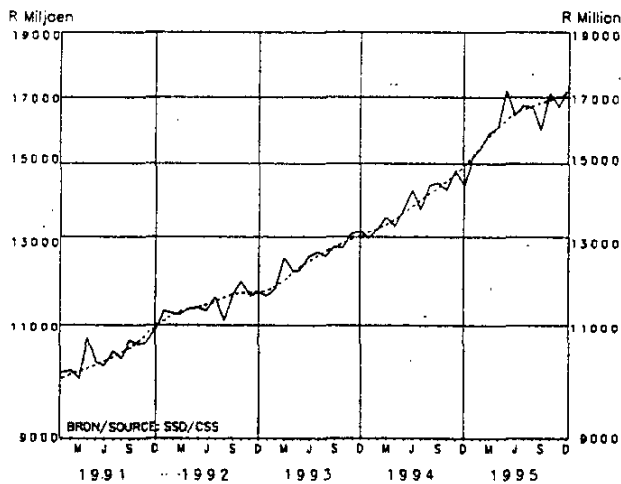
WHOLESALE TRADE SALES INCREASE FOR 1995

The total value of wholesale trade sales (excluding diamonds) for the year 1995 amounts to R196 495,6 million, which is 17,4% higher than for 1994. This represents an increase of 7,4% in real terms (at constant 1990 prices).

The wholesale trade sales (excluding diamonds) for December 1995 amount to R16 896,3 million, which is 3,1% higher than for November 1995 after seasonal adjustment. Wholesalers in miscellaneous goods, which have the largest market share, reflect the largest percentage increase (+9,9%) in their seasonally adjusted sales. Decreases in seasonally adjusted sales occurred in respect of wholesalers in office and shop equipment, books and stationery (-6,9%) and wholesalers in pharmaceutical and chemical products (-2,0%).

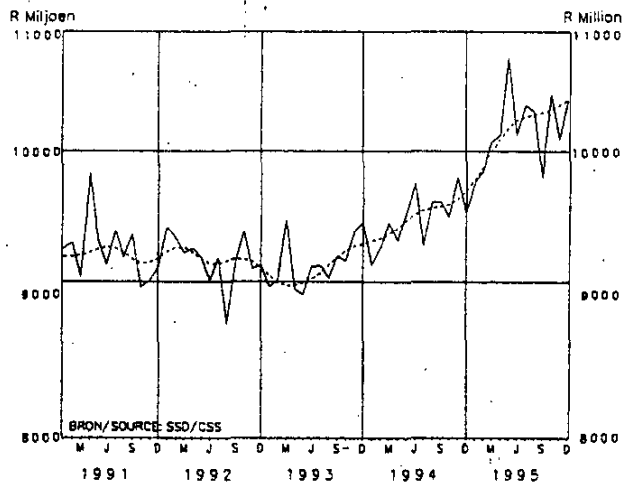
The value of wholesale trade sales (excluding diamonds) for December 1995 is 1,2% higher than the expected sales for December 1995 as foreseen by the wholesalers (see statistical release P6141.1 of 25 January 1996).

OPMERKINGS

Hierdie statistiese vrystelling toon finale ramings van die groothandelverkope in die Republiek van Suid-Afrika (die voormalige TBVC-state is voor Januarie 1995 uitgesluit). Die opname word op 'n firmabasis gedoen. Die resultate van die steekproefopname word verhef om die totale groothandelverkope te verteenwoordig. Beide die werklike en seisoensaangepaste waardes van groothandelverkope volgens soort besigheid teen heersende sowel as konstante 1990-pryse word getoon. Die waarde van verkope teen konstante 1990-pryse ten opsigte van elke soort besigheid is verkry deur die verkoopwaarde teen heersende pryse met behulp van subindekse van die produksieprysindeks op basis 1990 = 100 te defleer.

Groothandelverkope teen heersende pryse sluit BTW in.

'n Voorlopige raming van totale groothandelverkope word in statistiese vrystelling P6141.1 gepubliseer.

NOTES

This statistical release shows final estimates of the wholesale trade sales in the Republic of South Africa (the former TBVC states are excluded before January 1995). The survey is conducted on a firm basis. The results of the sample survey are raised to represent the total wholesale trade sales. Both actual and seasonally adjusted values of wholesale trade sales according to type of business at current as well as constant 1990 prices are shown. The value of sales at constant 1990 prices in respect of each type of business is obtained by deflating the sales value at current prices by means of sub-indices of the production price index on base 1990 = 100.

Wholesale trade sales at current prices include VAT.

A preliminary estimate of total wholesale trade sales is published in statistical release P6141.1.
