


DECREASE IN SEASONALLY ADJUSTED REAL WHOLESALE TRADE SALES FOR JANUARY 1996

The value of wholesale trade sales (excluding diamonds) amounted to R15 385,5 million for January 1996, which after seasonal adjustment showed a slight increase of 0,9% compared with December 1995. However, in real terms (at constant 1990 prices) this represents a decrease of 0,6%.

The sales of wholesalers in "miscellaneous" goods which have the largest market share, amounted to R4 609,8 million for January 1996, which after seasonal adjustment decreased by 2,1% compared with December 1995. In real terms (at constant 1990 prices) this represents a decrease of 2,7%. The seasonally adjusted sales of wholesalers in "textiles, clothing and footwear" showed the largest percentage decrease at current (-15,7%) and at constant 1990 prices (-16,7%) for January 1996 compared with December 1995.

NOTES

This statistical release shows final estimates of the wholesale trade sales in the Republic of South Africa (the former TBVC states are excluded before January 1995). The survey is conducted on a firm basis. The results of the sample survey are raised to represent the total wholesale trade sales. Both actual and seasonally adjusted values of wholesale trade sales according to type of business at current as well as constant 1990 prices are shown. The value of sales at constant 1990 prices in respect of each type of business is obtained by deflating the sales value at current prices by means of sub-indices of the production price index on base 1990 = 100.

Wholesale trade sales at current prices include VAT.

AFNAME IN SEISOENSAANGEPASTE REËLE GROOTHANDELVERKOPE VIR JANUARIE 1996

Die waarde van groothandelverkope (diamante uitgesluit) het R15 385,5 miljoen vir Januarie 1996 bedra, wat na seisoensaanpassing 'n geringe toename van 0,9% getoon het vergeleke met Desember 1995. In reële terme (teen konstante 1990-pryse) verteenwoordig dit egter 'n afname van 0,6%.

Die verkope van groothandelaars in "diverse" goedere wat die grootste markaandeel het, bedra R4 609,8 miljoen vir Januarie 1996, wat na seisoensaanpassing met 2,1% afgeneem het vergeleke met Desember 1995. In reële terme (teen konstante 1990-pryse) verteenwoordig dit 'n afname van 2,7%. Die seisoensangepaste verkope van groothandelaars in "tekstiele, klerasie en skoesele" het die grootste persentasie afname teen heersende pryse (-15,7%) en teen konstante 1990-pryse (-16,7%) vir Januarie 1996 vergeleke met Desember 1995 getoon.
