

GROOTHANDELAARS WAS ONNODIG PESSIMISTIES VIR NOVEMBER 1994

Die groothandelverkope (diamante uitgesluit) vir November 1994 is 5,0% hoër as die verwagte verkope vir November 1994 soos deur die groothandelaars in die vooruitsig gestel*.

Die finale waarde van groothandelverkope (diamante uitgesluit) vir November 1994 bedra R16 086,7 miljoen wat na seisoenaanpassing 0,9% hoër is as vir Oktober 1994. In reële terme verteenwoordig dit 'n toename van 0,5%. Die grootste toenames in reële verkope (teen konstante 1990-pryse) het voorgekom by groothandelaars in lewende hawe en landbouprodukte (9,1%) en groothandelaars in kantoor- en winkeltoerusting, boeke en skryfbehoeftes (8,4%). Hierdie toenames is in 'n groot mate teegewerk deur afnames in die verkope van groothandelaars in masjinerie en toerusting (-3,5%), groothandelaars in tekstiele, klerasie en skoeisel (-2,4%) en groothandelaars in diverse goedere (-0,5%).

Die gegewens in hierdie statistiese vrystelling sluit die voormalige Republieke van Transkei, Bophuthatswana, Venda en Ciskei uit. Gegewens van die voormalige Republieke sal vanaf die Januarie 1995-opname ingesluit word.

WHOLESALE TRADE SALES WERE UNNECESSARILY PESSIMISTIC FOR NOVEMBER 1994


The wholesale trade sales (excluding diamonds) for November 1994 are 5,0% higher than the expected sales for November 1994 as foreseen by the wholesalers*.

The final value of wholesale trade sales (excluding diamonds) for November 1994 amounts to R16 086,7 million, which after seasonal adjustment is 0,9% higher than for October 1994. In real terms this represents an increase of 0,5%. The largest increases in real sales (at constant 1990 prices) occurred in respect of wholesalers in livestock and agricultural produce (9,1%) and wholesalers in office and shop equipment, books and stationery (8,4%). These increases were to a large extent counteracted by decreases in the sales of wholesalers in machinery and equipment (-3,5%), wholesalers in textiles, clothing and footwear (-2,4%) and wholesalers in miscellaneous goods (-0,5%).


The data in this statistical release exclude the former Republics of Transkei, Bophuthatswana, Venda and Ciskei. Data of the former Republics will be included as from the January 1995 survey.

OPMERKINGS

Hierdie statistiese vrystelling toon finale rammings van die groothandelverkope (die voormalige Republieke van Transkei, Bophuthatswana, Venda en Ciskei uitgesluit). Die opname word op 'n firmabasis gedoen. Die resultate van die steekproefopname word verflik toon, die totale groothandelverkope te verteenwoordig. Beide die werklike en seisoensaangepaste waardes van groothandelverkope volgens soort besigheid teen heersende sowel as konstante 1990-pryse word getoon. Die waarde van verkope teen konstante 1990-pryse ten opsigte van elke soort besigheid is verkry deur die verkooptaarde teen heersende pryse met behulp van sub-indexe van die produksieprysindeks op basis 1990 = 100 te defleer.

Groothandelverkope teen heersende pryse sluit BTW in.

'n Voorlopige raming van totale groothandelverkope word in statistiese vrystelling P6141.1 gepubliseer.

NOTES

This statistical release shows final estimates of the wholesale trade sales (excluding the former Republics of Transkei, Bophuthatswana, Venda and Ciskei). The survey is conducted on a firm basis. The results of the sample survey are raised to represent the total wholesale trade sales. Both actual and seasonally adjusted values of wholesale trade sales according to kind of business at current as well as constant 1990 prices are shown. The value of sales at constant 1990 prices in respect of each kind of business is obtained by deflating the sales value at current prices by means of sub-indexes of the production price index on base 1990 = 100.

Wholesale trade sales at current prices include VAT.

A preliminary estimate of total wholesale trade sales is published in statistical release P6141.1.
