SKERP AFNAME IN GROOTHANDELVERKOPE VIR SEPTEMBER 1995

Die groothandelverkope (diamante uitgesluit) vir September 1995 is na seisoensaarpassing 3,3% laer as vir Augustus 1995.

Die grootste persentasie afname in seisoensaangepaste verkope het voorgekom by groothandelaars in tekstiele, klerasie en skoeisel (-17,2%). Ten spyte van hierdie skerp daling is verkope van hierdie groothandelaars vir die eerste nege maande van 1995 steeds 8,2% hoër as vir die ooreenstemmende tydperk van 1994.

Die waarde van groothandelverkope (diamante uitgesluit) vir September 1995 is slegs 0,4% hoër as die verwagte verkope vir September 1995 soos deur die groothandelaars in die vooruitsig gestel (kyk statistiese vrystelling P6141.1 van 8 November 1995).

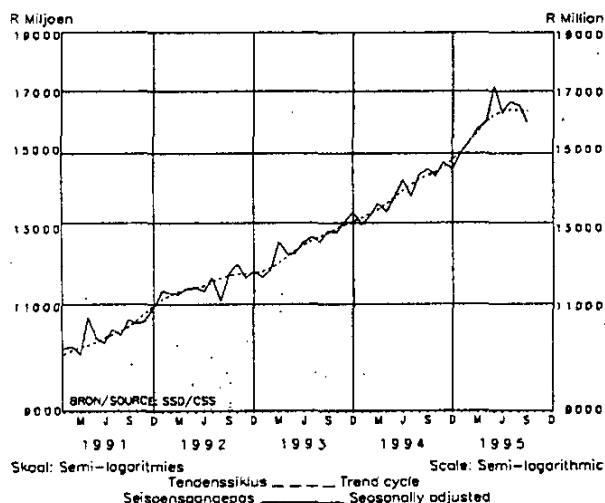
SHARP DECREASE IN WHOLESALE TRADE SALES FOR SEPTEMBER 1995

The wholesale trade sales (excluding diamonds) for September 1995 are 3,3% lower than for August 1995 after seasonal adjustment.

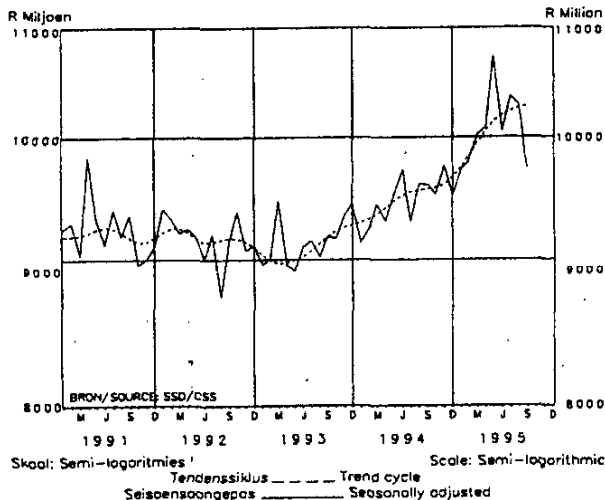
The largest percentage decrease in seasonally adjusted sales occurred at wholesalers in textiles, clothing and footwear (-17,2%). Despite this sharp decrease the sales for these wholesalers for the first nine months of 1995 are still 8,2% higher than for the corresponding period of 1994.

The value of wholesale trade sales (excluding diamonds) for September 1995 is only 0,4% higher than the expected sales for September 1995 as foreseen by the wholesalers (see statistical release P6141.1 of 8 November 1995).

OPMERKINGS

Hierdie statistiese vrystelling toon finale ramings van die groothandelverkope in die Republiek van Suid-Afrika (die voormalige TBVC-state is voor Januarie 1995 uitgesluit). Die opname word op 'n firmabasis gedoen. Die resultate van die steekproefopname word verhef om die totale groothandelverkope te verteenwoordig. Beide die werklike en seisoensaangepaste waardes van groothandelverkope volgens soort besigheid teen heersende sowel as konstante 1990-pryse word getoon. Die waarde van verkope teen konstante 1990-pryse ten opsigte van elke soort besigheid is verkry deur die verkoopwaarde teen heersende pryse met behulp van sub-indeks van die produksieprysindeks op basis 1990 = 100 te defleer.

Groothandelverkope teen heersende pryse sluit BTW in.

'n Voorlopige raming van totale groothandelverkope word in statistiese vrystelling P6141.1 gepubliseer.

NOTES

This statistical release shows final estimates of the wholesale trade sales in the Republic of South Africa (the former TBVC states are excluded before January 1995). The survey is conducted on a firm basis. The results of the sample survey are raised to represent the total wholesale trade sales. Both actual and seasonally adjusted values of wholesale trade sales according to type of business at current as well as constant 1990 prices are shown. The value of sales at constant 1990 prices in respect of each type of business is obtained by deflating the sales value at current prices by means of sub-indices of the production price index on base 1990 = 100.

Wholesale trade sales at current prices include VAT.

A preliminary estimate of total wholesale trade sales is published in statistical release P6141.1.
