

# Retail trade in motor vehicles and accessories

## December 2003

## Key findings regarding motor trading income for the year 2003

### Total motor trading income increases

*The total trading income of retailers in motor vehicles and accessories for the year 2003 increased by 14,1% compared with the same period in 2002.*

The increase of 14,1% was due to increases in income from the sales of used vehicles (+17,0%), 'other trading' income (+14,6%), the sales of new vehicles (+13,3%) and workshop income (+9,2%).


## Key findings regarding motor trading income for the month ended December 2003

### Total motor trading income increases

*The seasonally adjusted total trading income of retailers in motor vehicles and accessories for the last quarter of 2003 increased by 6,6% compared with the previous quarter. However, the seasonally adjusted total motor trading income for December 2003 decreased by 1,0% compared with November 2003.*

The increase of 6,6% in the seasonally adjusted total motor trading income for the last quarter of 2003 compared with the previous quarter was due to increases in the seasonally adjusted income from the sales of used vehicles (+8,8%), 'other trading' income (+6,5%), income from the sales of new vehicles (+5,8%) and workshop income (+4,6%).


## Key findings regarding the total number of vehicles sold during the year 2003

### Total number of vehicles sold increases

*The total number of vehicles sold during 2003 increased by 5,4% compared with the previous year.*

The increase of 5,4% in the total number of vehicles sold was due to increases of 7,8% and 3,0% respectively in the number of new vehicles and the number of used vehicles sold.

<b>Purpose of the survey</b>	<p>The retail trade in motor vehicles and accessories survey is a monthly survey covering a sample of private enterprises operating in the motor trade industry in South Africa. The results of the survey are used to compile estimates of the Gross Domestic Product (GDP) and its components, which are used to develop and monitor government policy. Furthermore, these statistics are also used by the private sector in analyses of comparative business and industry performance.</p>	
<b>New sample</b>	<p>According to international best practice and in order to train the relevant respondents in using the new questionnaire, to validate the information received and to avoid a break in the time series published in this statistical release, Stats SA decided to introduce the new questionnaire as the first step in the re-engineering process. Stats SA will in due course, as the second step, introduce a new sample.</p> <p>Currently Stats SA is busy re-engineering the register of businesses which serves as the sampling frame, in collaboration with the South African Revenue Service and the Departments of Trade and Industry and Labour.</p>	
<b>Response rate</b>	<p>The response rate for the survey of retail trade in motor vehicles and accessories for December 2003 was 78,4%.</p>

## Explanatory notes

- Introduction**
- 1 This publication contains results of the monthly survey of retail trade in motor vehicles and accessories. The survey is designed to obtain information regarding -
- income from the sales of new vehicles;
  - income from the sales of used vehicles;
  - workshop income;
  - other trading income;
  - cash and credit sale transactions of vehicles; and
  - the number of new and used vehicles sold.
- Scope of the survey**
- 2 The survey collects information from a sample of enterprises in South Africa that are predominantly involved in the retail trade in motor vehicles and accessories. These enterprises include -
- motor vehicle dealers, filling stations and workshops;
  - motor cycle dealers;
  - spares and accessories dealers;
  - retail tyre dealers;
  - automotive electricians;
  - radiator repairers;
  - panel beaters and spray painters;
  - other specialised motor repair services; and
  - other motor trade.
- Classification**
- 3 The 1993 edition of the Standard Industrial Classification of all Economic Activities (SIC), Fifth edition, Report No. 09-90-02, was used to classify the statistical units in the survey. The SIC is based on the 1990 *International Standard Industrial Classification for all Economic Activities (ISIC)* with suitable adaptations for local conditions. Statistics in this publication are presented at SIC subgroup (5 digit) level. Each statistical unit is classified to an industry that reflects the predominant activity of the enterprise.
- Statistical unit**
- 4 The statistical unit for collection of information is an enterprise. An enterprise is a legal or a combination of legal units that includes and directly controls all functions necessary to carry out its production activities. Data are only collected for those enterprises that are predominantly engaged in the retail trade in motor vehicles and accessories industry.
- Survey methodology and design**
- 5 All statistical units are stratified in the motor trade industry according to type of dealer and measure of size, where measure of size is the total motor trading income of the enterprise. All large enterprises are completely enumerated. For medium size enterprises and small enterprises, samples are drawn by systematically selecting enterprises with equal probability.
- 6 The data are collected by mail each month from a sample of approximately 420 motor trade enterprises from a population of approximately 14 000 motor trade enterprises. Questionnaires have to be returned to Stats SA within 10 days after the end of the reference month. Fax and telephone reminders are used to follow up non-respondents.

<b>Seasonal adjustment</b>	<b>7</b>	Seasonally adjusted estimates of retail trade in motor vehicles and accessories are generated each month, using the X-11 Seasonal Adjustment Program developed by US Bureau of the Census Economic Research and Analyses Division, 1968.
	<b>8</b>	Seasonal adjustment is a means of removing the estimated effects of normal seasonal variation from the series so that the effects of other influences on the series can be more clearly recognised. Seasonal adjustment does not aim to remove irregular or non-seasonal influences which may be present in any particular month. Influences that are volatile or unsystematic can still make it difficult to interpret the movement of the series even after adjustment for seasonal variations. Therefore, the month-to-month movements of seasonally adjusted estimates may not be reliable indicators of trend behaviour.
<b>Trend cycle</b>	<b>9</b>	The trend cycle is a long-term pattern or movement of a time series. The X-11 Seasonal Adjustment Program is used for smoothing seasonally adjusted data.
<b>Reliability of estimates</b>	<b>10</b>	Data presented in this publication are based on information obtained from a sample of enterprises and are, therefore, subject to sampling variability; that is, they may differ from the figures that would have been produced if the data had been obtained from all motor trade enterprises in South Africa.
	<b>11</b>	Inaccuracies may occur because of imperfections in reporting by enterprises and errors made in collection and processing of the data. Inaccuracies of this kind are referred to as non-sampling errors. Every effort is made to reduce non-sampling errors to a minimum by careful designing of the questionnaires, pilot studies, editing of data and efficient operating procedures.

## Glossary

<b>Enterprise</b>	An enterprise is a legal unit or a combination of legal units that includes and directly controls all functions necessary to carry out its production activities.
<b>Establishment (branch)</b>	An establishment (branch) is the smallest economic unit that functions as a separate entity. Each statistical unit is classified to an industry.
<b>Miscellaneous trading income</b>	Miscellaneous trading income includes the income from the sales of petrol, diesel oil and lubricants.
<b>Motor trading enterprise</b>	A motor trading enterprise is an enterprise deriving 50% or more of its income from the sales of goods relating to the motor industry.
<b>Other vehicles</b>	Other vehicles include caravans, trailers and tractors.
<b>Percentage change</b>	<p>When using monthly actual values, the percentage change is the change in actual values of the motor trading income of the relevant month compared with the actual values of the motor trading income of the same month in the previous year expressed as a percentage.</p> <p>When using annual actual values, the percentage change is the change in the actual values of motor trading income of the relevant year compared with the actual values of motor trading income of the previous year expressed as a percentage.</p> <p>When using seasonally adjusted values, the percentage change is the change in the seasonally adjusted values of the motor trading income of the relevant month compared with the seasonally adjusted values of the motor trading income of the previous month, expressed as a percentage.</p>
<b>Reference month</b>	Reference month for the survey means one calendar month.
<b>Total motor trading income</b>	Total motor trading income includes the income from the sales of new vehicles, the sales of used vehicles, income from the workshop and all other trading income.
<b>Workshop income</b>	Workshop income includes labour charges, as well as spares, accessories, fuels and lubricants transferred to the workshop.
