## Key findings as at the end of March 2010

### Total income for the accommodation industry

Total income for the accommodation industry for the first quarter of 2010 decreased by 0,3% compared with the first quarter of 2009. Total income for the accommodation industry in March 2010 increased by 1,6% compared with March 2009 (see Table A and Table 2, page 5).

### Income from accommodation

Income from accommodation for the first quarter of 2010 decreased by 0,9% compared with the first quarter of 2009. This decrease was mainly due to a decrease of 5,0% in the number of stay unit nights sold during the same period. Income from accommodation in March 2010 increased by 2,1% compared with March 2009 (see Table A and Table 2, page 5).

### Stay units available

The number of stay units available for the first quarter of 2010 increased by 2,4% compared with the first quarter of 2009. The number of stay units available in March 2010 increased by 2,5% compared with March 2009 (see Table A and Table 2, page 5).

### Stay unit nights sold

The number of stay unit nights sold for the first quarter of 2010 decreased by 5,0% compared with the first quarter of 2009. The number of stay unit nights sold in March 2010 decreased by 4,8% compared with March 2009 (see Table A and Table 2, page 5).

The main contributor to the decrease of 0,9% in the income from accommodation for the first quarter of 2010 compared with the first quarter of 2009 was hotels (-4,6% and contributing -3,1 percentage points). This decrease was, however, partially counteracted by an increase in other accommodation (12,4% and contributing 2,9 percentage points).

The main contributor to the increase of 2,1% in the income from accommodation in March 2010 compared with March 2009 was other accommodation (18,1% and contributing 4,2 percentage points). This increase was, however, partially counteracted by a decrease in hotels (-2,5% and contributing -1,7 percentage points).

## Explanatory notes

- Introduction** 1 The results presented in this publication are derived from the monthly survey of the tourist accommodation industry. This survey is based on a sample drawn from the 2009 Business Sampling Frame (BSF) that contains businesses registered for value added tax (VAT).
- Purpose of the survey** 2 The Tourist Accommodation Survey is a monthly survey covering a sample of public and private enterprises involved in the short-stay accommodation industry in South Africa.  
The results of the survey are used to compile estimates of the Tourism Satellite Accounts (TSA) and the gross domestic product (GDP) and its components, which are used to develop and monitor government policy. These statistics are also used in the analysis of comparative business and industry performance.
- Scope of the survey** 3 This survey covers the following **tax registered** private and public enterprises that are **mainly** engaged in providing short-stay commercial accommodation:
- Hotels, motels, botels and inns;
  - Caravan parks and camping sites;
  - Guest-houses and guest-farms; and
  - Other accommodation.
- Response rate** 4 The preliminary response rate for the Tourist Accommodation Survey for March 2010 was 95,9%. The improved response rate for February 2010 was 99,1%.
- Classification by industry** 5 The 1993 edition of the Standard Industrial Classification of all Economic Activities (SIC), Fifth Edition, Report No. 09-09-02, was used to classify the statistical units in the survey. The SIC is based on the 1990 International Standard Industrial Classification of all Economic Activities (ISIC) with suitable adaptations for local conditions. Each enterprise is classified to an industry, which reflects its predominant activity. Statistics in this publication are presented at 5-digit SIC level.
- Size groups** 6 The enterprises are divided into four size groups according to turnover. Large enterprises are enterprises with an annual turnover of R13 million and more. The Department of Trade and Industry (DTI) cut-off points defining the size groups, namely large, medium, small and micro enterprises, are given in Table D.

- Statistical unit** 7 The statistical units for the collection of the information are enterprises and establishments.
- Survey methodology and design** 8 The survey was conducted by mail, fax and telephone.  
The 2009 sample of approximately 902 enterprises was drawn using stratified simple random sampling. The enterprises were first stratified at 5-digit level according to the SIC and then by size of enterprises. All large enterprises are completely enumerated. Turnover was used as the measure of size for stratification.
- Weighting methodology** 9 For those strata not completely enumerated, the weights to produce estimates are the inverse ratio of the sampling fraction, modified to take account of non-response in the survey. Stratum estimates are calculated and then aggregated with the completely enumerated stratum to form subgroup estimates. These procedures, which are in line with international best practice, are described in more detail on the Stats SA website at: <http://www.statssa.gov.za/publications/publicationsearch.asp>.

**Relative standard error** 10 Data presented in this publication are based on information obtained from a sample and are, therefore, subject to sampling variability; that is, they may differ from the figures that would have been produced if the data had been obtained from all enterprises in the tourist accommodation industry in South Africa.

One measure of the likely difference is given by the standard error (SE), which indicates the extent to which an estimate might have varied by chance because only a sample of enterprises was used. The relative standard error (RSE) provides an immediate indication of the percentage errors likely to have occurred due to sampling, and thus avoids the need to refer to the size of the estimate.

**Non-sampling errors** 11 Inaccuracies may occur because of imperfections in reporting by enterprises and errors made in the collection and processing of the data. Inaccuracies of this kind are referred to as non-sampling errors. Every effort is made to minimise non-sampling errors by careful design of questionnaires, testing them in pilot studies, editing reported data and implementing efficient operating procedures. Non-sampling errors occur in both sample surveys and censuses.

**Revised figures** 12 Revised figures are due to respondents reporting revisions or corrections to their figures and late submission of their data to Stats SA. Preliminary figures are indicated in the relevant tables. Data are edited at the enterprise level.

**Seasonal adjustment** 13 Seasonally adjusted estimates will not be published until there are sufficient data points for the new survey. As soon as sufficient data points are available, Stats SA will consider publishing seasonally adjusted estimates.

**Comparability with discontinued Hotels' Trading Statistics** 15 The information in this statistical release and the discontinued monthly Hotels' Trading Statistics statistical release is not strictly comparable. The Hotels' Trading Statistics survey was conducted using a list of all hotels graded by the then South African Tourism Board (Satour) when the grading of hotels was still compulsory by law. This survey is conducted from a sample drawn from a new Business Register of all enterprises registered for value added tax (VAT) and income tax. The higher levels from this survey can be mainly attributed to the following:

- The coverage of all types of tourist accommodation enterprises including hotels; and
- The improved coverage of the new Business Register, especially of small and micro enterprises.

**Rounding-off of figures** 16 Where figures have been rounded off, discrepancies may occur between sums of the component items and the totals.



## Glossary

<b>Average income per stay unit night sold</b>	Average rate per stay unit (i.e. rate per room in a hotel or powered site in a caravan park) is calculated by dividing the total income from accommodation by the number of stay unit nights sold in the survey period.
<b>Enterprise</b>	An enterprise is a legal unit or combination of legal units that includes and directly controls all functions to carry out its activities.
<b>Establishment</b>	An enterprise or part of an enterprise that is situated in a single location and in which only a single (non-ancillary) productive activity is carried out or in which the principal productive activity accounts for most of the value added.
<b>Income from accommodation</b>	Income from amounts charged for stay units. Other income is excluded (e.g. income from meals).
<b>Income from restaurant and bar sales</b>	Income from meals, banqueting and beverages and tobacco sales.
<b>Industry</b>	Group of establishments engaged in the same or similar kinds of economic activity. Industries are defined in the System of National Accounts (SNA) in the same way as in the Standard Industrial Classification of all Economic Activities, Fifth Edition, Report No. 09-90-02 of January 1993 (SIC).
<b>Occupancy rate</b>	The number of stay unit nights sold, divided by the product of the number of stay units available and the number of days in the survey period, expressed as a percentage.
<b>Other accommodation</b>	Includes lodges, bed-and-breakfast establishments, self-catering establishments and other establishments not elsewhere classified.
<b>Stay unit</b>	The unit of accommodation available to be charged out to guests, for example, a powered site in a caravan park or a room in a hotel.
<b>Stay unit nights sold</b>	The total number of stay units occupied on each night during the survey period.
<b>Total income</b>	Includes income from accommodation, income from restaurant and bar sales and other income.
<b>Tourist</b>	A visitor who stays at least one night in the place visited.
