Total income for food and beverages decreases for October 2009

The total income generated by the food and beverages industry for October 2009 decreased by 0,9% compared with October 2008. The decrease was mainly due to a decrease in income from food sales (-0,9% and contributing -0,8 of a percentage point) (see Table B).

The main contributors to the decrease of 0,9% in total income for October 2009 compared with October 2008 were restaurants and coffee shops (-3,6% and contributing -2,0 percentage points) and other catering services (-22,8% and contributing -1,1 percentage points). However, these decreases were partly counteracted by an increase in income for takeaway and fast-food outlets (10,4% and contributing 2,3 percentage points) (see Table C, page 4).

Total income for food and beverages decreases marginally during the three months ended October 2009

The total income generated by the food and beverages industry for the three months ended October 2009 decreased by 0,6% compared with the three months ended October 2008. Decreases were reported for income from food sales (-0,8% and contributing -0,7 of a percentage point) and other income (-4,4% and contributing -0,1 of a percentage point). However, income from bar sales increased during the above-mentioned period (2,0% and contributing 0,2 of a percentage point) (see Table D).

The 0,6% decrease in total income for the three months ended October 2009 compared with the three months ended October 2008 was due to decreases in income reported by restaurants and coffee shops (-2,8% and contributing -1,6 percentage points), other catering services (-17,2% and contributing -0,8 of a percentage point) and caterers (-2,6% and contributing -0,4 of a percentage point). However, these decreases were counteracted by an increase in income reported by takeaway and fast-food outlets (10,0% and contributing 2,2 percentage points) (see Table E and Figure 1, page 5).



Explanatory notes

Introduction

The results presented in this publication are derived from the monthly survey of the food and beverages industry. This survey is based on a sample drawn from the 2009 Business Sampling Frame (BSF) that contains businesses registered for value added tax (VAT).

Purpose of the survey

The food and beverages survey is a monthly survey covering a sample of public and private enterprises involved in the preparation of meals and drinks for immediate consumption in South Africa. The purpose of this survey is to monitor trends in the food and beverages industry.

The results of the survey are used to compile estimates of the Tourism Satellite Accounts (TSA) and the Gross Domestic Product (GDP) and its components, which are used to develop and monitor government policy. These statistics are also used in the analysis of comparative business and industry performance. The results of this monthly survey are published monthly in this statistical release P6420: *Food and beverages*.

Scope of the survey

This survey covers the following **tax registered** private and public enterprises that are **mainly** engaged in providing food and beverages for immediate consumption:

- Restaurants and coffee shops;
- Takeaway and fast-food outlets;
- · Caterers; and
- Other catering services.

Response rate

The preliminary response rate for the 'Food and beverages' survey for October 2009 was 89,0%. The improved response rate for September 2009 was 94,0%.

Classification by industry

The 1993 edition of the Standard Industrial Classification of all Economic Activities (SIC), Fifth Edition, Report No. 09-09-02, was used to classify the statistical units in the survey. The SIC is based on the 1990 International Standard Industrial Classification of all Economic Activities (ISIC) with suitable adaptations for local conditions. Statistics in this publication are presented at 5-digit SIC level. Each enterprise is classified to an industry, which reflects its predominant activity.

Size groups

The enterprises are divided into four size groups according to turnover. Large enterprises are enterprises with an annual turnover of R13 million and more. The Department of Trade and Industry (DTI) cut-off points defining the size groups, namely large, medium, small and micro enterprises, are given in Table F.

Statistical unit

The statistical units for the collection of the information are enterprises.

Survey methodology and design

The survey was conducted by mail, fax and telephone.

A sample of approximately 900 enterprises was drawn using stratified simple random sampling. The enterprises were first stratified at 5-digit level according to the SIC and then by size of enterprises. Large enterprises are completely enumerated. Turnover was used as the measure of size.

Weighting methodology

For those strata not completely enumerated, the weights to produce estimates are the inverse ratio of the sampling fraction, modified to take account of non-response in the survey. Stratum estimates are calculated and then aggregated with the completely enumerated stratum to form subgroup estimates. Relative standard error

Data presented in this publication are based on information obtained from a sample and are, therefore, subject to sampling variability; that is, it may differ from the figures that would have been produced if the data had been obtained from all enterprises in the food and beverages industry in South Africa.

One measure of the likely difference is given by the standard error (SE), which indicates the extent to which an estimate might have varied by chance because only a sample of enterprises was used. The relative standard error (RSE) provides an immediate indication of the percentage errors likely to have occurred due to sampling, and thus avoids the need to refer to the size of the estimate.

Non-sampling errors

Inaccuracies may occur because of imperfections in reporting by enterprises and errors made in the collection and processing of the data. Inaccuracies of this kind are referred to as non-sampling errors. Every effort is made to minimise non-sampling errors by careful design of questionnaires, testing them in pilot studies, editing reported data and implementing efficient operating procedures. Non-sampling errors occur in both sample surveys and censuses.

Revised figures

Revised figures are due to respondents reporting revisions or corrections to their figures and late submission of their data to Stats SA. Preliminary figures are indicated in the relevant tables. Data are edited at the enterprise level.

Seasonal adjustment

Seasonally adjusted estimates will not be published until there are sufficient data points for the new survey. As soon as sufficient data points are available, Stats SA will consider publishing seasonally adjusted estimates.

Glossary

Enterprise A legal unit or a combination of legal units that includes and directly controls all

functions necessary to carry out its activities.

Income from bar sales Refers to income from liquor sales.

Income from food sales Refers to income from the sale of meals and non-alcoholic drinks.

Industry It is a group of enterprises engaged in the same or similar kinds of economic activity.

Industries are defined in the System of National Accounts (SNA) in the same way as in the Standard Industrial Classification of all Economic Activities, Fifth Edition; Report

No. 09-09-02 of January 1993 (SIC).

Other catering services Include bars, taverns, other drinking places, ice-cream parlours, etc.

Other income Includes all income not earned from food sales or bar sales.

Restaurants and coffee

shops

Enterprises involved in the sale and provision of meals and drinks, ordered from a menu, prepared on the premises for immediate consumption and with provided seating.

Total income Includes income from food sales, income from bar sales and other income.

Takeaway and fast-food

outlets

Enterprises involved in the sale and provision of meals and drinks, ordered from a menu, prepared on the premises for takeaway purposes in a packaged format (not on

plates), at a stand or in a location, with or without provided seating.

General information
