
TOTAL EXPENDITURE BY UNIVERSITIES AND TECHNIKONS AMOUNTED TO R20 244,0 MILLION IN 2003

Total expenditure by South African universities and technikons amounted to R20 244,0 million in the 2003 financial year (ending on 31 December 2003). This reflected an increase of 16,1% compared with the R17 440,1 million of the 2002 financial year. Universities spent R15 882,8 million (78,5%), while technikons spent R4 361,2 million (21,5%) of the total expenditure in 2003.

The largest contributor to the total expenditure of R20 244,0 million for 2003 was remuneration of employees (R10 229,8 million or 50,5% of total expenditure), followed by expenditure on other goods and services for current activities (R5 908,4 million or 29,2% of total expenditure), depreciation (R1 048,7 million or 5,2% of total expenditure), maintenance (R775,3 million or 3,8% of total expenditure), machinery and equipment (R731,7 million or 3,6% of total expenditure), new constructions (R593,7 million or 2,9% of total expenditure), current transfers to households (R332,5 million or 1,6% of total expenditure) and interest (R322,0 million or 1,6% of total expenditure), books (R270,4 million or 1,3% of total expenditure) and land and existing buildings (R31,5 million or 0,2% of total expenditure) (see Figure 1, p. 1 and Table 1, p. 4, columns 8 and 11).

Explanatory Notes

Introduction

1. This statistical release provides expenditure information of universities and technikons for the 2002 and 2003 financial years. The financial year of universities and technikons ends on 31 December of each year.

Methodology

3. Stats SA receives financial statements of universities and technikons annually from the Department of Education. Universities and technikons keep their accounts on an accrual basis in accordance with Generally Accepted Accounting Practice (GAAP), i.e. payments are recorded in the period to which the transactions relate and surpluses, deficits, assets and liabilities are carried over to the next financial year. Financial statements were received for all 35 institutions listed above. Missing or incomplete information was supplemented through telephonic liaison with the relevant universities and technikons as far as possible.

- 4. The tables contain only the consolidated information of all the accounts and funds of the universities and technikons. Stats SA does not receive separate information for hostels and trust funds, to exclude the information from the tables.
- 5. The expenditure on land and buildings by government departments (as a direct liability against their votes) on behalf of certain universities and technikons is not included in the tables.

Comparability with previous statistical release

6. Respondents are unable to provide adequate detail information regarding expenditure on research.

Maintenance of buildings and structures and machinery and equipment are shown as one item in this release whereas in the previous release it was subdivided between maintenance on buildings and structures and maintenance on machinery and equipment.

The former Vaal Triangle Technikon was transformed to the Vaal University of Technology as from 2003 and is therefore included under universities in this release for the 2003 financial year.

Classification

7. Economic classification

Glossary

Books This includes mainly library books.

Economic classification Economic classification is a measure of the nature and economic effect of

government operations on the economy of the country.

Households Households may be defined as individuals or a small group of persons who share

the same living accommodation.

Machinery and equipment Machinery and equipment are divided into vehicles, computer equipment,

furniture and other machinery and equipment.

Non-residential buildings Non-residential buildings include clinics, hospitals, offices and office blocks,

warehouses, laboratories, workshops and lecture halls.

Other constructions Other constructions include sport fields, roads and fences.

Other goods and services Other goods and services include purchases of all other goods and services,

except remuneration of employees, for current activities. In accordance with the recommendations of the 1993 System of National Accounts (SNA) these kinds of expenditure exclude capital expenditure relating to office, school, and

household furniture and equipment.

Remuneration of employees Remuneration of employees primarily includes salaries, wages, service and other

bonuses, allowances (including car allowances), retirement benefits, contributions to medical, insurance and pension funds, compensation in respect

of examinations and housing subsidies.

Residential buildings Residential buildings are buildings that are used entirely or primarily as

residences and include student houses, flats, hostels and nursing homes.

Subsidies Subsidies are current unrequited payments that general government pays to

enterprises on the basis of the quantities or values of the goods and services,

which they produce, sell or import.
