KEY FINDINGS

1. Historical trends: foreign travellers and South African residents

In the 1980s the trends in the numbers of arrivals and departures of foreign travellers were fairly similar in pattern. Figure 1 and Table 1.1 show that prior to 1986, the trend in the number of arrivals and departures remained reasonably steady at around 650 000 per annum. From 1986 to 1990, there was a gradual increase in the number of foreign travellers to South Africa (SA) and between 1990 and 1993, the rise was very steep. After 1993 the pace of increase in arrivals continued, but there was a marked lag between the number of arrivals and the number of departures. The numbers of arrivals and departures declined in 1997 and 2001. However, the volume of arrivals has steadily increased over the past five years *i.e.* since 2003. There was an increase of 38,7% from 6 640 095 in 2003 to 9 207 697 in 2007. The volume of departures grew by 34,7% from 5 955 199 in 2003 to 8 022 796 in 2007.

Figure 2 and Table 1.1 show the trend in arrivals and departures of SA residents from 1980 to 2007. In general, the volume of arrivals and departures was more or less the same. The sudden drop in the number of arrivals and departures of SA residents after 2002 was mainly due to the changes in the immigration acts regarding the recording of information on the international movements of South African residents. Act No.13 of 2002 resulted in information on arrival and departure of SA residents not being collected. Collection through the scanning of passports resumed after implementation of Act no.19 of 2004.

2. Foreign arrivals to South Africa in 2007

2.1 Distribution of foreign arrivals by region

A detailed description of the monthly distribution of foreign arrivals in 2007 by region is given in Table 2.1.3. The highest number (890 391) of foreign arrivals was recorded in the summer month of December while the lowest number (638 349) was recorded in the winter month of June.

Travellers to South Africa continue to be predominantly residents from the SADC countries. Thus out of the 9 207 697 foreign arrivals, 2 247 295 (24,4%) came from overseas countries; 6 745 795 (73,3%) from SADC countries; 75 858 (0,8%) from East and Central Africa; 69 057 (0,7%) from West Africa; 11 331 (0,1%) from North Africa and the country of residence of 58 361(0,6%) arrivals was not specified.

2.2 Mode of travel and ports of entry

Table 2.1.2 shows that during 2007, as many as 6 320 634 (68,6%) foreign travellers arrived in South Africa by road, followed by air arrivals of 2 500 964 (27,2%). In addition, 5 293 (0,1%) arrived by rail and sea whilst the mode of travel for 380 806 (4,1%) was not

specified. Of the 2 500 964 total number of foreign travellers arriving by air, 1 959 187 (78,3%) came through OR Tambo International Airport; 521 277 (20,8%) arrived through Cape Town International Airport; 5 581 (0,2%) came through Durban International Airport and 14 919 (0,6%) through other airports.

There were 1 965 162 air arrivals from overseas in 2007 which account for 87,4% of all overseas arrivals. The number of overseas travellers that arrived by road was 270 083 (12,0%) and those that came by sea and rail were 4 023 (0,2%). The mode of travel of 8 027 (0,4%) was not specified. The total number of travellers who arrived by road during 2007 from SADC countries was 6 005 304 (89,0%). The number arriving by air was 393 103 (5,8%) and those arriving by sea, and rail were 1 089 (0,01%). The mode of travel of 346 299 (5,1%) arrivals was not specified. For travellers arriving from 'other' African countries, 129 307 (82,8%) came in by air and 25 684 (16,4%) by road. Whereas 38 came in by rail and sea, the mode of travel of 1 217 (0,8%) was not specified.

2.3 Country of residence

As presented in Figure 3a and Table 2.1.3 the leading countries for overseas arrivals in 2007 were: the UK, 506 481 (22,5%); the USA, 282 062 (12,6%); Germany, 259 856 (11,6%); the Netherlands, 130 878 (5,8%); France, 118 175 (5,3%); Australia, 96 690 (4,3%); India, 57 999 (2,6%) and Italy, 55 459 (2,5%).

Figure 3b and Table 2.1.3 indicate that the leading countries for arrivals from SADC countries were: Lesotho, 2 171 954 (32,2%); Mozambique, 1 085 556 (16,1%); Swaziland, 1 041 235 (15,4%); Zimbabwe, 977 101 (14,5%); Botswana, 821 070 (12,2%) Namibia, 221 360 (3,3%); Zambia, 184 358 (2,7%) and Malawi 148 061(2,2%).

Figure 3c and Table 2.1.3 show that Nigeria, 41 827 (26,8%); Kenya, 27 643 (17,7%); Ghana, 13 953 (8,9%); Uganda, 12 728, (8,1%); Ethiopia, 8 736 (5,6%) Congo, 6 511 (4,2%); Cameroon 5 088 (3,3%) and 4 671 Egypt (3,0%) were the leading source countries for arrivals from other African countries.

2.4 Purpose of travel

An overwhelming majority, 8 571 506 (93,1%) of foreign arrivals in 2007 was admitted into the country on visitor's temporary resident permit (see Table 2.1.1). Hence, very few travellers came to South Africa for business 197 437 (2,1%); work 116 817 (1,3%) and studies 112 339 (1,2%).

Figure 4 shows that, 2 072 924 (92,2%) of the overseas arrivals reported that they were in South Africa on holiday, while 76 215 (3,4%); 71 777 (3,2%) and 14 841 (0,7%) had come for business, to work and to study respectively.

For arrivals from SADC countries 6 358 905 (94,3%) reported that they were in South Africa on holiday, while 108 816 (1,6%); 26 633 (0,4%) and 80 557 (1,2%) had come for business, to work and to study respectively.

Unlike arrivals from overseas and SADC countries, relatively fewer arrivals from 'other' African countries came to South Africa for holidays 125 640 (80,4%). Rather, a higher proportion of arrivals from 'other' African countries had come for business 11 833 (7,6%); to work 9 032 (5,8%) and to study 7 754 (5,0%).

Data in Table 2.1.5 and Figures 5, 6, 7 and 8 series reveal that the majority of overseas arrivals on holiday (23,0%); business persons (22,5%) and workers (12,0%) were UK residents. However, the highest proportion of overseas students (17,2%) came from USA. Arrivals from SADC countries were more diverse. Persons on holiday (31,5%) were predominantly Lesotho residents. Whereas the majority of students (27,8%) were Botswana residents; the business persons (21,4%) and workers (49,1%) were mainly Zimbabwe residents. Nigeria residents predominated among arrivals from 'other' African countries in all four categories holiday (27,3%); business (22,4%); work (25,6%) and study (28,7%).

3. South African residents in 2007

The mode of travel used by South African residents was quite similar to that of foreign travellers. Table 2.2.1 indicates that during 2007, as many as 2 628 306 (59,1%) South African residents arrived in South Africa by road, followed by 1 754 525 (39,4%) air arrivals. A total of 66 001 (1,5%) arrived by sea, rail and unspecified mode of travel. Of the total number of South Africa residents arriving by air, 1 490 427 (84,9%) arrived through OR Tambo International Airport, while 210 256 (12,0%) arrived through Cape Town International Airport; 13 803 (0,8%) arrived through Durban International Airport and 40 039 (2,3%) came in through other airports.

Similarly, road, 2 601 978 (58,7%), was the most common mode of travel used by South African residents departing South Africa (see Table 3.2.1). This was followed by air travel, 1 781 677 (40,2%). A total of 49 837(1,1%) left by sea, rail and unspecified mode of transport. Of the total number of residents departing by air, (85,1%) used OR Tambo International Airport, while 210 629 (11,8%) left through Cape Town International Airport; 14 807 (0,8%) through Durban International Airport and 40 030 (2,2%) through other airports.

EXPLANATORY NOTES

1. Introduction

This annual report contains information on population movements into and out of South Africa for the year 2004. It reports on arrivals and departures of South African and foreign travellers. Travellers include (a) same-day visitors and tourists and (b) other travellers such as migrant workers, business persons and students.

Legal movements across South African borders as well as legal immigration into South Africa fall under the jurisdiction of the Department of Home Affairs (DHA). Statistics South Africa (Stats SA) then processes and publishes this information.

Administrative data sources from the DHA, that is, information from all the country's ports of entry and applications for permanent residence constitute the only comprehensive source of information on foreign arrivals and departures, documented immigrants and emigrants. The information from this source of data provides the best national coverage (in terms of both space and time) of the population movements of South African residents and foreign travellers. The data:

- can be used to estimate, monitor and understand salient characteristics of foreign travellers and volumes of South African residents travelling outside South Africa;
- can, in the absence of information on foreign tourists, be further analysed to provide some indication of international tourism; and
- provide information that can be used to (a) assess the extent of government's progress in strengthening bilateral political and economic relations by assessing the number of international tourist arrivals; and (b) benchmark surveys focusing on demand for local tourism services by foreign travellers.

2. Data

Data routinely collected by immigration officers at all land, air and sea entry ports on all travellers (South African residents and foreign travellers) arriving into or departing from South Africa are captured into the DHA's population Movement Control System (MCS). Generally the data are collected directly from travel documents either by scanning or capturing onto the port's electronic database. Individual ports regularly transmit data onto the national database at the head office of the DHA. Statistics South Africa (Stats SA) downloads the data covering a particular calendar month from the mainframe of the State Information Technology Agency (SITA), where the DHA stores its data.

3. Definitions

3.1 Definitions used by the United Nations World Tourism Organisation (UNWTO)

International traveller refers to any person on a trip between two or more localities in different countries.

Tourism comprises the activities of persons travelling to, and staying in places outside their usual environment, for not more than one consecutive year, for leisure, business and other purposes. The usual environment of a person consists of a certain area around his/her place of residence, plus all other places he/she frequently visits.

Tourist (overnight visitor) is a visitor who stays at least one night in collective or private accommodation in the place.

Traveller refers to any person on a trip between two or more localities (e.g. Countries).

Visitor refers to any person travelling to a place other than that of his/her usual environment for less than 12 consecutive months and whose main purpose of trip is not the exercise of an activity remunerated visited. An international tourist is an international visitor who stays at least one night in collective or private accommodation in the country visited. Domestic tourist refers to a domestic visitor who stays at least one night in collective or private accommodation in the place visited.

2.2 Definitions used specifically in this report

Africa refers to all the countries in Africa (both mainland and island countries).

Country refers to individual countries within a region. Note that not all the lists of countries available in the data are reported in the release owing to the few monthly arrivals from those countries. Data on these countries will be made available to individuals on request.

Foreign traveller refers to a traveller who is not a South African citizen or permanent resident.

'Other' African countries refers to all African non-SADC member countries.

Overseas refers to all other countries outside Africa.

Region refers to the following country classification: Europe, North America, Central and South America, Australasia, the Middle East, Asia, SADC, East and Central Africa, West Africa and North Africa.

SADC refers to the thirteen countries, excluding South Africa, that belong to the Southern African Development Community.

South African resident refers to either a South African citizen or a non-South African citizen with a South African permanent residence permit.

5. Limitations

The main limitation of the published information is its inability to directly measure the volume of tourists. The main aspects of the United Nations World Tourism Organisation's (UNWTO) definition of a tourist are duration of stay and whether individuals are remunerated in the place being visited. Although the intended duration of stay can be inferred from the expiry date of the temporary residence permit, this does not necessarily translate into actual duration of stay. In addition, the data do not provide information on the remuneration status of travellers in South Africa.

The information on the total number of arrivals and departures of South African residents is collected from the scanning of passports. However, data on country of final destination and purpose of visit will be available when the re-introduction of the departure forms is in full operational at the three international airports (OR Tambo, Cape Town and Durban). Processing of available departure forms from the three international airports is currently underway.

6. Related publications

Tourism statistics are also published in the quarterly *Bulletin of Statistics* and in the monthly Statistical Release P0351: *Tourism and Migration*.


Fig. 1: Arrival and departure of foreign travellers, SA, 1980 - 2007


Fig. 2: Arrival and departure of South African residents, 1980 - 2007











Fig.3a: Arrivals from eight leading overseas countries, 2007**Fig. 3b: Arrivals from eight leading SADC countries, 2007****Fig. 3c: Arrivals from eight leading 'Other' African countries, 2007****Fig. 4: Arrivals from all regions by purpose of visit, 2007**

2007**




Fig. 7b: Percentage distribution of arrivals from SADC countries to study, 2007




Fig. 7c: Percentage distribution of arrivals from 'Other' African countries to study, 2007




Fig. 8a: Percentage distribution of arrivals from overseas countries to work 2007




Fig. 8b: Percentage distribution of arrivals from SADC countries to work, 2007





Fig. 8c: Percentage distribution of arrivals from 'Other' African countries to work, 2007
