MANUFACTURING INDUSTRY 2005

1. Introduction

This publication updates Statistical Release P3002 'Manufacturing Industry 2005'. The financial information has been revised following the re-classification of some enterprises. The Statistical Release was published at a 2-digit SIC level only and the Report is published at a 3-digit SIC level. Further financial tables have been added (details of sales and purchases, opening inventory, closing inventory).

Estimates are presented in respect of the 2005 manufacturing large sample survey (LSS). The 2005 manufacturing LSS collected data from a sample of approximately 9 531 enterprises drawn from a sampling frame of approximately 45 114, which were operating between 1 July 2004 and 30 June 2005. The sample was stratified in such a way that all large enterprises (with an annual income exceeding R51 million) were included. The data for the number of employees were provided for the last pay period ended on or before 30 June 2005. Data were collected at the 3-digit SIC level of classification of enterprise.

The statistical unit for the collection of information is an enterprise. An enterprise is a legal unit (or a combination of legal units) that includes and directly controls all functions necessary to carry out its production activities. Each industry is classified to an industry that reflects its predominant activity. The estimates are presently published only at national level.

The last survey of manufacturing, namely 'Large sample survey of the manufacturing industry 2001', was conducted for the year 2001.

1.1 Scope and coverage

The boundaries of manufacturing and the other sectors of the classification system can be somewhat ambiguous. As a general rule, the units in the manufacturing sector are engaged in the transformation of materials into new products. Their output is a new product.

The 2005 manufacturing large sample survey covers enterprises registered in the taxation system that are mainly engaged in:

- ➤ Food products and beverages (SIC30)
- > Textiles, clothing, leather and footwear (SIC31)
- Wood and wood products, paper, publishing and printing (SIC32)
- Petroleum, chemical products, rubber and plastic products (SIC33)
- ➤ Glass and non-metallic mineral products (SIC34)
- > Basic iron and steel, precious and non-ferrous metal products, fabricated metal products and machinery (SIC35)
- > Electrical machinery and apparatus (SIC36)
- > Radio, television and communication apparatus and professional equipment (SIC37)
- Motor vehicles, parts and accessories and other transport equipment (SIC38)
- Furniture and other manufacturing divisions (SIC39)

Conversely, there are activities that are sometimes considered manufacturing, but which for SIC are classified in another major division (i.e. not classified as manufacturing). They include:

- o the slaughtering of poultry undertaken in conjunction with farming (when done for own account or broiler production); logging and cutting operations to produce raw products mainly within the forest, classified in major division 1 (Agriculture, Hunting and Forestry);
- o beneficiating and other preparations of crude ores and other minerals, classified in major division 2 (Mining);
- o construction of not self produced prefabricated structures at the site of construction, classified in major division 5 (Construction);

- o activities of breaking bulk and redistribution in smaller lots; the customised assembly/installation of computers by wholesale or retail traders (if income for assembly is not significant and not separately reported, else it will be treated as two separate activities, of which the assembly will be classified as a manufacturing activity); the installation of floor coverings (carpets, rugs, mats) by the wholesaler as part of sales (not by a construction contractor), classified in the appropriate subgroup of major division 6 (Wholesale or Retail Trade);
- o sorting of scrap; mixing paints and cutting metals to customer order by wholesale or retail traders, classified in major division 6 (Wholesale or Retail Trade).

1.2 Data items

The following categories of data items were collected: industrial classification, details of employment, trading income, expenditure, profit or loss, inventories, book value of assets and products manufactured.

1.3 Reference period

The questionnaires were completed for the financial year of the enterprise which ends on any date between 1 July 2004 and 30 June 2005, according to the usual reporting schedule of the enterprise.

Example

- 1 October 2003 30 September 2004
- 1 January 2004 31 December 2004
- 1 February 2004 31 January 2005
- 1 March 2004 28 February 2005
- 1 April 2004 31 March 2005

1.4 Current prices

The rand values are at current prices.

1.5 Reliability of data

All estimates compiled for this survey are subject to both sampling and non-sampling errors.

The estimates presented in this publication are subject to sampling variability since they are based on information obtained from a sample. That is, they may differ from the figures that would have been produced if the data had been obtained from all enterprises in the manufacturing industry in South Africa.

One measure of the likely difference is given by the standard error (SE), which indicates the extent to which an estimate might have varied by chance because only a sample of enterprises was used. The relative standard error (RSE) provides an immediate indication of the percentage errors likely to have occurred due to sampling, and thus avoids the need to refer to the size of the estimate. Therefore, the larger the RSE, the less reliable the estimate.

Following are some of the likely sources of non-sampling errors: sampling frame not up-to-date, wrong definitions and classification, phrasing of questions, non-response, processing and estimation. Every effort is made to minimise non-sampling errors by careful design of questionnaires, testing them in pilot studies, editing reported data and implementing efficient operating procedures. Non-sampling errors occur in both sample surveys and censuses.

1.6 Confidentiality

According to Section 17 of the Statistics Act, 1999 (Act No. 6 of 1999), completed questionnaires remain confidential to Statistics South Africa (Stats SA). Individual business information is never disclosed. Results are presented in aggregated form only.

1.7 Related publications

Stats SA conducts a monthly survey on manufacturing industry. That survey is used to calculate indices of the physical volume of manufacturing production. These are in turn used to monitor the state of the economy.

Estimates for the principal financial statistics in manufacturing, wholesale and retail industries for 2005 were originally published in October 2006 (P3001 – Manufacturing industry 2005, P6101 – Wholesale trade industry 2005 and P6201 – Retail trade industry 2005). The estimates for total income were: Manufacturing R926 513 million, wholesale R537 516 million and retail R312 263 million, with a total of R1 776 292 million (Table A).

Analysis of products and commodities within these industries led to the reclassification of some enterprises and the consequent revision of the estimates. The revised estimates are: manufacturing R953 916 million, wholesale R530 868 million and retail R304 360 million, with a total of R1 789 144 million. Most reclassifications took place between manufacturing, wholesale and retail, but the net gain in total income reflects the reclassification to manufacturing of some enterprises outside the wholesale and retail trade industry.

2. Background to the programme of large sample surveys

The large sample surveys serve to document comprehensively the nature and structure of all industries within the economy.

Previously, Stats SA periodically conducted industry censuses i.e. collections covering all entities known to be mainly engaged in particular sectors. The last industry 'census' conducted for the manufacturing sector was in 1996. Since then, Stats SA has replaced industry censuses with periodic 'large sample surveys' of industry sectors. These surveys are based on larger samples than the sub-annual and annual surveys. They are not an attempt to completely enumerate all entities within the industry scope of the surveys, but are based on stratified random samples which are representative of the survey population.

2.1 Purpose and uses of large sample surveys

The large sample survey results are used in constructing and refreshing supply/use tables, and for benchmarking the Gross Domestic Product (GDP) and its components, as well as production and price indices and annual and short-term statistical series.

Users of the large sample surveys programme include:

- Prices statisticians, particularly in refreshing the commodity basket of producer price indices.
- Policy advisers in government for monitoring the performance of industries and their contribution to the South African economy and evaluating the effectiveness of industry policies.
- Industry associations monitoring trends in their own and competing or complementary industries in order to inform their members of market changes.
- Individual businesses using the data to analyse their performance relative to their industry.

2.2 Scope and coverage

This programme of large sample surveys covers enterprises registered in the taxation system (VAT and income tax) that are mainly engaged in the following industries, as defined in the Standard Industrial Classification of all Economic activities (SIC):

- Mining and quarrying
- Manufacturing
- Electricity, gas and water supply
- Construction
- Wholesale and retail trade, repair of motor vehicles, motor cycles, personal and household goods, and hotels and restaurants
- Transport, storage and communication
- Financial intermediation, insurance, real estate and business services
- Community, social and personal services (except national, provincial and local government activities)

Note: The agriculture, forestry, fishing, hunting and related services industry (SIC 1) is not included as it is covered by a separate programme within Stats SA. Similarly, the public administration and defence activities industry (SIC 92), the financial intermediation (SIC 81) and insurance and pension funding (SIC 82) are covered by other programmes within both Stats SA and elsewhere (e.g. the South African Reserve Bank (SARB)).


The largest average annual percentage change in value added occurred in the period 1993–1996 (14,1%), followed by 1996–2001 (11,8%), and 2001–2005 (7,9%). The largest average annual percentage change in output occurred in the period 1993–1996 (14,3%), followed by 1996–2001 (12,6%), 2001–2005 (10,8%), and 1991–1993 (5,9%).

4. Summary of findings for the year 2005


4.1 Income

4.1.1 Total income by type of manufacturing




In 2005, the total income in the manufacturing industry was R953 916 million (Figure 1). The three largest types of manufacturing contributed 60,4% of the total income: These were 'Division 33 – Coke, petroleum, chemical products, rubber and plastic' (R228 046 million or 23,9%), 'Division 35 – Basic metals, fabricated metal products and machinery' (R190 091 million or 19,9%), and 'Division 30 – Food products and beverages' (R158 690 million or 16,6%).


4.1.2 Sales of goods by type of manufacturing



Income from sales of goods contributed R834 419 million, or 87,5% of the total income in manufacturing industry (Figure 2), where 'Division 33 – Coke, petroleum, chemical products, rubber and plastic', 'Division 35 – Basic metals, fabricated metal products and machinery' and 'Division 30 – Food products and beverages' were the major contributors to income from sales of goods.


4.1.3 Income from services rendered and interest received






In 2005, 39,9% (or R29 131 million) of income from services rendered was earned by manufacturing in 'Division 33 – Coke, petroleum, chemical products, rubber and plastic' (Figure 3). Also 27,4% (or R1 881 million) of income from interest received was earned by the same type of retailers (Figure 4).

4.1.4 Income by enterprise size




Analysis of income by enterprise size indicates that the large enterprises (those with a Business Register (BR) turnover greater than R51 million) earned 81,2% (or R776 153 million) of the total income of the manufacturing industry. Large and medium enterprises combined contributed 90,7% to the total income (Figure 5).



The large enterprises are particularly dominant among 'Division 38 – Transport equipment', 'Division 30 – Food products and beverages', and 'Division 33 – Coke, petroleum, chemical products, rubber and plastic' (Figure 6).

4.2 Expenditure


4.2.1 Total expenditure



In 2005, the total expenditure in the manufacturing industry was R876 487 million. The largest contributor to total expenditure was 'Division 33 – Coke, petroleum, chemical products, rubber and plastic' (R206 216 million or 23,5%), followed by 'Division 35 – Basic metals, fabricated metal products and machinery' (R172 661 million or 19,7%), and 'Division 30 – Food products and beverages' (R147 756 million or 16,9%) (Figure 7).



4.2.2 Salaries and wages




Salaries and wages paid to employees in the manufacturing industry for 2005 amounted to R113 713 million. Employees in 'Division 35 – Basic metals, fabricated metal products and machinery' accounted for the largest proportion of salaries and wages paid (R27 191 million or 23,9%), followed by 'Division 33 – Coke, petroleum, chemical products, rubber and plastic' (R19 352 million or 17,0%), and 'Division 30 – Food products and beverages' (R17 431 million or 15,3%) (Figure 8).

4.2.3 Composition of expenditure



Purchases accounted for 59,8% (R523 850 million) of the total expenditure, followed by salaries and wages with 13,0% (R113 713 million) and depreciation with 2,9% (R25 022 million) (Figure 9).

4.3 Net profit before tax



Net profit before tax is computed as income plus closing stocks minus expenditure minus opening stocks. For the year 2005, net profit before tax in the manufacturing industry was R89 013 million. The largest contributor to net profit before tax was 'Division 33 – Coke, petroleum, chemical products, rubber and plastic' (R24 052 million or 27,0%), followed by 'Division 35 – Basic metals, fabricated metal products and machinery' (R20 633 million or 23,2%), and 'Division 30 – Food products and beverages' (R12 083 million or 13,6%) (Figure 10).


4.4 Profit margin

In 2005, the profit margin (net profit after tax as a percentage of turnover) in the manufacturing industry was 7,0%. 'Division 34 – Glass and other non-metallic mineral products' had the highest profit margin (11,6%), followed by 'Division 32 – Wood and wood products, paper, publishing and printing' (10,3%), and 'Division 35 – Basic metals, fabricated metal products and machinery' (8,0%).



4.5 Employment




At the end of June 2005, the total number of persons employed in the manufacturing industry was 1 435 828. The largest number was employed by 'Division 35 – Basic metals, fabricated metal products and machinery' (283 587 or 19,8%), followed by 'Division 30 – Food products and beverages' (282 422 or 19,7%), and 'Division 31 – Textiles, clothing, leather and footwear' (204 143 or 14,2%) (Figure 11).

4.5.1 Employment by enterprise size




Large enterprises employed 753 867 people (or 52,5%), followed by micro enterprises (those with a BF turnover less than R5 million) (20,1% or 288 575), medium enterprises (those with a BF turnover between R13 million and R51 million) (16,6% or 237 954) and small enterprises (those with a BF turnover between R5 million and R13 million) (10,8% or 155 432) (Figure 12).




Employment in the large enterprises is dominated by 'Division 30 – Food products and beverages' with 228 485 employees, followed by 'Division 35 – Basic metals, fabricated metal products and machinery' with 109 741 employees, and 'Division 33 – Coke, petroleum, chemical products, rubber and plastic' with 94 126 employees (Figure 13).

4.5.2 Employment by gender



Females comprised 30,6% of employees in the manufacturing industry, ranging from 14,1% in 'Division 38 – Transport equipment' to 68,4% in 'Division 31 – Textiles, clothing, leather and footwear' (Figure 14).

4.6 Capital expenditure on new assets and book value of fixed assets



In 2005, the capital expenditure on new assets in the manufacturing industry was R41 263 million. The largest contributor to capital expenditure on new assets was 'Division 33 – Coke, petroleum, chemical products, rubber and plastic' (R13 635 million or 33,0%), followed by 'Division 30 – Food products and beverages' (R9 607 million or 23,3%), and 'Division 38 – Transport equipment' (R5 391 million or 13,1%) (Figure 15).

Explanatory notes

Background

The results presented in this publication have been derived from the 2005 manufacturing large sample survey. This is a periodic survey, which measures economic activity in the manufacturing industry of the South African economy. This survey is based on a sample of private and public enterprises operating in the manufacturing industry.

The sample was drawn from the new business register. The new business register is based mainly on the income tax (IT) and value-added tax (VAT) databases. All enterprises are legally bound to register for either VAT or IT or both. Enterprises registered in the taxation system are included on the business register, and hence, were given a chance of selection in the sample for the survey. The published survey estimates are exclusive of VAT.

The last survey of the manufacturing industry, namely 'Large sample survey of the manufacturing industry 2001' was conducted for the year 2001.

Value added tax (VAT) Reference period

All figures exclude Value added tax (VAT).

The information was collected from enterprises for their financial year, which ended on any date between 1 July 2004 and 30 June 2005.

Purpose of the survey

The results of the survey are used within Stats SA for compiling the Gross Domestic Product (GDP) and its components. These statistics are also used by government policy advisers in monitoring the performance and contribution of individual industries to the South African economy and the effectiveness of industry policies, and by private sector users in the analyses of comparative business and industry performance.

Scope and coverage

This survey covers the following income tax registered private and public enterprises that are mainly engaged in manufacturing:

- (i) Food products and beverages
- (ii) Textiles, clothing, leather and footwear
- (iii) Wood and wood products, paper, publishing and printing
- (iv) Petroleum, chemical products, rubber and plastic products
- (v) Glass and non-metallic mineral products
- (vi) Basic iron and steel, non-ferrous metal products, metal products and machinery
- (vii) Electrical machinery and apparatus
- (viii) Radio, television and communication apparatus and professional equipment
- (ix) Motor vehicles, parts and accessories and other transport equipment
- (x) Furniture and other manufacturing divisions

Classification by industry

The 1993 edition of the *Standard Industrial Classification of all Economic Activities* (SIC), Fifth Edition, Report No. 09-09-02, was used to classify the statistical units in the survey. The SIC is based on the 1990 *International Standard Industrial Classification of all Economic Activities* (ISIC) with suitable adaptations for local conditions. Statistics in this publication are presented at SIC division (3-digit) level. Each enterprise is classified to an industry, which reflects its predominant activity.

Statistical unit

The statistical unit for the collection of the information is an enterprise. An enterprise is a legal unit (or a combination of legal units) that includes and directly controls all functions necessary to carry out its production activities.

Size groups

The enterprises are divided into four size groups, according to the value of turnover recorded for them on the Stats SA business register. Large enterprises are those with an annual recorded turnover of R51 million and more. Table C presents the size groups defined using the Department of Trade and Industry (DTI) cut-off points.

Survey methodology and design

The survey was conducted by post, e-mail, fax, telephone and personal visits.

A sample of approximately 9 500 enterprises was drawn using stratified simple random sampling. The enterprises were first stratified at 3-digit level according to the SIC, and then by size of enterprises. All large enterprises are completely enumerated. Turnover as recorded on the business register was used as the measure of size for stratification.

Weighting methodology

For those strata not completely enumerated, the weights to produce estimates are the inverse ratio of the sampling fraction, modified to take account of non-response in the survey. Stratum estimates are calculated and then aggregated with the completely enumerated stratum to form division estimates. These procedures, which are in line with international best practice, are described in more detail on the Stats SA website at www.statssa.gov.za/publications/publicationsearch.asp.

Relative standard error

Data presented in this publication are based on information obtained from a sample and are, therefore, subject to sampling variability; that is, they may differ from the figures that would have been produced if the data had been obtained from all enterprises in the manufacturing industry in South Africa.

One measure of the likely difference is given by the standard error (SE), which indicates the extent to which an estimate might have varied by chance because only a sample of enterprises was used. The relative standard error (RSE) provides an immediate indication of the percentage errors likely to have occurred due to sampling, and thus avoids the need to refer to the size of the estimate.

Non-sampling errors

Inaccuracies may occur because of imperfections in reporting by enterprises and errors made in the collection and processing of the data. Inaccuracies of this kind are referred to as non-sampling errors. Every effort is made to minimise non-sampling errors by careful design of questionnaires, testing them in pilot studies, editing reported data and implementing efficient operating procedures. Non-sampling errors occur in both sample surveys and censuses.

Comparability with previously published information

The information in this publication and previous manufacturing surveys is not strictly comparable. This large sample survey was conducted from a sample drawn from a new business register of **all** enterprises registered for either VAT or IT (or both). The new register has better coverage of the small and micro enterprises.

Rounding-off of figures

The figures in the tables have, where necessary, been rounded off to the nearest final digit shown. There may therefore be slight discrepancies between the sums of the constituent items of the totals shown.

Glossary

Concentration ratio

Concentration ratios in the manufacturing industry measure the scarcity or lack of enterprises and the inequality in size of enterprises in a manufacturing subgroup or division regarding selected variables.

Employees

Those people employed by the business or organisation who received payment (in salaries, wages, commission, piece rates or payments in kind) for the last pay period ended on or before 30 June 2005.

Enterprise

A legal entity or a combination of legal units that includes and directly controls all functions necessary to carry out its production activities.

Industry

Is made up of enterprises engaged in the same or similar kinds of economic activity. Industries are defined in the System of National Accounts (SNA) in the same way as in the Standard Industrial Classification of all Economic Activities, Fifth Edition, Report No. 09-90-02 of January 1993 (SIC).

Intermediate consumption

Intermediate consumption includes:

- Purchases raw materials, fuel, gas and materials used for maintenance
- Accommodation expenditure
- Advertising expenditure
- Bank charges
- Containers and packaging materials
- Entertainment expenditure
- Insurance premiums
- · Motor vehicle running expenditure
- Leasing and hiring of plant, machinery, equipment and vehicles
- Paper expenditure
- Postal and courier services
- Printing expenditure
- Railage and transport-out
- Rental of land, buildings, other structures

Net profit or loss after tax

Net profit or loss after tax is derived as:

Total income **plus** Closing stocks **minus** Total expenditure **minus** Opening stocks **minus** Company tax

- Repair and maintenance expenditure
- Research and development
- Royalties, franchise fees, copyright, trade names and patent rights paid
- Security services
- Staff training
- Stationery expenditure
- Sub-contractors paid
- Telecommunication services
- Travelling expenditure
- Water and electricity services (excluding property taxes)
- Other expenditure
- Changes in inventories: Raw materials, materials for processing, packaging materials, fuel consumables and maintenance stores e.g. spares

Net profit or loss before tax

Net profit or loss before tax is derived as:

Total income **plus** Closing stocks **minus** Total expenditure **minus** Opening stocks

Output

Is the aggregate value of goods manufactured and work done, and includes:

- Sales of goods
- Income of services rendered
- Changes in inventories: Work in progress and finished goods
- Income from rental and leasing of land, buildings and other structures
- Income from operating, leasing and hiring of plant, machinery and equipment
- Income from operating, leasing and hiring of motor vehicles and other transport
- Sundry trading income
- · Royalties etc. received
- Other income

Other manufacturing

Also include medium, small and micro units that might be classified within one of the classifications mentioned in 'scope and coverage' because they were only sampled at a 1-digit SIC level.

Profit margin

Profit margin is derived as:

Net profit after Tax *divide* Turnover *multiply* 100

Skills development levy

Refers to the skills development levies payable in terms to the Skills Development Levies Act (Act No. 9 of 1999).

Statistical unit

Is a unit about which statistics are tabulated, compiled or published. The statistical units are derived from and linked to the South African Revenue Service (SARS) administrative data.

Stratum

A stratum is constructed by concatenating the SIC classification and size group variables.

Turnover

Turnover includes:

- The value of sales and/or transfers-out of own manufactured products/articles;
- The value of sales of finished goods not produced by this enterprise and sold without further processing or packing;
- The value of sales of finished goods not produced by this enterprise but packed by this enterprise;
- Amount received for services rendered;
- Rent and lease payments received for land and buildings; and
- Rent, leasing and hiring received for machinery, vehicles and other equipment.

Value added

Value added is the value of output less intermediate consumption. It represents the value added to the cost of materials used in the process of production.

General information
