1. Introduction

This publication reports the estimated values and quantities of selected products which were produced by the manufacturing industry in South Africa in 2017, as well as the estimated details of purchases of raw materials by the industry. Financial results for the industry are reported in Report No. 30-02-03, *Manufacturing industry: Financial 2017*.

The estimates presented here are derived from the results of the 2017 manufacturing large sample survey (LSS).

The previous manufacturing LSS was conducted in 2014 (Reports No. 30-02-03 (2014) and 30-02-04 (2014)).

1.1 Scope and coverage

This survey covers enterprises registered for value added tax (VAT) in the taxation system that are engaged mainly in manufacturing. It includes the following divisions within its scope:

- Manufacture of food products and beverages (SIC 30).
- Manufacture of textiles, clothing, leather and footwear (SIC 31).
- Manufacture of wood and wood products, paper, publishing and printing (SIC 32).
- Manufacture of coke, petroleum, chemical products, rubber and plastic (SIC 33).
- Manufacture of glass and other non-metallic mineral products (SIC 34).
- Manufacture of basic metals, metal products, machinery and equipment (SIC 35).
- Manufacture of electrical machinery and equipment (SIC 36).
- Manufacture of telecommunication and professional equipment (SIC 37).
- Manufacture of transport equipment (SIC 38).
- Manufacture of furniture and other manufacturing (including tobacco and recycling) (SIC 39).

Including

The South Africa-based activities of enterprises which operate in multiple countries.

1.2 Data items

The following categories of data items were collected: income from own manufactured products, selected production quantities, and purchases of raw materials.

1.3 Reference period

The questionnaires were completed for the financial year of the enterprise which ends on any date between 1 July 2016 and 30 June 2017, according to the usual reporting schedule of the enterprise.

Example

- 1 October 2015 30 September 2016
- 1 January 2016 31 December 2016
- 1 February 2016 31 January 2017
- 1 March 2016 28 February 2017
- 1 April 2016 31 March 2017

1.4 Current prices

The rand values are at current prices.

1.5 Reliability of data

All estimates compiled for this industry are subject to both sampling and non-sampling errors.

The estimates are subject to sampling variability since they are based on information obtained from a sample. They may therefore differ from the figures that would have been produced if the data had been obtained from all enterprises in the manufacturing industry in South Africa. The standard error (SE) indicates the extent to which an estimate might have varied by chance, because only a sample of enterprises was used. The relative standard error (RSE) (the standard error expressed as a percentage of the estimate) provides an indication of the percentage error likely to have occurred due to sampling, and thus avoids the need to refer to the size of the estimate. The larger the RSE, the less reliable the estimate is.

The following are some of the likely sources of non-sampling errors: sampling frame not up to date, wrong definitions and classification, phrasing of questions, non-response, processing and estimation. Every effort is made to minimise non-sampling errors by careful design of questionnaires, testing them with a sample of respondents, editing reported data and implementing efficient operating procedures. Non-sampling errors occur in both sample surveys and censuses.

1.6 Confidentiality

According to Section 17 of the Statistics Act, 1999 (Act No. 6 of 1999), completed questionnaires remain confidential to Statistics South Africa (Stats SA). Individual business information is never disclosed. Results are presented in aggregated form only.

2. Summary of results

2.1 Income from own manufactured products

The total income from own manufactured products for the manufacturing industry in 2017 was R2 065,7 billion. The income represents an increase of 5,9% per annum over the income reported in the corresponding survey of 2014 (R1 740,2 billion). Comparing 2014 and 2017, large increases were reported for 'transport equipment' (+R119,3 billion), 'food and beverages' (+R87,1 billion), 'metals, metal products, machinery and equipment' (+R40,5 billion) and 'wood products, paper products and printed matter' (+R30,7 billion).

Between 2014 and 2017, 'transport equipment' gained the biggest percentage share (+3,9 percentage points) in income from own manufactured products (from a percentage contribution of 12,2% in 2014 to 16,1% in 2017). 'Coke, petroleum products, chemical products, rubber and plastic products' lost the biggest percentage share (-4,7 percentage points) over the same period (from 30,0% in 2014 to 25,3% in 2017).

The income of the top ten own manufactured products for the manufacturing industry in 2017 was R448,2 billion (a percentage share of 21,7%). The income represents an increase of 4,3% per annum over the income reported in the corresponding survey of 2014 (R395,5 billion). The product with the largest income was 'diesel fuel, automotive' (R80,2 billion or 3,9%), followed by 'light commercial vehicles' (R57,3 billion or 2,8%) and 'unleaded petrol, 95 octane' (R47,3 billion or 2,3%). Comparing 2014 and 2017, large increases were reported for 'medium passenger motor vehicles' (+R19,5 billion) and 'locomotives and related service vehicles' (+R17,3 billion). 'Petroleum refinery products' (-R23,6 billion) and 'unleaded petrol, 95 octane' (-R2,5 billion) were the only products in the top ten own manufactured products to record a decrease.

'Locomotives and related service vehicles' and 'medium passenger motor vehicles' gained the biggest percentage share (+0,7 percentage points) in income from own manufactured products (from a percentage share of 0,7% in 2014 to 1,4% in 2017, and from 1,4% in 2014 to 2,1% in 2017, respectively). 'Petroleum refinery products' lost the biggest share (-1,8 percentage points) in the same period (from 4,0% in 2014 to 2,2% in 2017).

Explanatory notes

Background The results presented in this publication have been derived from the 2017 large sample survey of manufacturing. This is a periodic survey which measures economic activity in the manufacturing sector of the South African economy. The survey is based on a sample of private enterprises operating in the manufacturing industry.

This publication summarises the details of products of the manufacturing industry. Financial data are published in a separate report.

The sample was drawn from Stats SA's business register. The business register is mainly based on the value added tax (VAT) database of the South African Revenue Service (SARS). Stats SA continuously updates its business register, based on units registered in the taxation system) at SARS.

The last large sample survey of the manufacturing industry was conducted for the year 2014 (Statistical Report No. 30-02-04 (2014)).

Value added tax (VAT) All figures exclude value added tax (VAT).

Reference period The information was collected from enterprises for their financial year, which ended on any date between 1 July 2016 and 30 June 2017.

- Statistical unit The statistical unit for the collection of the information is an enterprise. An enterprise is a legal unit (or a combination of legal units) that includes and directly controls all functions necessary to carry out its production activities.
- Size groups The enterprises are divided into four size groups according to the value of turnover recorded for them on the Stats SA business register. Table 21 presents the cut-off points for size groups.

Survey methodology and The survey was conducted by email, telephone and personal visits.

design

A sample of approximately 16 100 enterprises was drawn using cluster stratified simple random sampling. Enterprises were clustered using district municipality, then stratified at four-digit level according to the SIC and by size of enterprise. All large, medium and small enterprises were completely enumerated. Micro enterprises with more than one geographic location were also fully enumerated. Business register turnover was used as the measure of size for stratification.

Weighting methodology For those strata not completely enumerated, the weights to produce estimates are the inverse ratio of the sampling fraction, modified to take account of non-response in the survey. Stratum estimates are calculated and then aggregated with the completely enumerated stratum to form division estimates.

Collection rate Collection rate = ((collected enterprises + finalised investigations) / sample size)*100. The collection rate was 74,0%.

- Turnover collection
 Turnover collection rate = ((weighted collected enterprises BR turnover + weighted finalised investigations BR turnover) / population turnover)*100. The turnover collection rate was 94,4%.
- **Revisions to 2014 results** Revisions were made to previous results due to new information obtained after publication.
- Non-sampling errors Inaccuracies may occur because of imperfections in reporting by enterprises and errors made in the collection and processing of the data. Inaccuracies of this kind are referred to as non-sampling errors. Every effort is made to minimise non-sampling errors by careful design of questionnaires, testing them in pilot studies, editing reported data and implementing efficient operating procedures. Non-sampling errors occur in both sample surveys and censuses.

Rounding-off of figures The figures in the tables have, where necessary, been rounded off to the nearest final digit shown. There may therefore be slight discrepancies between the sums of the constituent items and the totals shown.
