Wholesale trade industry, 2009

1. Introduction

This publication presents estimates in respect of the 2009 wholesale trade large sample survey (LSS). The 2009 wholesale trade LSS collected data from a sample of approximately 3 100 enterprises drawn from a sampling frame of 36 250 which were operating between 1 July 2008 and 30 June 2009. The sample was stratified in such a way that all large enterprises (those with turnover equal to or greater than R64 million) were included. The data for the number of employees were provided for the last pay period ended on or before 30 June 2009. Data were collected at the 4-digit SIC level of classification of enterprises.

The previous wholesale trade LSS was conducted in 2005 (Wholesale trade industry, 2005).

1.1 Scope and coverage

The 2009 wholesale trade LSS covers enterprises registered in the taxation system that are mainly engaged in the following activities classified according to the January 1993 edition of the Standard Industrial Classification of all Economic Activities (SIC), Fifth edition, Report No. 09-09-02:

- Wholesale trade on a fee or contract basis (SIC 6110).
- o Agricultural raw materials and livestock (SIC 6121).
- o Food, beverages and tobacco (SIC 6122).
- Textiles, clothing and footwear (SIC 6131).
- o Other household goods (SIC 6139).
- Solid, liquid and gaseous fuels and related products (SIC 6141).
- Metals and metal ores (SIC 6142).
- o Construction materials, hardware, plumbing and heating equipment and supplies (SIC 6143).
- Other intermediate products, waste and scrap (SIC 6149).
- o Machinery, equipment and supplies (SIC 6150).
- General and other wholesale trade (SIC 6190).

The following activities are excluded:

- Sale of farmers' products by farmers (SIC 11).
- Manufacture and sale of manufactured goods (SIC 3).
- o Sale of goods to mainly individuals and households (SIC 62).
- o Sale (retail and wholesale) of motor vehicles, motor cycles and their parts and of fuel for these items (SIC 63).
- o Sale of food and drinks for consumption on the premises and sale of take-away foods (SIC 6420).
- o Renting and hiring of motor vehicles, machinery and equipment and personal and household goods (SIC 85).
- Handling and storage activities of businesses (SIC 74).
- o Repair and maintenance of office machinery and computers (SIC 86).
- o Repair of machinery, which is classified under manufacturing along with the manufacture of the relevant type of machinery.

1.2 Data items

The following categories of data items were collected: industrial classification, information and communication technology (ICT), details of employment, trading income, expenditure, profit or loss, inventories, book value of assets, details of sales of goods and purchases.

1.3 Reference period

The questionnaires were completed for the financial year of the enterprise which ended on any date between 1 July 2008 and 30 June 2009, according to the usual reporting schedule of the enterprise.

Example

- 1 October 2007 30 September 2008
- o 1 January 2008 31 December 2008
- o 1 February 2008 31 January 2009
- o 1 March 2008 28 February 2009
- o 1 April 2008 31 March 2009

1.4 Current prices

The rand values are at current prices.

1.5 Reliability of data

All estimates compiled for this industry are subject to both sampling and non-sampling errors.

The estimates presented in this publication are subject to sampling variability since they are based on information obtained from a sample. That is, they might differ from the figures that would have been produced if the data had been obtained from all enterprises in the wholesale trade industry in South Africa.

One measure of the likely difference is given by the standard error (SE), which indicates the extent to which an estimate might have varied by chance because only a sample of enterprises was used. The relative standard error (RSE) provides an immediate indication of the percentage errors likely to have occurred due to sampling, and thus avoids the need to refer to the size of the estimate. The larger the RSE, the less reliable the estimate. The following are some of the likely sources of non-sampling errors: sampling frame not up to date, wrong definitions and classification, phrasing of questions, non-response, processing and estimation. Every effort is made to minimise non-sampling errors by the careful design of questionnaires, testing them in pilot studies, editing reported data and implementing efficient operating procedures. Non-sampling errors occur in both sample surveys and censuses.

1.6 Confidentiality

According to section 17 of the Statistics Act, 1999 (Act No. 6 of 1999), completed questionnaires remain confidential to Statistics South Africa (Stats SA). Individual business information is never disclosed. Results are presented in aggregated form only.

2. Background to the large sample surveys

The LSSs serve to document comprehensively the nature and structure of all industries within the economy.

Previously, Stats SA periodically conducted industry censuses, i.e. collections covering all entities known to be mainly engaged in particular sectors. The last industry 'census' was conducted for the manufacturing sector in 1996. Since then, Stats SA has replaced industry censuses with periodic LSSs of industry sectors. These surveys are based on larger samples than the sub-annual and annual surveys. They do not attempt to completely enumerate all entities within the industry scope of the surveys, but are based on stratified random samples which are representative of the survey population.

2.1 Purpose and uses of large sample surveys

The LSS results are used in constructing and refreshing supply and use tables, and for benchmarking the gross domestic product (GDP) and its components, as well as production and price indices, and annual and short-term statistical series.

Users of the LSSs include the following:

- i. Price statisticians, particularly in refreshing the commodity basket of producer price indices;
- ii. Policy advisors in government, for monitoring the performance of industries and their contribution to the South African economy and evaluating the effectiveness of industry policies;
- iii. Industry associations monitoring trends in their own and competing or complementary industries in order to inform their members of market changes; and
- iv. Individual businesses using the data to analyse their performance relative to their industry.

2.2 Scope and coverage

The LSSs cover enterprises registered in the taxation system (VAT and income tax) that are mainly engaged in the following industries, as defined in the Standard Industrial Classification of all Economic Activities (SIC):

- i. Mining and guarrying;
- ii. Manufacturing;
- iii. Electricity, gas and water supply;
- iv. Construction:
- v. Wholesale and retail trade, repair of motor vehicles, motor cycles and personal and household goods, and hotels and restaurants;
- vi. Transport, storage and communication;
- vii. Financial intermediation, insurance, real estate and business services; and
- viii. Community, social and personal services (except national, provincial and local government activities).


Note: The agriculture, forestry, fishing, hunting and related services industry (SIC 1) is not included as it is covered by a separate programme within Stats SA. Similarly, the public administration and defence activities industry (SIC 91), the financial intermediation industry (SIC 81) and insurance and pension funding industry (SIC 82) are covered by other programmes within both Stats SA and elsewhere (e.g. the South African Reserve Bank (SARB)).

2.3 Reporting unit

The statistical unit for the collection of information is an enterprise. An enterprise is a legal unit (or a combination of legal units) that includes and directly controls all functions necessary to carry out its activities. Each industry is classified to an industry that reflects its predominant activity.


3. Summary of findings for the year 2009

Figure 1 - Income in the wholesale trade industry, 2009




The total income for the wholesale trade industry in 2009 was R948 330 million. The largest contributor to the total income was 'wholesale trade in machinery, equipment and supplies' (R231 307 million or 24%), followed by 'wholesale trade in food, beverages and tobacco' (R154 931 million or 16%), 'wholesale trade in other household goods' (R112 436 million or 12%) and 'wholesale trade in solid, liquid and gaseous fuels and related products' (R105 621 million or 11%) (Figure 1 and Table 3, page 8).

Figure 2 – Income by enterprise size in the wholesale trade industry, 2009




Large enterprises (those with turnover equal to or greater than R64 million) generated 80% or R759 068 million of the total income of the wholesale trade industry in 2009 (Figure 2 and Table 4, page 9).

Figure 3 - Profit margin in the wholesale trade industry, 2009




The profit margin for the wholesale trade industry was 3,2% in 2009. 'Wholesale trade on a fee or contract basis' had the highest profit margin at 8,2%, followed by 'wholesale trade in metals and metal ores' at 5,4% and 'wholesale trade in machinery, equipment and supplies' at 4,3% (Figure 3 and Table 2, page 7).

Figure 4 - Concentration ratios (CR) in the wholesale trade industry, 2009




The 20 largest enterprises contributed 21,6% of the total income of the wholesale trade industry in 2009. 'Wholesale trade in agricultural raw materials and livestock' had the highest CR20 (75,8%), while 'wholesale trade in solid, liquid and gaseous fuels and related products' had the highest concentration ratios in two categories CR10 (65,8%), CR5 (59,5%). 'Other wholesale trade' had the lowest CR5 (7,9%), CR10 (11,0%) and CR20 (15,6%) (Figure 4 and Table 5, page 10).

Figure 5 - Composition of expenditure in the wholesale trade industry, 2009




Expenditure in the wholesale trade industry in 2009 amounted to R916 512 million. The expenditure consisted primarily of 'purchases' (R748 231 million or (81%), followed by 'salaries and wages' (R59 711 million or 7%), 'excise and customs duty' (R8 764 million or 1%) and 'interest' (R8 538 million or 1%) (Figure 5 and Table 6, pages 11-12).

The total capital expenditure on new assets in the wholesale trade industry in 2009 was R10 852 million. The largest contributor to the total expenditure was 'plant, machinery and equipment' (R4 859 million or 45%), followed by 'vehicles' (R1 897 million or 17%) and 'buildings and construction' (R1 086 million or 10%) (Figure 6 and Table 10, page 16).


Figure 7 - Employment in the wholesale trade industry, 2009



The total number of persons employed in the wholesale trade industry at the end of June 2009 was 440 117. 'Wholesale trade in machinery, equipment and supplies' employed the largest number of persons (100 828 or 23%), followed by 'other wholesale trade' (90 610 or 21%), 'wholesale trade in food, beverages and tobacco' (54 409 or 12%) and 'wholesale trade in other household goods' (49 855 or 11%) (Figure 7 and Table 11, page 17).

Figure 8 - Gender ratios in the wholesale trade industry, 2009



The proportion of males out of the total persons employed was 67% and that of females was 33%. The industry with the highest proportion of males employed was 'wholesale trade in construction materials, hardware, plumbing and heating equipment and supplies' (73%), whilst 'other wholesale trade' had the highest proportion of females employed (50%) (Figure 8 and Table 11, page 17).

Employment by enterprise size indicates that the large enterprises (those with turnover equal to or greater than R64 million) had the highest number of employees (217 848 or 50%), followed by small enterprises (108 222 or 25%), micro enterprises (63 625 or 14%) and medium enterprises (50 422 or 11%) (Figure 9 and Table 13, page 19).

Explanatory notes

Background

The results presented in this publication have been derived from the 2009 wholesale trade large sample survey. This is a periodic survey which measures economic activity in the wholesale trade sector of the South African economy. This survey is based on a sample of private and public enterprises operating in wholesale trade industries.

The sample was drawn from Stats SA's business register. The business register is based mainly on the income tax (IT) and value-added tax (VAT) databases of the South African Revenue Service (SARS). All enterprises are legally bound to register for either VAT or IT or both. Enterprises registered in the taxation system are included on the business register, and hence were given a chance of selection in the sample for the survey.

Value added tax (VAT)

All figures exclude value added tax (VAT).

Reference period

The information was collected from enterprises for their financial year, which ended on any date between 1 July 2008 and 30 June 2009.

Purpose of the survey

Results of the survey are used within Stats SA for compiling the gross domestic product (GDP) and its components. These statistics are also used by government policy advisers in monitoring the performance and contribution of individual industries to the South African economy and the effectiveness of industry policies, and by private sector users in analyses of comparative business and industry performance.

Classification by industry

The 1993 edition of the Standard Industrial Classification of all Economic Activities (SIC), Fifth Edition, Report No. 09-09-02, was used to classify the statistical units in the survey. The SIC is based on the 1990 International Standard Industrial Classification of all Economic Activities (ISIC) with suitable adaptations for local conditions. Statistics in this publication are presented at SIC group (four-digit) level. Each enterprise is classified to an industry, which reflects its predominant activity.

Statistical unit

The statistical unit for the collection of the information is an enterprise. An enterprise is a legal unit (or a combination of legal units) that includes and directly controls all functions necessary to carry out its production activities.

Size groups

The enterprises are divided into four size groups according to the value of turnover recorded for them on the Stats SA business register. Large enterprises are those with an annual recorded turnover of R64 million and above. Table 18 presents the size groups defined using the Department of Trade and Industry (DTI) cut-off points.

Survey methodology and design

The survey was conducted by post, email, fax, telephone and personal visits.

A sample of approximately 3 100 enterprises was drawn from a frame of 36 250 enterprises using stratified simple random sampling. The enterprises were first stratified at the four-digit level according to the SIC and then by size of enterprise. All large enterprises were completely enumerated. Turnover as recorded on the business register was used as the measure of size for stratification. The response rate was 82,0%.

Weighting methodology

For those strata not completely enumerated, the weights to produce estimates are the inverse ratio of the sampling fraction, modified to take account of non-response in the survey. Stratum estimates were calculated and then aggregated with the completely enumerated stratum to form division estimates.

Relative standard error

Data presented in this publication are based on information obtained from a sample and are, therefore, subject to sampling variability; that is, they may differ from the figures that would have been produced if the data had been obtained from all enterprises in the wholesale industry in South Africa.

One measure of the likely difference is given by the standard error (SE), which indicates the extent to which an estimate might have varied by chance because only a sample of enterprises was used. The relative standard error (RSE) provides an immediate indication of the percentage errors likely to have occurred as a result of sampling, and thus avoids the need to refer to the size of the estimate.

Every effort is made to minimise non-sampling errors by careful design of questionnaires, testing them in pilot studies, editing reported data and implementing efficient operating procedures. Non-sampling errors occur in both sample surveys and censuses.

Rounding of figures

The figures in the tables have, where necessary, been rounded to the nearest final digit shown. There may therefore be slight discrepancies between the sums of the constituent items of the totals shown.

Glossary

Casual employees

Casual employees are employees who fall neither within the 'permanent employees' category nor the 'temporary employees' category. Such employees are typically working daily or hourly.

Concentration ratio

The concentration ratio is the ratio of the income of the n largest enterprises to the total income.

Current assets

Assets that are expected to be turned into cash within one year during the normal cause of business. They include:

Current liabilities

Current liabilities are debts or obligations that are due within one year. They include:

Employees

Statistical unit

A statistical unit is a unit about which statistics are tabulated, compiled or published. The statistical units are derived from and linked to the South African Revenue Service (SARS) administrative data.

Stratum

A stratum is constructed by concatenating the SIC classification and size group variables.

Temporary employees

Temporary employees are employees appointed on a short-term contract basis with a stipulated termination date for periods not exceeding one year.

Turnover

Turnover includes:

- value of sales of goods;
- o amount received for services rendered;
- o rent and lease payments received for land and buildings; and
- o rent, leasing and hiring received for machinery, vehicles and other equipment.

Wholesale trade

Includes the resale (sale without transformation) of new and used goods to other wholesalers, retailers, agricultural, industrial, commercial, institutional and professional users either directly or through agents on a fee or contract basis.

Wholesaler

An enterprise deriving more than 50% of its turnover from sale of goods to other businesses and institutions.

Flowers and plants

but not further prepared).

Agricultural materials, waste, residues and by-products used for animal feed including feed for pet animals

Livestock

Include: Cattle, sheep and goats, horses, mules and hinnies, swine, poultry, pet animals, bees and worms.

Fruit and vegetables

Include: Fresh, frozen, canned and dried fruit and vegetables.

Meat and meat products

Include: Fresh, chilled or canned meat, poultry, turkey, fowl and game, cooked, cured or frozen meats, meat preparations, meat carcasses, fat

and lard, sausage casings and edible offal.

Fish and seafood products

Include: Crustaceans, oysters and molluscs, fresh, frozen and cured fish, fresh and frozen lobster and other dressed or frozen seafood.

Bakery products

Include: Crisp bread, rusks, toasted bread and similar toasted products, gingerbread and the like, biscuits, waffles and wafers, other bread and

bakers' wares.

Sugar, cocoa, chocolate and snacks

Include: Raw cane or beet sugar, refined cane and chemically pure sucrose, molasses, cocoa paste (whether or not defatted), cocoa (butter,

fat and oil), cocoa powder (not sweetened), chocolate and other food preparations containing cocoa (in bulk forms and not in bulk),

white chocolate, nuts, fruit-peel and other parts of plants preserved by sugar, gum, candy and sugar preparations.

Coffee, tea and spices

Include: Decaffeinated or roasted coffee, green, black and partly fermented tea, extracts, essences and concentrates of tea or mate, and

spices.

Other food

Include: Prepared and preserved fruits and vegetables, preparations of milk, flour, meal, starch or malt extract for infant use, soups and broths,

vinegar and substitutes obtained from acetic acid, sauces, mixed condiments, mustard flour and meal, prepared mustard, yeast, macaroni, noodles, couscous and similar farinaceous products, fruit and vegetable juices, natural fruit juice base concentrates.

Exclude: Sports-specific footwear, golf shoes, bowling shoes, broomball shoes, curling shoes, skates.

Women's and girls' footwear

Include: Boots (winter, rain, etc.), shoes, sandals, slippers, cowboy boots, work boots, orthopaedic shoes, clip-on shoe accessories.

Exclude: Sports-specific footwear, golf shoes, bowling shoes, broomball shoes, curling shoes, skates.

Infants' and children's footwear

Include: All types of non-athletic infants' and children's footwear.

Sport footwear

Include: Running, walking, hiking, basketball, tennis, court shoes, cross-trainers, sports footwear such as golf, bowling shoes, etc.

Household furniture

Include: Seats, mattresses (spring, foam and water), box spring and foundations, bed frames, nursery furniture (cribs, crib mattresses, junior

toddlers' beds, changing tables, carriages, strollers, playpens, high chairs, walkers, carriers, baby monitors), finished and unfinished

furniture for the bedroom, living room, kitchen, dining room and home office.

Exclude: Parts and accessories.

Household appliances

Include: Vacuum cleaners and polishers, refrigerators, freezers, washing machines and dryers, stoves and food-mixers, microwaves, sewing

machines, beauty and personal care appliances i.e. hair dryers, razors, toothbrushes and small household appliances, i.e. toasters,

kettle, irons.

Sound and visual apparatus

Include: Televisions, VCRs, radios, sound systems, amplifiers, mixers, speakers, microphones, sound boards, CD/MP3 players, DVD players.

tape decks, and tape recorders.

Exclude: Still and digital cameras, slide projectors, slides, screens.

Household requisites

Include: Pots, pans, dishes, cutlery, brooms and brushes.

Musical records, audio and video tapes, compact disc and cassettes

Books, hard cover and paperback

Include: Text books, reference books, children's books, bibles, atlases and all other books including books in electronic format.

Newspapers, magazines and other periodicals

Include: Newspapers, magazines, periodicals, comic books.

Stationery

Include: Files, pens, pencils and other similar items.

Printed or illustrated postcards, printed cards bearing personal greetings or messages

Include: Wedding and visiting cards, greeting cards, invitation and postcards, and other cards.

Trade advertising material and commercial catalogues

Include: Trade catalogue and brochures, tourist booklet and pamphlets, shopping newspapers made mainly of advertisements, posters and

similar display advertisements.

Paper and paperboard

Include: Newsprint, hand-made paper and other uncoated paper and paper board, toilet tissue, processed paper and paper board, sacks and

bags of paper, seed packets, boxes, letter files, box files and other packing containers, plain postcards and correspondence cards,

bobbins, spools, cones, utensils such as paper cups and plates.

Precious stones

Include: Pearls, precious or semi-precious stones, industrial diamonds, dust and powder of natural or synthetic precious or semi-precious

stones.

Jewellery, gold, silverware and medals

Include: Jewellery and other articles of precious metal or of metal clad with precious metal, coins.

Pharmaceuticals for human and veterinary use

Include: Prescription medicines, bacteriological and biological medicines, ethical drugs, proprietary (patent) medicines and radioactive pharmaceuticals.

Medical goods

Include: Protective and healthcare textiles, dressings, bandages, pressure garments and prosthetics, hygiene products, antiseptic wound dressings, eyeglasses

and contact lenses, wheelchairs, crutches and other personal medical goods, measuring and control instruments.

Cosmetics and toiletries

Include: Body soaps, oral care products, hair care products and non-electric razors and blades.

Photographic and optical goods

Include: Cameras, photographic paper films and plates, still and motion picture photographic equipment.

Games and toys

Include: Board games, puzzles, handicraft and hobby craft kits, science kits and sets, toys and fireworks, video games.

Musical instruments, tapes and recordings

Include: Instruments, accessories and supplies, pre-recorded audio tapes, video tapes and recordings.

Sports goods and entertainment requisites

Include: Firearms and ammunitions (all kinds), bows and arrows (all kinds), fishing tackle and other equipment, hunting blinds, tents, sleeping

bags, camping-type air mattresses, hunting and camouflage clothing, hip waters, lanterns, picnic coolers, camping stoves, bait.

Hockey, baseball, football, soccer, volleyball and basketball equipment and supplies

Include: Nets, balls, hockey skates, ringuette equipment, cleated footwear, team uniforms, and other related equipment.

Golf equipment and accessories

Include: Golf clubs, golf bags and pull-carts, golf shoes and gloves, tees, etc.

Exercise and fitness equipment

Include: Home gyms, stationary bikes, rowing machines, abdominal exercisers, free weights, exercise balls, etc.

All other sporting goods

Include: Figure skates, in-line skates, skateboards, roller skates, sailboards, rock-climbing equipment and accessories, tennis and squash

equipment, ping pong equipment, badminton equipment, pool/snooker tables and accessories, life jackets, wet suits, saddlers, tack, water skis and equipment, scuba equipment, bowling shoes and equipment, broomball shoes and equipment, curling shoes and

equipment, snorkels, goggles, binoculars, water air mattresses, dance shoes, trampolines, boxing equipment, etc.

Luggage and travel accessories

Include: Luggage, trunks, duffel bags, backpacks, sport bags, portfolios, school bags, travel accessories, etc.

Exclude: Purses, wallets, billfolds, camera and instrument cases, fashion knapsacks, etc.

Garden products, equipment and lawn mowers

Include: Pools (above and in-ground) and pool supplies, outdoor hot tubs/jacuzzis, ponds and accessories, barbeques and accessories,

wheelbarrows, pruning shears, garden tools, hoses, garden shovels, spades, hoes, rakes, garden sheds, lawn ornaments, outdoor specialty

lighting (security/landscape/patio), outdoor urns, outdoor planters, picnic tables, sprinklers, playground structures, playground

equipment.

Lighting equipment

Include: Lighting fixtures, light bulbs, fluorescent tubes, and flashlights.

Cleaning materials

Include: Bleach, soap, bars, tablets, antiseptic, detergents, household cleaners and polishers.

Telephones and home office equipments

Include: Telephones, cellular phones, answering machines, fax machines, pagers, calculators, photocopiers, etc. including parts and

accessories.

Solid fuels

Include: Firewood and coal.

Petroleum products

Include: Petrol, diesel, lubricating oils, greases and paraffin.

Gaseous fuel

Include: Liquefied petroleum gas.

Construction materials

Include: Wood, steel, glass, sand, concrete products, electrical cables and accessories.

Plumbing, heating, cooling and electrical equipment and supplies

Include:

Furnaces and filters, ductwork, humidifiers attached to furnaces, central air conditioners, air exchangers, air cleaners, water purifiers, water heaters, woodstoves, fireplace inserts and related equipment, baseboard heaters, pipes and valves for plumbing, bathtubs, bathtubs/shower enclosures, whirlpools, indoor jacuzzis, saunas, toilets, sinks, faucets, laundry tubs, pumps, fuse boxes, electrical wiring, light switches and plugs, power generators, etc.

Hand tools and equipment for domestic

Include: Ladders, carpenters' tools, snow shovels, portable power tools, bench power tools, axes, picks, wrenches, screwdrivers, saws, planes,

trowels, hammers, pliers, drills, sanders, toolboxes, measuring tapes, chain saws.

Hardware

Include: Corrugated iron, window frames and doorframes, locksets, key blanks, fasteners, nuts, bolts, nails, screws, washers, hinges, knobs

and pulls.

Paint, varnishes and lacquers

Include: Household paints, thinners, brushes, paste, scrapers, varnishes and lacquers.

Sanitary equipment and installation

Include: Baths, washbasins, toilets and other sanitary porcelain, tubes, pipes, fittings, taps, t-pieces, connections, rubber.

Glassware and woodenware

Include: Mirrors and glass household products, art and decorative ware, wooden doors and windows, wood structural products, shingles and

shakes, treated wood, kitchen cabinets, particles and wafer boards, plywood, veneer and wood flooring.

Wallpaper and floor covering

Include: Rugs, tiles, mats and runners, vinyl and textile wall coverings.

Electrical wiring, switch gear, circuit breakers and related materials

Include: Wiring device and related electrical supplies.

Industrial chemicals

Include: Aniline, printing ink, essential oils, industrial gases, chemical glues, colouring matter, synthetic resin, methanol, scents and flavouring,

soda, industrial salt, acids and sulphurs, starch derivatives, industrial alcohol, bleaching compounds, dry ice, explosives, organic

chemicals.

Exclude: Non-military ammunitions.

Fertilisers and agrochemical products

Include: Agricultural chemical dusts and sprays, chemical fertilisers, herbicides, insecticides, orchard care chemicals, sterilising compounds

and disinfectants, lawn care chemical products.

Rubber and rubber products

Include: Synthetic rubber and mixtures with natural rubber in primary forms or in plates, sheets or strips.

Waste, scrap and material for recycling

Include: Collecting, sorting, separating, stripping of used goods such as cars to obtain reusable parts, packing and repacking storage and

delivery, but without a real transformation process, purchased and sold waste which have a remaining value.

Office machinery, furniture and equipment

Include: Adding machines, photocopy machines, typewriters, typist chairs and tables, scales, cash registers, safes, filing cabinets, show cases

and shelves.

Computer equipment

Include: Central processors, printers, peripherals, monitors and modems.

Agricultural machinery, equipment and supplies

Include: New and used tractors, ploughs and harvesters, barn machinery, irrigation machinery, harrows and tillers.

Exclude: Agricultural chemicals.

Forestry machinery, equipment and supplies

Include: Logging and pulp machinery, equipment and supplies.

Construction machinery, equipment and supplies

Include: Asphalt mixing and laying machinery, concrete mixing plant machinery, crawler tractors, excavating machinery and equipment, front-

end loaders, graders, road construction and maintenance machinery.

Mining, oil and gas machinery, equipment and supplies

Include: Oil well machinery and equipment, oil refining machinery and equipment, petroleum production machinery and equipment, natural gas

field production equipment, mining machinery, agitators and classifiers.

Industrial machinery, equipment and supplies

Include: Conveyors and transmission belting, elevators, hoist, machinery, packaging and bottling machinery, metal-working machinery such as

printing plates and typesetting machinery, industrial pumps, compressors and blowers (gaskets), bearing and mechanical power

transmission equipment and other industrial machinery and supplies.

Electrical generators, motors and transformers, turbine and control panels

Include: Converters, ballasts, regulators and fuses.

Electronic equipment and components

Include: Printed and integrated circuits, semiconductors and other electronic equipment and components such as electronic alarms and signal systems.

General information
